SET INDEX

The SET's crucial support is at the 1.000 level for this round.

In the hourly picture, the SET decreased to trade below 1045 points. That opens a downside for continued retreats.

Also, the main outlook remains bearish. Given that, we continue to view that the SET will decrease to touch its crucial support of 1,000 points for this round. It is the index's previous low and also its psychological support.

Since the index continued to decrease intraday, it may continue to retreat.

On March 17, 2020, foreign investors registered a net long position of 15,666 contracts on the Index Futures.

The S50H20's basis was -6.66 points.

The index was unable to rise to hover above 700 points. To elaborate, it retreated to close at 674 points. Since the broad outlook remains bearish, the index may continue to fall. In this regard, we see the next support at 650/635 points.

- For the short bet placed yesterday's afternoon at 690-695 points, we believe investors had cut loss intraday when the index increased to trade above 702 points.
- For those without any position, go short at 690-695 points. Cash in at 676/650 points. Cut loss if the index increases to trade above 710 points.
