
Eye at the resistance of 1380 points

Yesterday, the SET decreased by 3.20 points to end at 1372.98 points.

To elaborate, the SET recovered to test its resistance of 1380 points for the third straight day. However, since the index failed to break the said level, we maintain our view that it will move sideways to accumulate strength.

In this regard, look at the resistance of 1380 points. If the SET can close above the said level, it will enter a round of recoveries.

The index will continue to move sideways to accumulate strength within 890-922 points.

On June 18, 2020, foreign investors registered a net long position of 8,882 contracts on the Index Futures.

The S50M20's basis was -1.43 points.

In the big picture, we maintain our view that the index will move sideways within 890-922 points to accumulate strength for an upward cycle.

In the 60-minute picture, the index has resistances waiting to be tested at 915 and 922 points this morning. Given that, we expect it to slow, in line with its sideways movement in the big picture.
