โรงพยาบาลใหม่กระทบกำไร

โรงพยาบาลใหม่กดดันกำไร

THG อยู่ในรอบการลงทุนขนาดใหญ่ บริษัทฯ เปิดโรงพยาบาลใหม่ 4 แห่งในช่วงสองปีที่ผ่าน มา โดยหนึ่งในนั้นคือ Welly Hospital ในประเทศจีนถูกขายไปใน 1Q20 ทำให้กำไรจากการ ดำเนินงานหลักได้รับผลกระทบจากโรงพยาบาลใหม่สามแห่ง ประกอบด้วยโรงพยาบาลธนบุรี บำรุงเมือง ทุ่งสง และ Ar Yu (ประเทศพม่า) นอกจากนี้ผลกระทบจาก COVID-19 ยังมี แนวโน้มที่จะถ่วงการพลิกฟื้นของโรงพยาบาลดังกล่าว

โรงพยาบาลธนบุรี บำรุงเมืองจะดึงกำไรจากการดำเนินงานหลักให้ลดลงใน 2020E

THG เคยคาดว่าโรงพยาบาลธนบุรี บำรุงเมือง (11% ของรายได้ของบริษัทฯ) จะพลิกฟิ้นได้ใน ปีนี้ อย่างไรดีการพลิกฟิ้นดังกล่าวมีแนวโน้มล่าช้าออกไป เนื่องจาก 90% ของรายได้ของ โรงพยาบาลช มาจากผู้ป่วยต่างชาติ เราคาดว่าโรงพยาบาลธนบุรี บำรุงเมืองจะมีผลขาดทุน ประมาณ 150-200 ลบ. ใน 2020 นอกจากนี้กำไรของ THG จะได้รับแรงกดดันจากผลขาดทุน ของโรงพยาบาลธนบุรี ทุ่งสงและ Ar Yu ซึ่งเปิดทำการในปีที่แล้ว ด้วยเหตุผลดังกล่าว เราจึง คาดว่า THG จะรายงานผลขาดทุนจากการดำเนินงาน (core profit loss) จำนวน 10 ลบ. ใน 2020 จากต้นทุนคงที่ที่อยู่ในระดับสูง เราคาดว่า EBITDA ของโรงพยาบาลที่ประสบปัญหา ขาดทุนทั้งหมดจะเข้าสู่จุดคุ้มทุนได้ใน 2021-2023 ซึ่งจะทำให้กำไรจากการดำเนินงานโตได้ 13% CAGR ในปี 2019-2023E

COVID-19 ชะลอยอดขายของ Jin

Jin Wellbeing County (Jin) เป็นอีกหนึ่งธุรกิจของ THG ที่ได้รับผลกระทบจากการแพร่ระบาด COVID-19 การชะลอตัวทางเศรษฐกิจได้ทำให้โอกาสในการขายลดลง ใน 1Q20 Jin รายงาน ยอดขายโครงการจำนวน 4 ยูนิต ทำให้ยอดขายโครงการรวมอยู่ที่ 150 ยูนิต (โอนแล้ว 117) จากจำนวนยูนิตรวมที่ 494 ตัวเลขดังกล่าวต่ำกว่าเป้าประมาณการโอนเดิมของ THG ที่ 200 ยู นิตภายใน 2019 ปัจจัยดังกล่าวจะส่งผลกระทบต่อทั้งงบกำไรขาดทุนและงบกระแสเงินสดของ บริษัทฯ ปัจจุบัน THG กำลังเจรจากับลูกค้าต่างชาติเพื่อขายห้อง big lot จำนวนมากกว่า 100 ยูนิต อย่างไรก็ดี COVID-19 อาจทำให้การเจรจาดังกล่าวล่าช้าออกไป

กำไรจากการดำเนินงานหลักควรผ่านจุดต่ำสุดใน 2020 และมีแนวโน้มฟื้นตัวในระยะยาว

เราเริ่มรายงาน THG ด้วยคำแนะนำถือ ที่ราคาเป้าหมาย 20.5 บาท (DCF, WACC 8.2%, LTG 3%) ปัจจุบัน THG ซื้อขายที่ FY21E P/E ที่ 56x เทียบกับค่าเฉลี่ยของกลุ่มฯ ที่ 34x เรา แนะนำถือ THG เนื่องจากหุ้นขาดปัจจัยบวกระยะสั้นและ Valuation ที่ยังไม่น่าสนใจ อย่างไรก็ ดี เรามองว่า THG อาจมีความน่าสนใจมากขึ้นในระยะกลางและยาว เนื่องจากการดำเนินงานมี แนวโน้มแตะจุดต่ำสุดในปีนี้ นอกจากนี้ การขายห้อง big lotของ Jin อาจทำให้ Valuation ของ หุ้นถูกปรับขึ้น เนื่องจาก THG วางแผนใช้เงินที่ได้จากการขายเพื่อชำระหนี้ ซึ่งจะทำให้ ดอกเบี้ยจ่ายลดลงและฐานะทางการเงินของบริษัทฯ ดีขึ้น
