้กำไรสุทธิที่ดีในธุรกิจเคมีช่วยกู้ผลประกอบการ 4Q20

กำไรสุทธิ 4Q20 ของ SCC ที่ 8พัน ลบ. (-17% q-q, +13% y-y) สูงกว่าที่เราคาด 1% และสูง กว่าตลาดคาด 3% จากกำไรสุทธิในธุรกิจเคมีและบรรจุภัณฑ์ที่สูงเกินคาด โดยกำไรสุทธิของ ธุรกิจเคมีปรับตัวขึ้นเป็น 5.8พัน ลบ. (+6% q-q, +108% y-y) จาก Product Margins ที่อยู่ใน ระดับสูงจากความต้องการที่มากขึ้นในประเทศจีนแม้ว่าจะมีมาตรการปิดเมือง ธุรกิจปูนซีเมนต์ และวัสดุก่อสร้าง (CBM) รายงานผลขาดทุนสุทธิ 194 ลบ. จากผลขาดทุนจากการด้อยค่า จำนวน 1.3พัน ลบ. จากธุรกิจปูนซีเมนต์ในพม่าและอินโดนีเซีย รวมถึงความต้องการซีเมนต์ที่ อ่อนแอ กำไรสุทธิจากธุรกิจบรรจุภัณฑ์เพิ่มเป็น 1.5พัน ลบ. (+11% q-q, +24% y-y) จาก ปริมาณขายที่อยู่ในระดับสูง

ธุรกิจเคมีรายงานกำไรดีต่อเนื่องใน 4Q20

ใน 4Q20 กำไรสุทธิของธุรกิจเคมีเพิ่ม 108% y-y จาก Product Margins ที่สูงขึ้น ปริมาณขาย ผลิตภัณฑ์เคมี (PE และ PP) ลดลงเหลือ 384kt (-13% q-q) จากการปิดโรงงาน MOC ตาม แผนเป็นเวลา 38 วัน ซึ่งน้อยกว่าที่วางแผนไว้เดิมที่ 45 วัน EBITDA Margin รวมของธุรกิจ เคมีปรับตัวขึ้น y-y เป็น 23% จากอัตรากำไรของ HDPE-naphtha (+13% q-q) PP-naphtha (+28% q-q) PVC-ethylene dichloride (+15% q-q) และ Butadiene-naphtha เป็น USD167/t (+334% q-q) ตามการฟื้นตัวของความต้องการในอุตสาหกรรมยานยนต์

ธุรกิจปูนซีเมนต์และวัสดุก่อสร้างยังเป็นปัจจัยถ่วง

ธุรกิจปูนซีเมนต์รายงานผลขาดทุนสุทธิจำนวน 194 ลบ. ลดลงจากที่เคยรายงานกำไรสุทธิ 1.9 พัน ลบ. ใน 3Q20 จากผลขาดทุนจากการด้อยค่า ใน 4Q20 ความต้องการปูนซีเมนต์ใน ประเทศลดลง 5% y-y เนื่องจากความต้องการในภาครัฐ (40% ของความต้องการรวม) ทรงตัว y-y ในขณะที่ความต้องการในภาคเอกชน (60% ของความต้องการรวม) ลดลง 7% y-y ราคา ปูนซีเมนต์ในประเทศลดลง q-q มาอยู่ที่ 1,700-1,750บาท/t ปริมาณขายเซรามิกอยู่ที่ 39m sqm ลดลง 12% y-y จากความต้องการที่อ่อนแออันเป็นผลต่อเนื่องจากสภาวะน้ำท่วมรุนแรงใน เวียดนามและกัมพูชา ในขณะที่ราคาเซรามิกลดลง 2% y-y จากความต้องการที่อ่อนแอ

แนวโน้มกำไรสุทธิทรงตัวในปี 2021


เราคาดว่ากำไรสุทธิของ SCC จะดีขึ้นในปี 2021-22 เนื่องจากเราคาดว่ากำไรสุทธิของธุรกิจ CBM และบรรจุภัณฑ์จะฟื้นตัว ในขณะที่กำไรสุทธิของธุรกิจเคมีจะดีต่อเนื่องในปี 2021-22 เรา คิดว่า PE-naphtha margins จะอ่อนตัวลงจากสภาวะอุปทานเกินดุล อย่างไรก็ดีเราคาดว่ากำไร สุทธิที่ดีของธุรกิจบรรจุภัณฑ์จะช่วยทดแทนอัตรากำไรที่อ่อนแอในปี 2021-22 โดยได้แรง ขับเคลื่อนจากตันทุนกระดาดใช้แล้วที่ลดลงและความต้องการที่เพิ่มสูงขึ้น
