อุตสาหกรรมยานยนต์ผลักดันการเติบโตใน 3QFY21

กำไร 3QFY21 สูงเป็นประวัติการณ์โดยอยู่ที่ 433 ลบ.

EPG รายงานกำไรสุทธิ 3QFY21 (ต.ค.-ธ.ค. 20) อยู่ที่ 433 ลบ. (+41% q-q, +103% y-y) สูงกว่าประมาณการของตลาด 212% และของเรา 25% เมื่อหักผลขาดทุนจากอัตราแลกเปลี่ยน จำนวน 24 ลบ. กำไรจากการดำเนินงาน 3QFY21 อยู่ที่ 456 ลบ. (+70% q-q, +116% y-y) จากอัตรากำไรที่สูงขึ้น y-y ของ Eastern Polypack (EPP) และ Aeroklas รวมถึงรายได้ที่ เพิ่มขึ้น 6.8% y-y อัตรากำไรขั้นต้นของ EPG เพิ่มขึ้นเป็น 33.2% จาก 30.2% ใน 2QFY21 (ก.ค.-ก.ย. 20) จากอัตราการใช้กำลังการผลิตที่เพิ่มขึ้นและการควบคุมตันทุนที่มีประสิทธิภาพ อัตรากำไรขั้นต้นของ Aeroflex ลดลง q-q ไปอยู่ที่ 43.8% เทียบกับ 44.1% ใน 2QFY21 ในขณะที่อัตรากำไรขั้นต้นของ Areoklas เพิ่มเป็น 34% เทียบกับ 29.1% ใน 2QFY21 นอกจากนี้อัตรากำไรขั้นต้นของ EPP ดีขึ้น q-q เป็น 21.1% จาก 17.8% ใน 2QFY21 จาก ปริมาณขายที่สูงขึ้นของบรรจุภัณฑ์อาหารและเครื่องดื่ม

Aeroklas เป็นพระเอกที่แท้จริงใน 3QFY21

ใน 3QFY21 รายได้ของ Aeroklas และ EPP เพิ่ม แต่รายได้ของ Aeroflex ลดลง y-y จาก COVID-19 โดยรายได้ของ Aeroflex ลดลง 13% y-y เป็น 648 ลบ. จากยอดขายที่ลดลงทั้งใน และต่างประเทศ รายได้ของ Aeroflex ในสหรัฐฯ ยังอยู่ในระดับสูงที่ 40.6% ของยอดขายรวม ในขณะที่รายได้ของ Aeroflex ในประเทศไทยลดลงเหลือ 31.2% ของยอดขายรวมใน 3QFY21 Aeroklas รายงานรายได้จำนวน 1.29พัน ลบ. เพิ่มขึ้น 24.3% y-y จากความต้องการที่สูงขึ้น จากผู้ผลิตรถยนต์หลังการผ่อนคลายมาตรการปิดเมือง EPP บันทึกรายได้ 653 ลบ. (+7% q-q, +2% y-y) จากความต้องการบรรจุภัณฑ์พลาสติกสำหรับอาหารที่สูงขึ้น

มีปัจจัยบวก 3 ประการสำหรับทุกธุรกิจอยู่ข้างหน้า

เรามองว่าปริมาณขายของ EPG จะเพิ่มต่อเนื่องตั้งแต่ 4QFY21 (ม.ค.-มี.ค. 21) เป็นต้นไปจาก 1) ความต้องการที่เพิ่มขึ้นจากโรงงานผลิตยานยนต์ (Aeroklas); 2) อัตราการใช้กำลังการผลิตที่ สูงขึ้นสำหรับโรงงานในประเทศไทยและการฟื้นตัวของความต้องการสำหรับฉนวน (Aeroflex) ใน 2H21 จากกลุ่มก่อสร้างและอุตสาหกรรม พร้อมกับการเพิ่มกำลังการผลิตในสหรัฐฯ อีก 2 เท่าเป็น 8,000tpa ภายใน ธ.ค. 21; และ 3) การฟื้นตัวของความต้องการสำหรับพลาสติกหลัง ประเทศไทยยกเลิกมาตรการปิดเมืองทั้งหมด ซึ่งอาจเกิดขึ้นใน 2H21

เห็นความเสี่ยงขาขึ้นเพิ่มเติมอยู่ไกล ๆ

เราคงคำแนะนำซื้อที่ราคาเป้าหมาย 12 บาท (FY22E EV/EBITDA ที่ 16.1x) เราเห็นว่าการ ฟื้นตัวของความต้องการสำหรับสินค้าของ EPG การขยายกำลังการผลิตของ Aeroflex และ ต้นทุนวัตถุดิบที่อยู่ในระดับต่ำควรช่วยผลักดันปริมาณขายในทุกธุรกิจใน 4QFY21 และ FY22
