กำไรจากการขายธุรกิจหมุนผลประกอบการในปี 2020

กำไรจากการขายธุรกิจหมุนผลประกอบการ 4Q20

GUNKUL รายงานกำไรสุทธิ (NP) 4Q20 จำนวน 1.7 พัน ลบ. (+221% y-y, +69% q-q) โดยได้แรงหนุนจากกำไรพิเศษจำนวน 1.1 พันจากการขายโรงไฟฟ้าพลังแสงอาทิตย์ Iwakuni กำลังการผลิต 75MW ในประเทศญี่ปุ่น ซึ่งเป็นกำไรจากการขายธุรกิจก่อนที่สองหลังกำไรพิเศษจำนวน 0.8 พัน ลบ. จากการขายโรงไฟฟ้าพลังแสงอาทิตย์ Utsunomiya กำลังการผลิต 69.8MW ใน 3Q20 เมื่อหักกำไรพิเศษดังกล่าว NP จากการดำเนินงานอยู่ที่ 0.4 พัน ลบ. (-23% y-y, +91% q-q) ต่ำกว่าที่เราคาด 5% และต่ำกว่าตลาดคาด 6% จากกำไรที่ลดลงของธุรกิจโรงไฟฟ้าพลังลม กำไรขั้นต้น (GP) ที่ดีขึ้นของธุรกิจโรงไฟฟ้าพลังแสงอาทิตย์ ลม และ EPC ในขณะที่ GP จากธุรกิจ Trading ลดลงเหลือ 79 ลบ. GP จากธุรกิจ EPC เพิ่มขึ้นเป็น 132 ลบ. (+188% y-y) ในขณะที่ธุรกิจโรงไฟฟ้าเพิ่มเป็น 781 ลบ. (+4% y-y) และธุรกิจบริการซ่อมบำรุงเพิ่มเป็น 73 ลบ. (+180% y-y) ซึ่งช่วยชดเชย GP จากธุรกิจ Trading ที่ลดลงเป็น 79 ลบ. (-42% y-y) ค่าใช้จ่ายดอกเบี้ยลดลง 11% q-q เหลือ 235 ลบ. แต่เพิ่มขึ้น 1.6% y-y จากค่าใช้จ่ายดอกเบี้ยที่เพิ่มขึ้นสำหรับโครงการใหม่ ๆ

กำไรที่ลดลงของธุรกิจโรงไฟฟ้าพลังลมกระทบ EBITDA margin

ใน 4Q20 ธุรกิจโรงไฟฟ้าพลังลมรายงาน NP ลดลง อย่างไรก็ดีผลบวกจาก NP ที่เพิ่มขึ้นของโรงไฟฟ้าพลังแสงอาทิตย์ในต่างประเทศ 4 แห่ง กำลังการผลิตรวม 125MW ประกอบด้วยโรงไฟฟ้าพลังแสงอาทิตย์ 2 แห่ง กำลังการผลิต 64.5MW ในประเทศญี่ปุ่นและโรงไฟฟ้าแสงอาทิตย์ 2 แห่งในเวียดนาม (ประกอบด้วย Triviet 1 กำลังการผลิต 60MW และ Bach Khoa A Chau 1 เริ่มดำเนินงานเชิงพาณิชย์ในเดือน ก.พ. 20) มีมากกว่าผลลบจากกำไรที่ลดลงดังกล่าว รายได้จากธุรกิจ EPC เพิ่มขึ้น 117% y-y เป็น 1.6 พัน ลบ. โดยได้แรงผลักดันจากงานที่เพิ่มขึ้นในภาคเอกชนและภาครัฐผ่านบริษัทลูก Future Electrical Control Company (FEC, not listed) EBITDA margin ของ GUNKUL อยู่ที่ 39% เพิ่มขึ้นจาก 30% ใน 3Q20 แต่ลดลงจาก 48% ใน 4Q19 จากกำไรที่ลดลงของโรงไฟฟ้าพลังลมที่มีอัตรากำไรสูงกว่า

คาดมีการซื้อและควบรวมกิจการเพิ่มในปี 2021

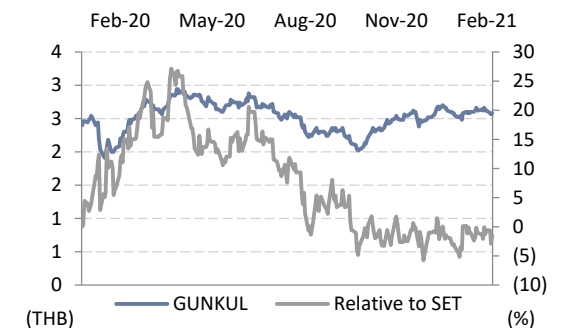
เราคาดว่า การเติบโตของ NP จากการดำเนินงานจะฟื้นตัวในปี 2021 จาก 1) กำไรที่ดีขึ้นของธุรกิจโรงไฟฟ้าจากความเร็วลมที่เพิ่มขึ้นตามฤดูกาล; และ 2) งานในมือที่เพิ่มขึ้นของธุรกิจ EPC มาอยู่ที่ 9 พัน ลบ. จากการประมูลโรงไฟฟ้าย่อยและสายส่ง นอกจากนี้เราคาดว่า GUNKUL จะมองหาโอกาสในการซื้อและควบรวมกิจการมากขึ้นในปี 2021 หลังได้เงินเพิ่มจากการขายธุรกิจ 2 แห่ง

คงคำแนะนำซื้อ

เราคงคำแนะนำซื้อที่ราคาเป้าหมาย 2.9 บาท (SOTP) เราคาดว่า NP จากการดำเนินงานของ GUNKUL จะฟื้นตัว y-y ในปี 2021 จากผลประกอบการที่ดีในธุรกิจโรงไฟฟ้าและรายได้ที่สูงขึ้นของธุรกิจ EPC

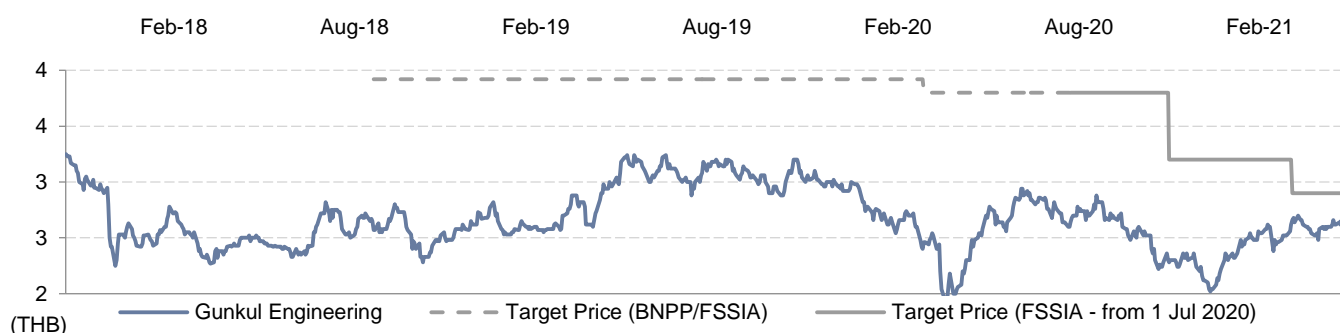
