กัญชาจะช่วยพลิกธุรกิจอาหารและเครื่องดื่มให้ฟื้น

กำไรสุทธิมีแนวโน้มโตต่อเนื่อง

เราคาดว่ากำไรสุทธิจากการดำเนินงานของ PTG จะยังคงดี โดยคาดว่าจะอยู่ที่ 450 ลบ. ใน 1Q21 (-29.7% q-q, +121.2% y-y) จาก 1) ปริมาณขายที่ลดลงในเดือน ม.ค. 21 จากผลกระทบจากการแพร่ระบาดของไวรัส Covid ในรอบที่ 2; และ 2) ส่วนแบ่งกำไรที่ลดลงจากธุรกิจไบโอดีเซลหลังราคาน้ำมันปาล์มและ B100 ลดลง อย่างไรก็ตามเราเชื่อว่ากำไรสุทธิจะถูกชดเชยได้บางส่วนจาก 1) Marketing Margin ที่ทรงตัว q-q จากธุรกิจสถานีบริการน้ำมัน โดยคาดว่าจะอยู่ที่ 1.8-1.9 บาทต่อลิตร; และ 2) ปริมาณขายน้ำมันที่สูงขึ้นมาอยู่ที่ 1.4 พันล้านลิตรใน 1Q21 (+8% q-q, +16% y-y) เพิ่มขึ้นจาก 1.3 พันล้านลิตรใน 4Q20 จากปริมาณขายปลีกที่สูงขึ้น

หนึ่งในผู้ประกอบการรายแรก ๆ ที่จับสินค้าอาหารและเครื่องดื่มผสมกัญชา

เมื่อวันที่ 27 มี.ค. 2021 PTG เริ่มธุรกิจกัญชาโดยได้เปิดตัวรายการอาหารและเครื่องดื่มผสมกัญชาประกอบด้วย ข้าวผัดกะเพรา ก๋วยเตี๋ยว ไบ๊วกุ๊ชาทอด กาแฟ ชา และ Jelly Soda ผู้บริหารระบุว่าสินค้าใหม่ที่ผลิตจากกัญชาประสบความสำเร็จอย่างสูงและได้รับการตอบรับที่ดีจากผู้บริโภค ปัจจุบัน PTG ให้บริการเครื่องดื่มผ่านร้าน PunThai Coffee ทั้ง 6 แห่งและ Coffee World อีก 4 แห่งในกรุงเทพฯ PTG ตั้งเป้าเพิ่มยอดขายของ PunThai และขึ้นเป็นอันดับ 2 ของตลาดในแง่ปริมาณขายกาแฟโดยใช้ประโยชน์จากธุรกิจอาหารและเครื่องดื่มผสมกัญชา

ปัจจุบันการใช้กัญชาเป็นเรื่องถูกกฎหมาย

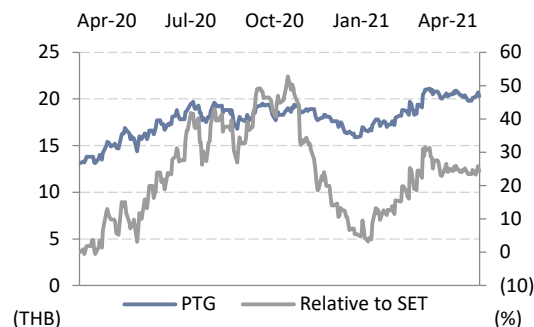
กระทรวงสาธารณสุขของไทยประกาศว่า ครอบ, ใต้มมีดีให้ตัดใบ ก้าน และรากของต้นกัญชาออกจากบัญชีรายการสารเสพติด ทำให้สามารถใช้กัญชาเพื่อประโยชน์ทางการแพทย์ รวมถึงในอุตสาหกรรมเครื่องสำอาง เครื่องสำอางค์ และยา การอนุญาตดังกล่าวไม่รวมถึงเมล็ดและช่อดอก ซึ่งมีส่วนประกอบของสารออกฤทธิ์ต่อจิตประสาท กล่าวคือ Tetrahydrocannabinol หรือ THC ในระดับสูง ปัจจุบันกัญชายังมีจำนวนจำกัดแต่ PTG มีความสามารถในการจัดหากัญชาเพื่อใช้ในสินค้าอาหารและเครื่องดื่มที่ขายผ่านร้าน PunThai และ Coffee World

เราคงคำแนะนำซื้อที่ราคาเป้าหมาย 24.5 บาท เราเชื่อว่ากำไรสุทธิรายไตรมาสของ PTG จะดีขึ้นต่อเนื่องในปี 2021-22 จากแผนการขยายสถานีบริการน้ำมันในปัจจุบัน ปริมาณขายที่กำลังเพิ่มขึ้น และ EBITDA ที่กำลังดีขึ้นจากธุรกิจที่ไม่ใช่น้ำมันประกอบด้วย อาหารและเครื่องดื่ม จากสินค้าผสมกัญชาและ LPG รวมถึงกำไรสุทธิที่สูงขึ้นจากธุรกิจไบโอดีเซล PTG คงเป้าหมายในการเพิ่ม 100-150 สถานีบริการน้ำมันใหม่ต่อปีและเพิ่มส่วนแบ่งตลาดของ LPG ที่ใช้ภายในบ้านโดยจะเพิ่มร้านขายก๊าซหุงต้มอาหาร 50 แห่งในปี 2021

Exhibit 2: Cannabis-infused food



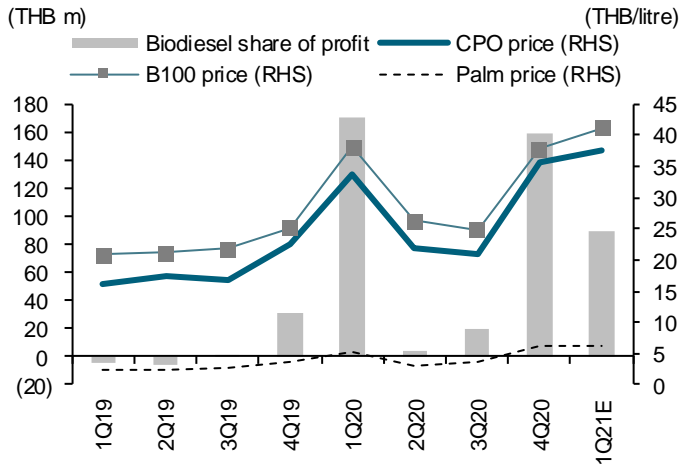

Exhibit 3: Cannabis-infused beverages



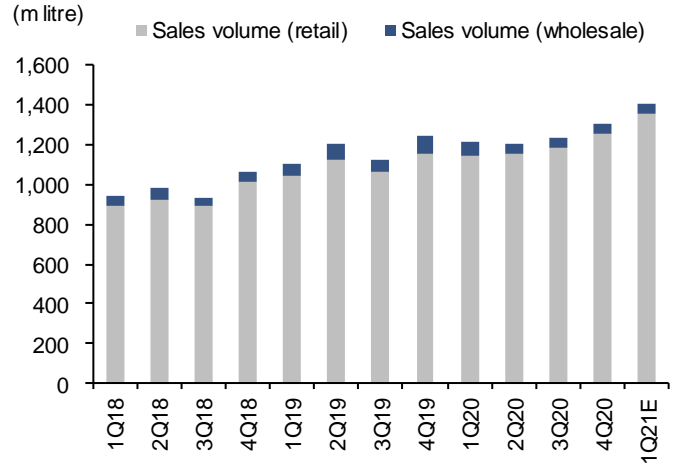

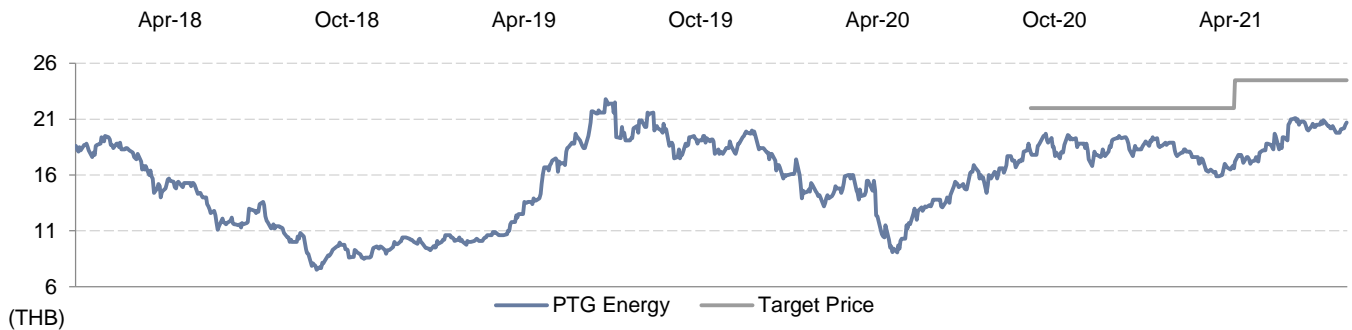
