ผลประกอบการออกมาตามคาด และกำลังฟื้นตัว

ผลประกอบการ 1Q21 ออกมาตามคาด

HMPRO รายงานกำไรสุทธิ 1Q21 ที่ 1.36 พัน ลบ. (+7.6% y-y, -11.8% q-q) ตามที่ตลาดคาด โดยได้แรงผลักดันจากผลประกอบการสาขาที่ดีขึ้นในหลายภูมิภาค ยกเว้นในแหล่งท่องเที่ยว การเติบโตของยอดขายจากสาขาเดิม (SSSG) เฉลี่ยอยู่ที่ประมาณ 1% (0.5% สำหรับ HomePro, 5% สำหรับ Mega Home และประมาณ 13% สำหรับ HMPRO Malaysia) รายได้ค่าเช่าลดลง 15% y-y เหลือ 325 ลบ. หลังการยกเลิกงาน HomePro Expo ซึ่งเดิมมีกำหนดในเดือน มี.ค. 21 โดยปกติงานดังกล่าวจะสร้างรายได้ค่าเช่า 70-80 ลบ. จากผู้ขายสินค้าให้กับบริษัท ในขณะที่ส่วนลดค่าเช่าเฉลี่ยเพิ่มเป็นประมาณ 20% เทียบกับ 10-20% ใน 4Q20 เนื่องจากการแพร่ระบาด Covid ในรอบที่ 2 และ 3 อัตรากำไรขั้นต้นทรงตัว y-y อยู่ที่ 25.7% เนื่องจากสัดส่วนสินค้าไม่ได้เปลี่ยนอย่างมีนัยสำคัญ สัดส่วนสินค้า Private Brand อยู่ที่ 19.5% เทียบกับ 19.5% ในปี 2020 สัดส่วนยอดขายต่อค่าใช้จ่ายในการขายและการบริหารลดลง 60bps y-y เหลือ 17% หลังการควบคุมต้นทุนที่มีประสิทธิภาพด้วยการลดค่าใช้จ่ายพนักงานและสาธารณูปโภค

คาด SSSG ระดับสูงใน 2Q21 จากฐานที่ต่ำ

เราเชื่อว่าการแพร่ระบาด Covid ในรอบที่ 3 จะมีผลกระทบต่อ HMPRO เนื่องจากรัฐบาลไม่ได้ปิดเมืองเหมือนเช่นปีที่แล้ว เราคาดว่า SSSG จะฟื้นตัวดีเป็น 60% ในเดือน เม.ย. 21 จากฐานที่ต่ำหลังการปิดสาขา (-50% SSSG ในเดือน เม.ย. 20) และการจัดงาน Super Expo ในช่วงวันที่ 2-6 เม.ย. ที่สาขาแทนที่จะจัด HomePro Expo อย่างไรก็ตาม เราคาดว่า SSSG ในเดือน พ.ค.-มิ.ย. จะติดลบ y-y จากการแพร่ระบาด Covid ในรอบที่ 3 ในภาพรวม SSSG ใน 2Q21 ควรออกมาเป็นบวกได้ที่ประมาณ 15%

แผนการขยายธุรกิจอยู่ในระดับต่ำกว่าเพื่อน

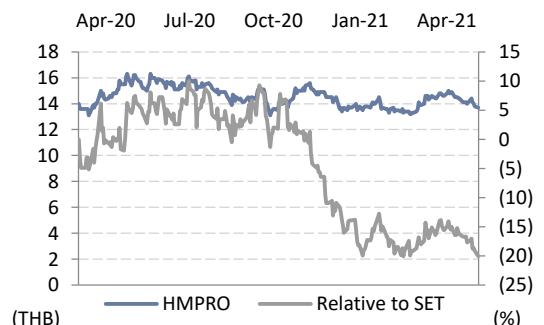
HMPRO ยังไม่ได้เปิดสาขาใหม่ใน 1Q21 บริษัท ตั้งใจเปิด 1 สาขาใหม่ในมาเลเซียภายในเดือน มิ.ย. 21 และอีก 1 สาขาในรูปแบบของ HomePro ในประเทศไทยภายใน 4Q21 ในมาเลเซียสาขาใหม่มีแนวโน้มต้องใช้เวลา 1-2 ปีก่อนคุ้มทุน เราคาดว่าจะเห็นแผนการขยาย Mega Home นับตั้งแต่ปี 2022 เป็นต้นไปจากนโยบายการขยายธุรกิจแบบระมัดระวังของบริษัท ในช่วงโรคระบาด

มีการซื้อขายในระดับการประเมินมูลค่าที่น่าสนใจ

เราปรับเพิ่มราคาเป้าหมายของเราเป็น 17.5 บาท จาก 16.5 บาท (DCF) หลังปรับการประเมินมูลค่าไปในปี 2022 ปัจจุบัน HMPRO มีการซื้อขายในระดับการประเมินมูลค่าที่น่าสนใจ โดยอยู่ที่ 28x ของค่า 2022E P/E ใกล้กับ -1.0SD ของค่าเฉลี่ย 5 ปีย้อนหลัง เราคาดว่า การฉีดวัคซีนและการกลับมาเปิดอุตสาหกรรมท่องเที่ยวจะเป็นปัจจัยบวกสำคัญที่จะผลักดันราคาหุ้นของบริษัท ตั้งแต่ช่วง 2H21 เป็นต้นไป

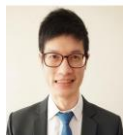

Investment thesis

HMPRO is the leading player in the home improvement sector, with a c22% market share based on revenue of THB62b in 2020. Despite the slowdown in the property sector in 2018-20, HMPRO has continued to deliver double-digit earnings growth, even though new-home customers have declined from 50% of total customers to about 20% (2015-20). Sales to renovation customers have grown to c50% currently, which are more sustainable, in our view. Moreover, about 30% of total customers are contractors, which should benefit from government spending.

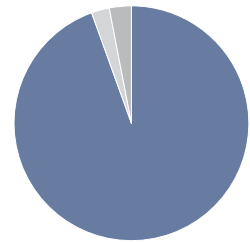
Company profile

HMPRO is a home-improvement product seller that targets the mid- to high-end segment. From 2013, it started to expand aggressively, both with its HomePro stores and in the budget segment with its Mega Home stores. It also expanded to Malaysia by setting up a store around the end of 2014.

Principal activities (revenue, 2020)

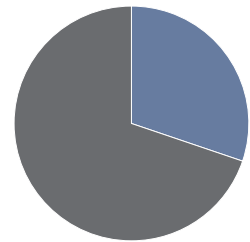

Catalysts

Potential catalysts include the faster-than-expected turnaround of overseas operations, the better-than-expected macro outlook in Thailand, and a higher proportion of house brands to drive its gross profit margin (GPM).

Risks to our call

The key downside risks to our DCF-based TP include: 1) lower-than-expected SSSG; 2) the slow recovery of tourist numbers; and 3) operating losses from its overseas business.

Earnings sensitivity

- For every 1% increase in SSSG we estimate 2021 EPS would rise 1%, and vice versa, all else being equal.
- For every 0.1% increase in GPM we estimate 2021 EPS would rise 1.1%, and vice versa, all else being equal.
- For every 0.1% increase in SG&A to sales we estimate 2021 EPS would fall 1.1%, and vice versa, all else being equal.

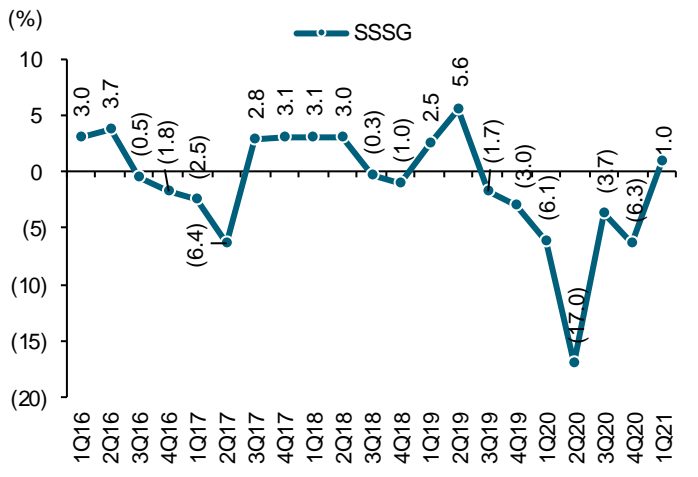

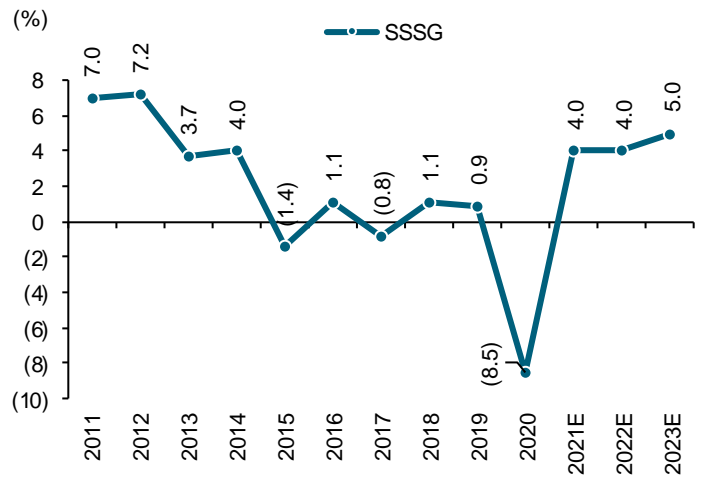

Exhibit 3: Yearly SSSG



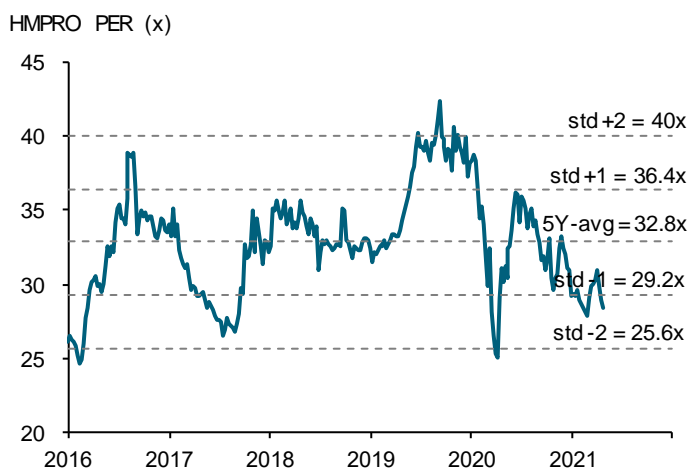

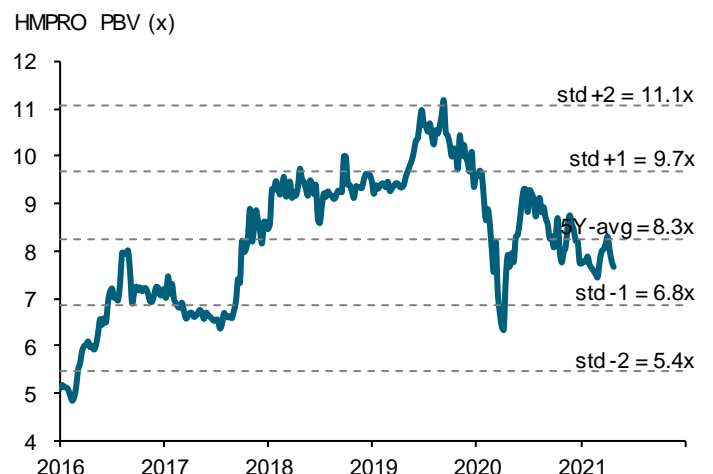

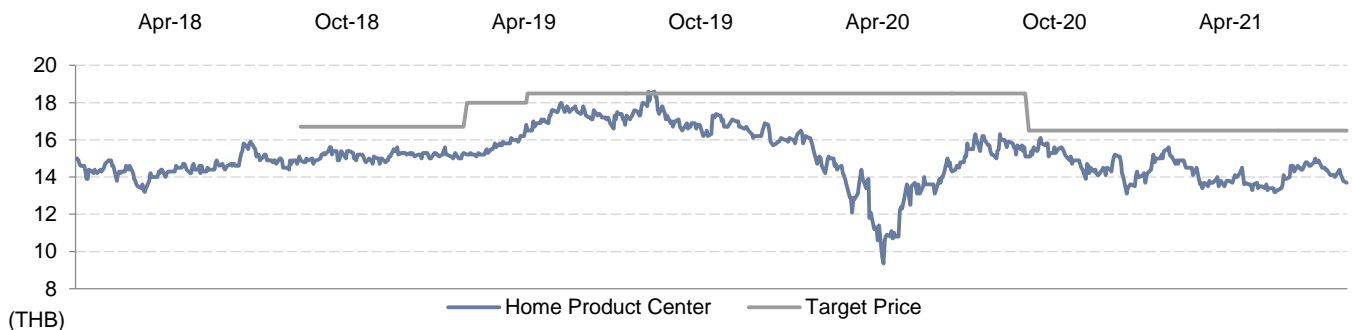
