## ปริมาณขายน้ำมันอยู่ในระดับสูงใน 1Q21

### ปริมาณขายที่อยู่ในระดับสูงช่วยหนุนผลประกอบการ 1Q21

PTG รายงานกำไรสุทธิ (NP) 1Q21 ที่ 531 ลบ. (+161% y-y, -21% q-q) สูงกว่าตลาดคาด 5% และราคาดี 10% โดยได้ปัจจัยหนุนจาก 1) ปริมาณขายน้ำมันผ่านสถานีบริการน้ำมันที่เพิ่มขึ้นเป็น 1,265 ล้านลิตร (+10% y-y, +0.5% q-q) ซึ่งคิดเป็น 95% ของปริมาณขายรวมของ PTG จาก 7 สถานีบริการที่เพิ่มใหม่ใน 1Q21 ปัจจัยดังกล่าวช่วยขยาย Marketing margin ที่ลดลง q-q มาอยู่ที่ประมาณ 1.8-1.9 บาทต่อลิตร; 2) ส่วนแบ่งกำไร 78 ลบ. จากธุรกิจไบโอดีเซลซึ่งลดลงจาก 159 ลบ. ใน 4Q20 และ 170 ลบ. ใน 1Q20 จากการจับคู่ที่ก่อให้เกิดผลร้ายระหว่างต้นทุนที่อยู่ในระดับสูงในเดือน ก.พ. 20 และราคาขายที่ลดลงอย่างรุนแรงในเดือน มี.ค. 20 จากอัตราการหมุนเวียนสินค้าคงคลังที่ 14-30 วัน; และ 3) กำไรขั้นต้นของธุรกิจที่ไม่ใช่น้ำมันที่กระโดดเพิ่ม 28.5% y-y ส่วนมากจากปริมาณขายที่เพิ่มขึ้นของ Punthai

### กำไรจากธุรกิจที่ไม่ใช่น้ำมันดีขึ้น

ใน 1Q21 รายได้เพิ่ม 10.8% y-y มาอยู่ที่ 32.3 พัน ลบ. ซึ่งน่าจะเกิดจากปริมาณขายรวมที่เพิ่ม 9.8% y-y พร้อมราคาขายปลีกที่สูงขึ้น 0.8% y-y กำไรขั้นต้นของธุรกิจที่ไม่ใช่น้ำมันประกอบด้วย LPG, อาหารและเครื่องดื่ม (F&B) และร้านสะดวกซื้อเพิ่ม 28.5% y-y โดยได้ปัจจัยหนุนจากยอดขาย LPG (+7.6% q-q ในแง่ปริมาณขาย) และ Punthai (+14% y-y) PTG บรรลุเป้าหมายสาขา Punthai โดยเพิ่มเป็น 281 แห่งจาก 274 สาขา ณ สิ้นปี 2020 จากข้อมูลของผู้บริหาร Punthai ได้แตะจุดคุ้มทุนที่ระดับ EBITDA ใน 1Q21 และบริษัท คาดว่าธุรกิจดังกล่าวจะเข้าสู่จุดคุ้มทุนที่ระดับ NP ในช่วง 2H21 PTG ตั้งเป้าเพิ่ม Punthai อีก 50 สาขา Max Mart อีก 50 สาขาและ Autobacs อีก 20 สาขาในปี 2021

### การเติบโตของ EBITDA ยังเป็นไปตามเป้าในปี 2021

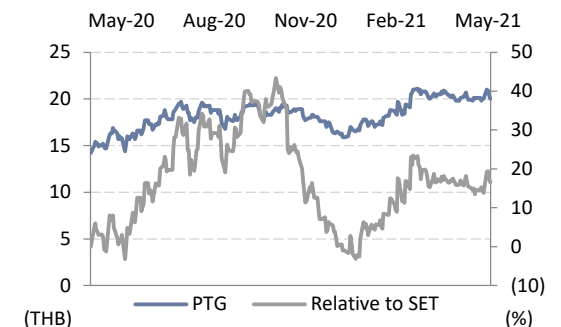
เราเชื่อว่า PTG จะสามารถบรรลุเป้าหมายการเติบโตของ EBITDA ที่ 10-15% y-y ในปี 2021 และคาดว่า EBITDA จากธุรกิจที่ไม่ใช่น้ำมันและ Bio-Complex จะโตในปี 2021 โดยได้ปัจจัยผลักดันจากปริมาณขาย F&B ที่สูงขึ้นของ Punthai เราคาดว่า NP จากธุรกิจ Biodiesel Complex ที่ PTG ถือหุ้น 40% จะยังคงดี โดยจะอยู่ในช่วง 240-260 ลบ. ในปี 2021 ตามที่บริษัท ได้ให้ข้อมูลไว้จากราคาน้ำมันที่ทรงตัวในระดับสูง ความต้องการที่เพิ่มขึ้นในธุรกิจ Biodiesel และสัดส่วนปริมาณขาย B10 ที่สูงขึ้น

### การเติบโตของปริมาณขายเป็นกุญแจสำคัญ

เราคาดว่าแนวโน้มราคาเป้าหมาย 24.5 บาท (SoTP) เราคาดว่า NPs รายไตรมาสของ PTG จะดีขึ้นในปี 2021-22 โดยได้ปัจจัยผลักดันจากการขยายสถานีบริการน้ำมันที่บริษัท กำลังดำเนินงานอยู่ ปริมาณขายน้ำมันที่เพิ่มขึ้นและ EBITDA ที่สูงขึ้นของธุรกิจที่ไม่ใช่น้ำมัน รวมถึง NPs ที่สูงขึ้นจากธุรกิจ Biodiesel

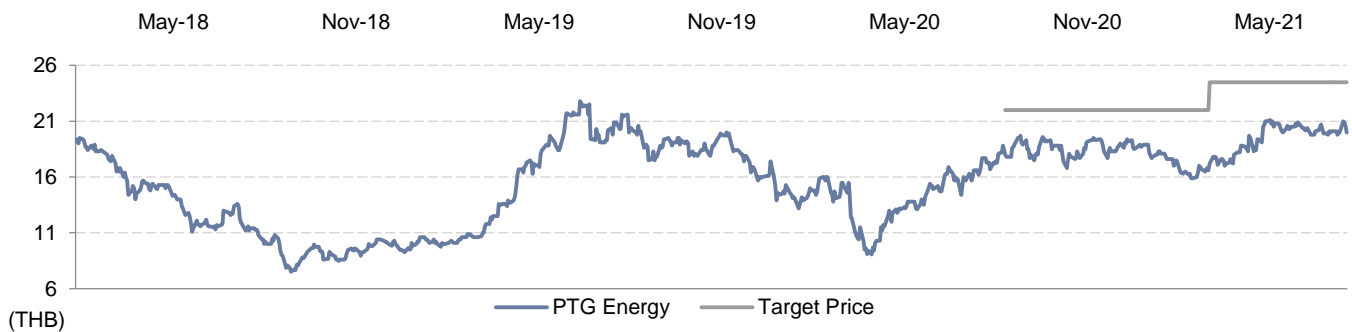
