A solid, in-line 2Q21 result

ผลประกอบการ 2Q21 แข็งแกร่งตามคาด

BPP รายงานกำไรหลักใน 2Q21 จำนวน 1,033 ลบ. เพิ่มขึ้น 6% q-q ส่วนกำไรสุทธิอยู่ที่ 1,126 ลบ. (+8.8% q-q) ดีกว่าที่เราคาด 1% และ Bloomberg's consensus คาด 5% เนื่องมาจาก 1) ส่วนแบ่งกำไรจาก BLCP 78 ลบ. +64% q-q เพราะไม่มีการปิดซ่อมบำรุงตาม กำหนดซึ่งส่งผลให้ค่าพร้อมจ่าย (EAF) มีอัตราสูงถึง 87% 2) โรงไฟฟ้า CHP ในประเทศจีนมี ผลขาดทุน 12 ลบ. จากอัตรากำไรขั้นต้นที่ลดลงเพราะราคาถ่านหินสูงขึ้น 3) ส่วนแบ่งกำไรจาก โรงไฟฟ้าหงสา (HPC) 1.1 พันลบ. +36% q-q เนื่องจากอุปสงค์ที่สูงขึ้น 4) ผลขาดทุนสุทธิ 20 ลบ.ของ Banpu Next (non listed).

โรงไฟฟ้า HPC เป็นตัวขับเคลื่อน

กำไรสุทธิใน 2Q21 ที่เพิ่มขึ้น 8.8% q-q เป็นผลมาจาก 1) ส่วนแบ่งกำไรของโรงไฟฟ้า HPC และ BLCP เพิ่มขึ้น q-q และ 2) กำไรจากอัตราแลกเปลี่ยน 38 ลบ. ในไตรมาสนี้ BPP ได้รับ ส่วนแบ่งกำไรจากบริษัทร่วมที่แข็งแกร่ง 1.2 พันลบ. เมื่อเทียบกับ 739 ลบ. ใน 1Q21 ค่าความ พร้อมจ่ายของโรงไฟฟ้า HPC ที่สูงถึง 92% ทำให้มีส่วนแบ่งกำไร 1.1 พันลบ. +36% q-q รวม กำไรจากอัตราแลกเปลี่ยนจำนวน 79 ลบ. ส่วนโรงไฟฟ้า SLG มีส่วนแบ่งขาดทุน 42ลบ.ใน 2Q21 เนื่องจากอัตราการใช้กำลังการผลิตลดลง และเนื่องจาก BPP อยู่ระหว่างการ เตรียมพร้อมเครื่องจักรซึ่งเราคาดว่าการใช้กำลังการผลิตจะเพิ่มขึ้นแตะ 80-90% ใน 4Q21 จาก ความต้องการที่สูงขึ้นตามฤดูกาล เราคาดว่าค่าความพร้อมจ่ายของ HPC จะแข็งแกร่งที่ระดับ 85-87% ในปี 2021-23 เนื่องจากการปิดช่อมบำรุงตามแผนได้แล้วเสร็จในปี 2020-1Q21 ส่วน BLCP มีส่วนแบ่งขาดทุน 78 ลบ.ใน 2Q21 โดยรวมผลขาดทุนจากอัตราแลกเปลี่ยน 41 ลบ.

กำไรปี 2021 แข็งแกร่งจากโครงการใหม่


เราคาดกำไรจากการดำเนินงานใน 3Q21-2022 จะแข็งแกร่งจากความต้องการที่สูงขึ้นตาม ฤดูกาลและค่าไฟที่สูงขึ้น ขณะที่การเติบโตของกำไรจากโรงไฟฟ้าพลังงานลมแห่งใหม่ใน เวียดนามที่ดำเนินการเชิงพาณิชย์ใน 2Q21 (30MW) และเริ่มรับรู้รายได้ (37.5MW) จะช่วย ชดเชยส่วนแบ่งกำไรที่อ่อนแอของ BLCP ได้ เราคาดกำไรสุทธิของ BPP จะเติบโต 2-43% ใน ปี 2021-23 โดยจะเร่งตัวในปี 2021 จากส่วนแบ่งกำไรที่ดีขึ้นของ HPC การ COD ของ SLG ในเดือน เม.ย. 2021 และกำไรที่สูงขึ้นของโรงไฟฟ้าที่เพิ่งเข้าไปลงทุนได้ Nakoso และโซลาร์ และโรงไฟฟ้าพลังงานลม

การเติบของกำไรแข็งแกร่งต่อเนื่อใน 2H21-2022

เราคงคำแนะนำซื้อ ด้วยราคาเป้าหมาย 23 บาท (SOTP) ธุรกิจของ BPP กำลังหันไปมุ่งเน้น การเพิ่มสัดส่วนพลังงานสีเขียว เช่นการลงทุนในธุรกิจ EV และแบตเตอรี่ เหล่านี้จะช่วยเพิ่ม สัดส่วนกำไรที่มาจากพลังงานสีเขียวเป็น 20% ในปี 2022 จาก 13% ในปี 2020
