## ผ่านจุดสูงสุดเข้าสู่ช่วงขาลง

## อยู่ในแนวโน้มขาลง

STGT รายงานกำไรสุทธิ (NP) 2Q21 อยู่ที่ 7.3 พัน ลบ. (+589% y-y, -28% q-q) ต่ำกว่าที่ตลาดคาด 9% และต่ำกว่าที่เราคาด 10% โดยมีปัจจัยกดดันจากราคาขายเฉลี่ย (ASP) ที่ลดลง 4.8% q-q เหลือ USD72.7 ต่อ 1,000 ชิ้น (ptp) จากความต้องการที่ลดลงของถุงมือยางสังเคราะห์ที่มีอัตราค่าไถ่สูง นอกจากนี้ปริมาณขายยังลดลง 15% q-q เหลือ 5.7 พันล้านชิ้นจากปัญหาติดขัดด้านการขนส่งส่วนมากในสหรัฐฯ, การสูญเสียการผลิตของโรงงาน TR และ TG จากการปิดที่เกี่ยวข้องกับ Covid, และต้นทุนวัตถุดิบที่สูงขึ้นของน้ำยางธรรมชาติ (NR) และยางสังเคราะห์ (NBR) เมื่อหักผลขาดทุนพิเศษจำนวน 120 ลบ. NP จากการดำเนินงานอยู่ที่ 7.4 พัน ลบ. (+649% y-y, -28% q-q) อัตราการใช้กำลังการผลิตลดลงเหลือ 88% จาก 95% ใน 1Q21 นอกจากนี้ปริมาณการขายยังลดลง 15% q-q จากปัญหาการขาดแคลนตู้ขนส่งสินค้า

## อัตรากำไรลดลงจาก ASP ที่ลดลง

ใน 2Q21 รายได้ลดลง 16% y-y ในขณะที่ EBITDA ลดลง 25% q-q พร้อม EBITDA margin ที่ตกลงเหลือ 65% จาก 73% ใน 1Q21 แต่เพิ่มขึ้นจาก 30% ใน 2Q20 อัตรากำไรขั้นต้นลดลงเหลือ 65% จาก 74% ใน 1Q21 แต่เพิ่มขึ้นจาก 29% ใน 2Q20 โดยได้ปัจจัยผลักดันจาก ASP ที่ลดลงเหลือ USD72.7ptp (-4.8% q-q) และ 2,268 บาท ptp (-1.3% q-q) อัตรากำไรสุทธิลดลงเหลือ 56% จาก 65% ใน 1Q21 จากค่าใช้จ่ายภาษีที่สูงขึ้น แม้ว่าต้นทุนทางการเงินจะลดลง 18.4% y-y เนื่องจาก STGT ได้จ่ายคืนหนี้จำนวน 2.1 พัน ลบ.

## ASP ที่ลดลงจะบดบังกำลังกำลังการผลิตที่สูงขึ้น

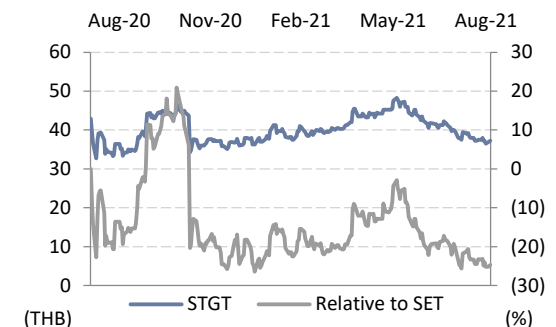
เราคาดว่า NP ของ STGT จะลดลงต่อเนื่องในช่วง 2H21-23 โดยมีปัจจัยกดดันจาก ASP ที่ลดลงเหลือ USD40ptp ในปี 2022 และต้นทุนราคาขายที่คาดว่าจะสูงขึ้น 32-54% y-y ในปี 2021-22 ในขณะที่เราคิดว่าคำสั่งซื้อในมือของถุงมือ NR และ NBR ที่อยู่ในระดับสูงจะยังมีต่อเนื่องไปในปี 2022-23 เราคิดว่า ASP ที่คาดว่าจะลดลงอย่างรุนแรงและอัตราการใช้กำลังการผลิตที่อยู่ในระดับต่ำจากปัญหาการขาดแคลนตู้ขนส่งสินค้าจะมีต่อเนื่องในช่วง 2H21 STGT ยังคงมุ่งมั่นที่จะเพิ่มกำลังการผลิต โดยวางแผนให้ได้กำลังการผลิต 35.85 พันล้านชิ้นในปี 2021, 50.4 พันล้านชิ้นในปี 2022, และ 82 พันล้านชิ้นในปี 2024 โดยจะเพิ่มขึ้นจาก 32.5 พันล้านชิ้นในปี 2020 พร้อมตั้งเป้าให้ได้สัดส่วน 50% สำหรับถุงมือ NR และ 50% สำหรับถุงมือ NBR ในปี 2024

## คำแนะนำถือ

เราแนะนำให้ถือที่ราคาเป้าหมาย 39 บาท เราคิดว่ากระแสการเติบโตของกำไรสุทธิของ STGT จะอ่อนตัวในปี 2022-23 จากแนวโน้มกำไรสุทธิของอุตสาหกรรมที่อ่อนแอจาก ASP ที่คาดว่าจะปรับตัวลดลง

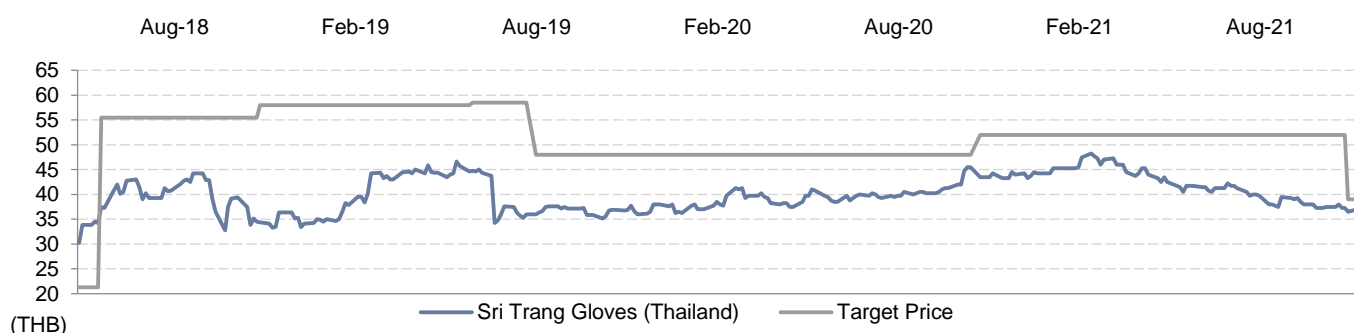
