## ผลประกอบการดีในทุกธุรกิจ

## โรงไฟฟ้าพลังน้ำและ HPC เป็นปัจจัยผลักดันสำคัญ

RATCH รายงานกำไรสุทธิ (NP) 2Q21 จำนวน 2.1พัน ลบ. (+98% y-y, +1.7% q-q) โดยได้ปัจจัยผลักดันส่วนมากจากส่วนแบ่งกำไรที่เพิ่มขึ้นจากอัตราการใช้กำลังการผลิตที่สูงขึ้นของโรงไฟฟ้าหงสา (HPC) และโรงไฟฟ้าพลังน้ำของบริษัท เมื่อหักผลขาดทุนอัตราแลกเปลี่ยนเงินจำนวน 67 ลบ. NP จากการดำเนินงานจะอยู่ที่ 2.2พัน ลบ. (+311% y-y, +20% q-q) สูงกว่าที่เราคาด 2% และตลาดคาด 8% โดยมีประเด็นสำคัญประกอบด้วย: 1) NP ตามส่วนการถือหุ้นจาก HPC จำนวน 1,060 ลบ. (รวมกำไรอัตราแลกเปลี่ยนเงินจำนวน 83 ลบ.) เพิ่มขึ้น 2.9x y-y; 2) รายได้ตามส่วนการถือหุ้นจำนวน 65 ลบ. จากโรงไฟฟ้าถ่านหินในเวียดนาม; 3) รายได้ตามส่วนการถือหุ้นที่สูงขึ้นจากโรงไฟฟ้าพลังน้ำ 2 แห่งประกอบด้วย Nam Ngum 2 (ผ่านการใช้หุ้นใน Southeast Asia Energy) จำนวน 91 ลบ. และ Xepian Xe-Namnoy จำนวน 42 ลบ. (ผ่าน PNP) ดึงขึ้นจากที่เคยขาดทุนสุทธิ 111.6 ลบ. ใน 2Q20 จากระดับน้ำที่สูงขึ้น; และ 4) รายได้ที่สูงขึ้นจากโรงไฟฟ้าพลังลม 2 แห่งประกอบด้วย Yandin และ Collector ในออสเตรเลียหลังดำเนินการผลิตเต็มกำลัง

## รายได้เพิ่มขึ้นจากทั้งโรงไฟฟ้าขนาดใหญ่และขนาดเล็ก

ใน 2Q21 รายได้ของ RG เพิ่มขึ้น 0.2% y-y จากค่าพร้อมจ่าย (AP) ที่สูงขึ้นเนื่องจากไม่มีการปิดซ่อมบำรุงครั้งใหญ่ ในขณะที่รายได้ของ RATCH-Australia (RAC) เพิ่มขึ้น 19.6% q-q จากการดำเนินการผลิตเต็มกำลังของ 2 โรงไฟฟ้าพลังลม กล่าวคือ Yandin และ Collector อย่างไรก็ตาม RATCH Cogen (RCO) รายงานรายได้ลดลง y-y มาอยู่ที่ 534 ลบ. (-3% y-y) จากความต้องการที่ลดลง โรงไฟฟ้าขนาดเล็กของ RATCH รายงาน NP สูงขึ้น y-y โดยประกอบด้วย Berkprai (+2.4 ลบ. y-y), RW Cogen (+0.8 ลบ. y-y) และ Navanakorn Electricity (+36.4 ลบ. y-y) จากความต้องการที่สูงขึ้น

## กำไรจะโตสูงต่อเนื่องในช่วง 2H21-2022

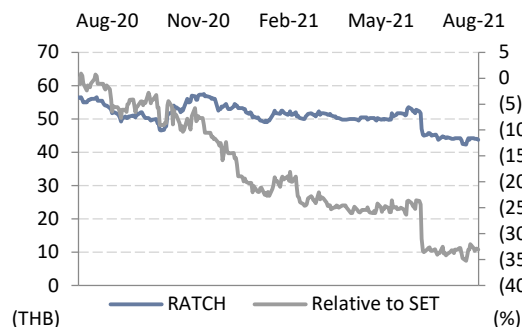
เราคาดว่ากำไรจะโตในระดับสูงในปี 2021-22 โดยมีสมมติฐานจาก 1) ค่า Availability Factor ที่สูงขึ้นเป็น 85-87% ของ HPC ในช่วง 2H21-22; และ 2) การเติบโตของกำลังการผลิตตามส่วนการลงทุน (137MW) จากโรงไฟฟ้าถ่านหิน Thang Long ขนาด 620MW ผ่าน An Binh Energy and Infrastructure Fund และจากโรงไฟฟ้าพลังน้ำเคลียร์ Guangxi Fangchenggang ในจีน (+236MW ใน 2021E), โรงไฟฟ้า Riau ในอินโดนีเซีย (+146MW ในปี 2021E) และ HKP ในประเทศไทย (+700MW ในปี 2024-25E)

## คงแนะนำซื้อ

เราคงคำแนะนำซื้อที่ราคาเป้าหมาย 60 บาท เราเชื่อว่ากลยุทธ์ในระยะสั้นของ RATCH ในการเลือกการเติบโตก่อนสิ่งแวดล้อมจะช่วยให้บริษัท สามารถทำให้กลยุทธ์การเติบโตแบบเป็นมิตรต่อสิ่งแวดล้อมมากยิ่งขึ้นในระยะยาวเป็นจริงได้ด้วยสัดส่วนรายได้จากพลังงานหมุนเวียนที่ 25% ซึ่งจะทำให้ RATCH อยู่ในระดับเดียวกับ 2 หุ้นเติบโตชั้นนำกล่าวคือ BGRIM และ GULF

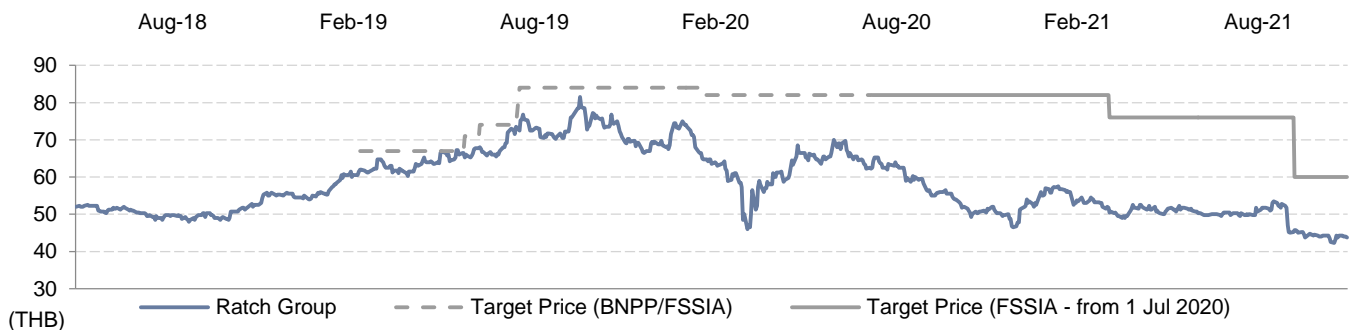
