## Empire of the sun

### ดวงอาทิตย์กำลังส่องสว่างในญี่ปุ่นใน 2Q21

ใน 2Q21 กำไรสุทธิจากการดำเนินงาน (NP) ของ SSP อยู่ที่ 235 ลบ. (+32% q-q, +13% y-y) สูงกว่าที่เราคาด 5% และตลาดคาด 10% NP ที่สูงขึ้นเกิดจากการเติบโตของกำลังการผลิตจากโรงไฟฟ้าพลังแสงอาทิตย์ใหม่ กล่าวคือ Yamaga (กำหนดดำเนินงานเชิงพาณิชย์ในเดือน มิ.ย. 20) ในญี่ปุ่น รายได้จากโรงไฟฟ้าแสงอาทิตย์ในญี่ปุ่นกระโดดเพิ่มเป็น 210 ลบ. (+20% q-q, +44% y-y) รายได้จากแผงกำเนิดไฟฟ้าบนหลังคาในอินโดนีเซียเพิ่มเป็น 4.4 ลบ. (+100% q-q, +633% y-y) ในขณะที่รายได้จากโรงไฟฟ้าพลังแสงอาทิตย์ในไทยเพิ่ม q-q เป็น 237 ลบ. (+3% q-q) อย่างไรก็ตามรายได้จากโรงไฟฟ้าพลังแสงอาทิตย์อื่นลดลง y-y ประกอบด้วยโรงไฟฟ้าพลังแสงอาทิตย์ขนาด 50MW ในเวียดนาม (-6% y-y) จากปริมาณไฟฟ้าที่ลดลงและโรงไฟฟ้าพลังแสงอาทิตย์ขนาด 16MW ในมองโกเลีย (-2.2% y-y) เมื่อรวมกำไรจากอัตราแลกเปลี่ยนที่ยังไม่ได้รับรู้จำนวน 5.2 ลบ. (เทียบกับผลขาดทุน 57.7 ลบ. ใน 2Q20) บริษัท รายงาน NP อยู่ที่ 230 ลบ. (+52.6% q-q, +53.0% y-y)

### อินโดนีเซียเป็นปัจจัยหนุนการเติบโตใหม่

ใน 2Q21 รายได้ของ SSP เพิ่มขึ้นเป็น 557 ลบ. (+14% q-q, +13% y-y) จากยอดขายไฟฟ้าที่สูงขึ้นในญี่ปุ่น (+44% y-y) และอินโดนีเซีย (+633% y-y) ซึ่งช่วยชดเชยรายได้ที่ลดลงในประเทศไทย (-3.7% y-y), เวียดนาม (-6% y-y) และมองโกเลีย (-2.2% y-y) ค่าเสื่อมและค่าตัดจำหน่ายเพิ่ม y-y เป็น 128 ลบ. (+38% y-y, -0.8% q-q) จากค่าเสื่อมที่เพิ่มขึ้นจากโครงการใหม่ ๆ ต้นทุนการเงินอยู่ที่ 80 ลบ. (+11% y-y, -1.2% q-q) จากการเบิกสินเชื่อระยะยาวจากทั้งสถาบันการเงินในไทยและญี่ปุ่นเพื่อลงทุนในโครงการใหม่ ๆ

### การเติบโตเห็นอยู่ไม่ไกล

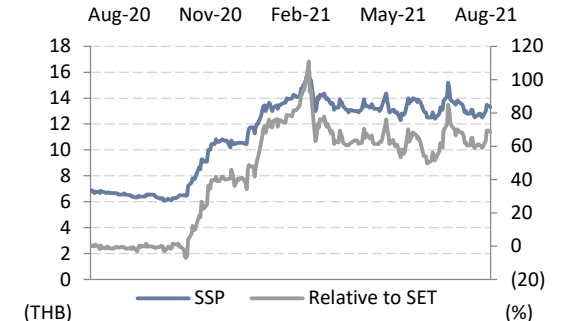
เราคาดว่า SSP จะใช้ประโยชน์จากความก้าวหน้าของการดำเนินงานในญี่ปุ่นและเวียดนามเพื่อขยายกำลังการผลิตในปี 2021-25 โครงการเพื่อการเติบโตที่เราคาดว่า SSP จะหามาในปี 2021 ประกอบด้วยการซื้อโรงไฟฟ้าชีวมวลขนาด 9MW ในประเทศไทยที่ประกาศไปแล้วและโรงไฟฟ้าพลังลมและแสงอาทิตย์ที่ดำเนินงานแล้วในปัจจุบันในเวียดนามและประเทศอื่น ๆ ซึ่งรวมถึงโรงไฟฟ้าพลังลมนอกชายฝั่ง (ระยะ 3) ที่คาดว่าจะมีขนาด 100MW ในเวียดนาม

### หุ้นโรงไฟฟ้าขนาดเล็กที่น่าสนใจที่สุดในไทย

เราแนะนำซื้อที่ราคาเป้าหมาย 20 บาท (SoTP) ราคาดังกล่าวรวมผลกระทบต่อกำไรจากหุ้นปันผลและ SSP-W1 เราคิดว่าแผนการเติบโตที่ SSP ผูกพันแล้วเพื่อเพิ่มกำลังการผลิตจาก 118MW เป็น 400MW ภายในปี 2025 มีโอกาสสำเร็จสูง ซึ่งอาจทำให้ NP เพิ่มขึ้นกว่า 2 พัน ลบ. ในปี 2025

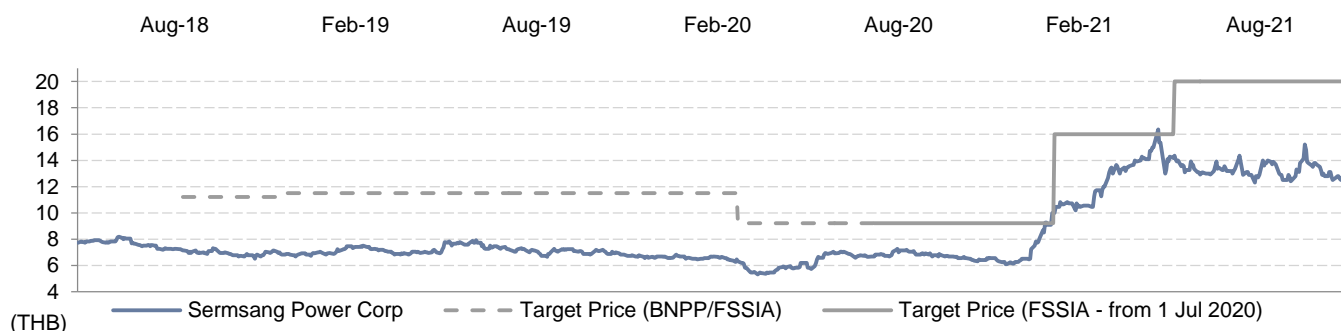
