## จุดที่เลวร้ายที่สุดน่าจะผ่านไปแล้ว

## กำไร 3Q21 น่าจะเป็นจุดต่ำสุด

ใน 3Q21 เราคาดว่ารายได้ของ BEM จะลดลง 10% q-q เป็น 2.2พัน ลบ. เนื่องจาก 1) รายได้ จากธุรกิจทางด่วนอาจลดลง 9% q-q จากปริมาณจราจรที่ลดลง 13% q-q ซึ่งเป็นอัตราการลดที่ ต่ำลงเมื่อเทียบกับ 2Q21 เนื่องจากมีวันหยุดที่บริษัทฯ ยกเว้นค่าผ่านทางน้อยกว่าใน 3Q21; และ 2) รายได้จากธุรกิจรถไฟฟ้าน่าจะลดลง 12% q-q เนื่องจากตัวเลขผู้โดยสารลดลงในช่วง ปิดเมืองถึง 72% q-q ในด้านต้นทุนเราคาดว่าค่าใช้จ่ายของ BEM จะลดลงต่อเนื่องจากไตรมาส ก่อนหน้า บริษัทฯ ได้เลื่อนต้นทุนบำรุงรักษาทางด่วนและลดค่าใช้จ่ายการขายและการบริหาร มากยิ่งขึ้นในช่วงปิดเมือง ท้ายที่สุด BEM จะได้รับรายได้เงินปันผลจาก TTW (TTW TB, NR) จำนวน 263 ลบ. ซึ่งอาจช่วยให้บริษัทฯ บันทึกกำไรได้เล็กน้อยที่ 24 ลบ. (-97% y-y, -88% q-q)

## สัญญาณฟื้นตัวที่ดีในเดือน ก.ย. 2021

BEM ประกาศตัวเลขปริมาณจราจรและผู้โดยสารต่อวันในเดือน ก.ย. 21 ที่ 0.78ล้าน (+32% m-m) และ 0.1ล้าน (+60% m-m) ตามลำดับ ซึ่งแสดงให้เห็นถึงการฟื้นตัวที่ดีจากเดือน ส.ค. 21 จากการผ่อนคลายมาตรการปิดเมืองของรัฐฯ หลังตัวเลขผู้ติดเชื้อ Covid อยู่ในระดับที่ ควบคุมได้มากยิ่งขึ้นและการระดมฉีดวัคซีน เราเชื่อว่ากระแสการฟื้นตัวน่าจะเกิดต่อเนื่องใน เดือนต่อมา BEM คาดว่าในช่วงวันทำงานในเดือน ต.ค. 21 ปริมาณจราจรและผู้โดยสารต่อวัน น่าจะอยู่ที่ 0.96ล้านและ 0.14ล้านตามลำดับ

## เสียระยะสั้นแต่ได้ระยะยาว


เราปรับลดประมาณการรายได้ของ BEM ในปี 2021 และ 2022 เพื่อสะท้อนผลกระทบของ Covid-19 ปัจจุบันเราคาดว่ารายได้ของ BEM จะลดลง 47% และ 20% ในปี 2021 และ 2022 ตามลำดับ อย่างไรก็ดีเราปรับเพิ่มประมาณการกำไรตั้งแต่ปี 2023 ขึ้นเล็กน้อย เนื่องจากเรา เชื่อว่าบริษัทฯ น่าจะสามารถรักษาต้นทุนได้อย่างมีประสิทธิภาพมากขึ้นหลัง Covid บังคับให้ บริษัทฯ ลดต้นทุน เราคิดว่าแนวโน้มของ BEM จะยังดีในระยะยาวหลังทุกอย่างกลับเป็นปกติ

#### คงแนะนำซื้อที่ราคาเป้าหมายปี 2022 ที่ 9.90 บาท

เราเชื่อว่าผลประกอบการในด้านกำไรที่แย่ที่สุดของ BEM ได้ผ่านพันไปแล้ว สอดคล้องกับ สถานการณ์ Covid ที่ดีขึ้นในประเทศไทย เราเห็นว่าปริมาณจราจรและผู้โดยสารและกำไรของ บริษัทฯ น่าจะปรับตัวดีขึ้นในทุกไตรมาสนับจากนี้ นอกจากนี้รัฐบาลน่าจะสรุปโครงการรถไฟฟ้า ในอนาคตได้ในเร็ววันนี้ ซึ่งอาจเป็นอีกปัจจัยบวกสำหรับบริษัทฯ เราคงแนะนำซื้อหลังปรับราคา เป้าหมายเป็น 9.90 บาท (SOTP)

#### Investment thesis

BEM is the only public company that has been granted concessions to construct and operate expressways, which presently total 87.56km. The company has also secured two mass transit lines (Blue and Purple), and is ranked as the second largest mass transit operator in Thailand.

The company has solid historical growth, and we expect that momentum to continue thanks to Bangkok's continued expansion and its citizens' demand for public transportation.

We expect the company to have a solid recovery on both expressway traffic and the ridership on its Blue mass transit line, following more visible signs of recovery, in line with the improving Covid-19 situation.









**Exhibit 2: Expressway traffic** 




**Exhibit 3: Mass transit ridership** 




