## WEH ยังเป็นปัจจัยผลักดันสำคัญ

### กำไรสุทธิ 3Q21 ดีขึ้นจากรุก EPC และโรงไฟฟ้าพลังลม

DEMCO รายงานกำไรสุทธิ (NP) 3Q21 จำนวน 23.3 ลบ. เพิ่มขึ้นจากที่เคยขาดทุนสุทธิ 34 ลบ. ใน 2Q21 และที่เคยมี NP 2.6 ลบ. ใน 3Q20 จากส่วนแบ่งกำไร 21.6 ลบ. ของหุ้น 4% ใน Wind Energy Holding (WEH, not listed) กำไรขั้นต้นลดลงเหลือ 17 ลบ. (-73% q-q, -80% y-y) จากที่เคยมีกำไรขั้นต้น 61 ลบ. ใน 2Q21 และ 85 ลบ. ใน 3Q20 ประกอบด้วย 1) กำไรขั้นต้น 17 ลบ. จากการบริการ (-70% q-q และ -70% y-y) หลังการแข่งขันรุนแรงขึ้น ซึ่งทำให้อัตรากำไรขั้นต้นลดลง; และ 2) ผลขาดทุนขั้นต้น 3 ลบ. จากการขาย เนื่องจากราคาเหล็กปรับตัวสูงขึ้น

### รายได้ 3Q21 โตตามมูลค่างานในมือ

ใน 3Q21 รายได้เพิ่มจาก 672 ลบ. ใน 2Q21 และ 691 ลบ. ใน 3Q20 เป็น 770 ลบ. ใน 3Q21 (+15% q-q, +11% y-y) โดยได้ปัจจัยหนุนจากรายได้ค่าบริการที่สูงขึ้น (+23% y-y) มูลค่างานในมือที่แน่นอนแล้วในปัจจุบันของงานออกแบบจัดหาพร้อมติดตั้ง (EPC) ที่บริษัทฯ กำลังก่อสร้างอยู่ที่ 4 พัน ลบ. ประกอบด้วย 1) 1.9 พัน ลบ. จากโครงการระบบวิศวกรรมโรงงานไฟฟ้า; 2) 2.1 พัน ลบ. จากโครงการโทรคมนาคมและอเนกประสงค์; และ 3) โครงการโรงไฟฟ้าหมุนเวียน

### มูลค่างาน EPC ในมือที่ 4 พัน ลบ. และ NP ที่สูงขึ้นตามฤดูกาลของ WEH เป็นปัจจัยสำคัญ

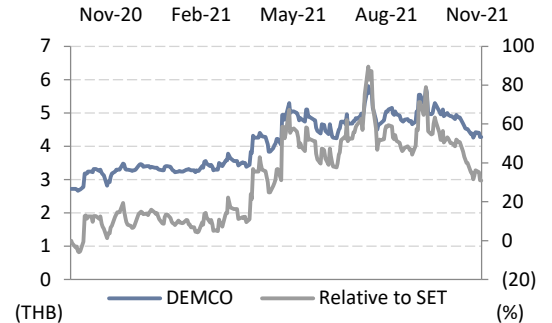
เราคาดแนวโน้ม NP ที่ดีขึ้นใน 4Q21-2022 จากมูลค่างานในมือ 4 พัน ลบ. ของธุรกิจ EPC ณ สิ้น 3Q21 และรายได้เงินปันผลที่ปรับตัวขึ้นจากหุ้น 4% ใน WEH ซึ่งจะช่วยเสริมสร้างความยั่งยืนของ NP ของบริษัทฯ เมื่อไม่นานมานี้ DEMCO ได้ชนะงาน EPC มูลค่า 1.13 พัน ลบ. เพื่อก่อสร้างระบบจำหน่ายไฟฟ้าสำหรับทางด่วนที่เชื่อมระหว่างเมือง 2 สาย กล่าวคือ บางใหญ่ - กาญจนบุรี (M81) และบางปะอิน - นครราชสีมา (M16) ซึ่งมีกำหนดสร้างเสร็จภายใน 3 ปี นอกจากนี้ตัวเลขโครงการประมูลยังมีแนวโน้มเพิ่มสูงขึ้น ซึ่งประกอบด้วยสถานีย่อยทั้งในภาครัฐและเอกชน สายส่งไฟฟ้า และโครงการโรงไฟฟ้าชีวมวลและก๊าซชีวภาพหลังการกลับมาเปิดเศรษฐกิจน่าจะช่วยเสริมแนวโน้ม NP ของบริษัทฯ ให้ดียิ่งขึ้น

### มูลค่าของ WEH เป็นแกนกลางที่สำคัญพร้อมมูลค่าเพิ่มจากรุก EPC

เราแนะนำซื้อที่ราคาเป้าหมาย 5.9 บาท (SOTP) เราคิดว่า DEMCO เป็นหุ้นโรงไฟฟ้าขนาดเล็กที่น่าสนใจ ไม่เพียงในแง่ของมูลค่าภายในพร้อมแนวโน้ม NP ที่กำลังปรับตัวขึ้นของธุรกิจ EPC แต่ยังรวมถึงมูลค่าที่ซ่อนอยู่ในหุ้น 4% ของ WEH เราเชื่อว่า DEMCO น่าจะประมูลชนะงาน EPC เพิ่มต่อเนื่องในไตรมาสข้างหน้าจากความต้องการงาน EPC สำหรับสายส่งไฟฟ้าและสถานีย่อยในประเทศไทยที่อันอยู่เป็นจำนวนมาก

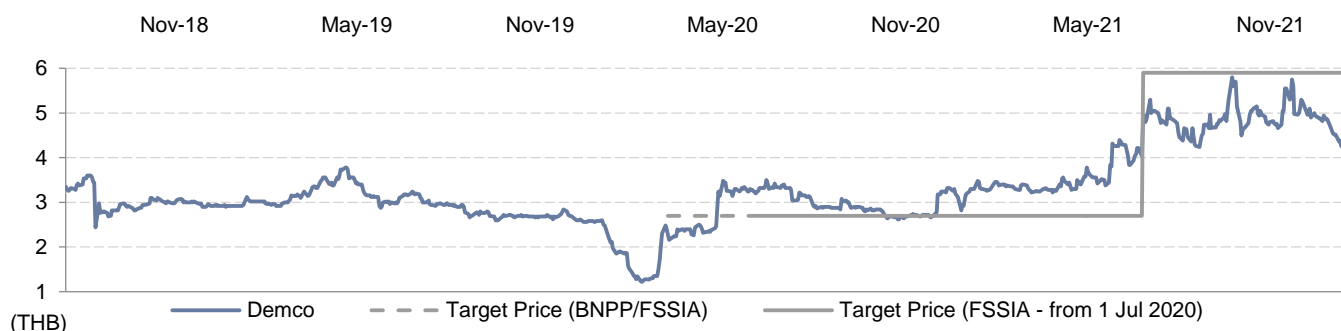
