Potential to sell KASSET

- KBANK might sell KASSET for THB67b. This would imply a valuation of 21x P/E, 39x P/BV, and 24x AUM/selling price.
- Based on our estimate, this would net an extra gain of cTHB52b.
- This news should provide positive sentiment to KBANK. We maintain BUY with our TP of THB180.

Potential to sell asset management business, KASSET

According to Bloomberg News on 1 April 2022, KBANK is considering selling its asset management subsidiary, KASSET. The required valuation of KASSET would be USD2b (THB67b). This would positively affect KBANK's share price, in our view.

Selling some portion of KASSET could be the best option

KBANK has not commented on this yet. However, during its latest analyst meeting, KBANK said it is considering unlocking its shareholder value. Thus, we think the bank might consider selling some portion or all of KASSET, depending on the valuation and business opportunity. To us, if KBANK sells some portion to a fund management expert(s), this could be the best option as the buyer(s) could support KBANK to expand its business opportunities, possibly to expand its business abroad, amid the tighter competition in the asset management business in Thailand. The bank could also continue to enjoy a potential rise in KASSET's net profit, while getting lump sum money to expand into other businesses in the future. On top of that, this could unlock value for KBANK's shareholders. If KBANK sells KASSET for THB67b, based on our estimate, it would net an extra gain after tax of cTHB52b, implying THB21/share. However, we do not expect the bank to book all of this extra gain to its net profit. We believe it would use it to set aside a special provision.

Might command a higher valuation than the TMBAM deal

The latest asset management deal in Thailand was the sale of a 65% stake in TMBAM to Prudential's Eastspring by TMB in Sep-18. The bank did not disclose the selling price. Based on our estimate, the selling price of TMBAM was valued at 23x P/E, 13x P/BV, and 30x AUM/selling price. If KBANK sells 100% of KASSET for THB67b, it would imply a valuation of 21x P/E, 39x P/BV, and 24x AUM/selling price. We are convinced that KBANK would seek a higher valuation than the value of the TMBAM sale as KASSET is ranked in the top three for market share in terms of AUM.

Maintain BUY with 2022 GGM-based TP of THB180

We maintain our GGM-based TP of THB180. We believe its net profit and ROE will increase continuously. We also think that it is in full swing to transform itself to unlock its value and increase shareholders' returns.

Investment thesis

We maintain our BUY call, as we believe that the extension of the relaxed loan classification and provision setup rules will allow the bank to have more time to deal with its trouble debts.

Moreover, once the Covid-19 dust has settled, we expect KBANK to post sustainable long-term growth, as it has laid a strong foundation for such. First, KBANK has been heavily investing in digital platforms for more than a decade – we believe it will utilise its digital platform to generate more revenue while reducing operating and funding costs. Second, KBANK is one of the first movers to have expanded into the Asean Economic Community +3. Therefore, its digital investment and international expansion should be a game changer, helping it to become a regional digital bank.

Company profile

Established on 8 June 1945, Kasikornbank was listed on the Stock Exchange of Thailand in 1976. At the end of 2021, KBANK operated 839 branches, down from 860 in 2021 and 10,991 ATMs, up from 10,911 in 2020. In addition, the bank has an international network that includes 16 establishments in eight countries.

Catalysts

Potential share price catalysts for KBANK include:

- Lower credit cost from fewer new NPLs;
- Faster expansion in the digital lending space than expected;
- The return of foreign fund flows into the Thai stock market.

Risks to our call

Downside risks to our GGM-based TP are 1) prolonged economic sluggishness and further waves of the Covid-19 pandemic affecting loan growth and asset quality; and 2) the impact of further interest rate cuts on NIM and potential new regulations from the Bank of Thailand on debt-servicing programs.



Potential to sell asset management business, KASSET

According to Bloomberg, KBANK, Thailand's second-biggest lender, is considering options for its asset management business, including a sale amid interest from other industry players, according to people familiar with the matter. KBANK, as the Bangkokbased lender is known, is working with a financial adviser on a strategic review of Kasikorn Asset Management (KASSET), the people said, asking not to be identified because the matter is private. The bank is seeking a valuation of as much as \$2 billion in a potential transaction, the people said. As reported, options include selling a majority or a minority stake of the business. KBANK is seeking a strategic partner to bolster its asset management platform and make it more competitive, they said. KASSET manages about \$47.2 billion, according to the bank's 2021 annual report. Considerations are preliminary. No final decision has been made and the Thai lender could still decide to retain the unit for longer, the people said. A representative for Kasikornbank declined to comment. A transaction would mirror previous ones from other top lenders in Southeast Asia's second-biggest economy. In 2018, TMB Bank Pcl sold a majority stake in its asset management business to Prudential Plc's Eastspring Investments. A year later, Eastspring acquired a controlling stake in Thanachart Bank Pcl's asset manager following the \$5.1 billion merger of TMB and Thanachart.




Selling some portion of KASSET could be the best option

KBANK has not commented on this yet. However, during the latest analyst meeting with the CEO, KBANK said it is considering unlocking its shareholder value, but did not mention the specific method. Therefore, we think the bank might consider selling some portion or all of KASSET, depending on the valuation and business opportunity. KBANK currently holds 100% of KASSET.

If KBANK sells KASSET for THB67b, based on our estimate, it would have an extra gain after tax of around THB52b, implying THB21/share. However, we do not expect the bank to book all of this extra gain to its net profit. We believe it would utilize it to set aside a special provision like Siam Commercial Bank (SCB TB, BUY) did when it had a special gain from the sale of SCBLife, and TMBThanachart (TTB TB, BUY) did when it sold TMBAM.

*Percentages in parentheses are the current percentage holding by KBANK Source: KBANK; FSSIA's compilation



KASSET's background

KASSET's net profits during 2018-2020 were relatively stable at cTHB2.8b yearly, which normally contributed c8% of KBANK's total net profit. KASSET's 1H21 net profit was THB1.57b, annualised at THB3.14b. Its 1H21 book value was THB1.7b. Its assets under management (AUM) as of 2021 amounted to THB1.58b. KASSET always ranks among the top three for market share in terms of AUM.

Might command a higher valuation than the TMBAM deal

The latest asset management deal in Thailand was the sale of a 65% stake in TMB Asset Management (TMBAM) to Prudential's Eastspring by TMB in Sep-18. The bank did not disclose the selling price, but it booked a gain of THB7.6b. Based on our estimate, the selling price for 65% should be THB8b (TMBAM's book value as of 2018 = THB1b), implying that the total value of TMBAM was THB12.7b.

As of 2018, TMBAM recorded a net profit/ book value/ AUM of THB0.56/ THB1.0b/ THB380b. Thus, the selling price would be valued at 23x P/E, 13x P/BV, and 30x AUM/selling price. If KBANK sells 100% of KASSET for THB67b, it would imply a valuation of 21x P/E, 39x P/BV, and 24x AUM/selling price. We are convinced that KBANK would seek a higher valuation than the value of the TMBAM sale as KASSET is always ranked among the top three for market share in terms of AUM. It is also a more well-known brand among Thai clients.
