ต้นทุนวัตถุดิบที่ปรับขึ้นกระทบผลประกอบการ 2Q22

- APURE รายงานกำไรสุทธิ 2Q22 ในเกณฑ์ดีโดยอยู่ที่ 81 ลบ. สูงกว่าที่ตลาดคาด 5% และที่เรคาด 4%
- แม้ว่าต้นทุนวัตถุดิบจะปรับขึ้น อัตรากำไรสุทธิยังสูงกว่า 10% เราคาดว่าราคาหุ้นจะฟื้นตัวดีในช่วง 2H22
- คงแนะนำซื้อที่ราคาเป้าหมาย 10 บาท

ผลประกอบการ 2Q22 อยู่ในเกณฑ์ดีแม้ว่าต้นทุนจะปรับขึ้น

APURE รายงานกำไรสุทธิ 2Q22 อยู่ในเกณฑ์ดีโดยอยู่ที่ 81 ลบ. (+77% q-q, -6% y-y) กำไรปกติอยู่ที่ 82 ลบ. (+106% q-q, -22% y-y) สูงกว่าที่ตลาดคาด 5% และที่เรคาด 4% รายได้โตเป็น 632 ลบ. เพิ่มขึ้น 65% q-q แต่ลดลง 3% y-y จากการขาดแคลนข้าวโพดหวาน ซึ่งเป็นวัตถุดิบสำคัญที่เก็บเกี่ยวได้ในช่วงปลายไตรมาสจากสภาวะอากาศที่ไม่เอื้ออำนวย ซึ่งทำให้อัตรากำไรใช้กำลังการผลิตของโรงงานต่ำกว่าคาด

ต้นทุนวัตถุดิบที่ปรับขึ้นเป็นตัวการสำคัญ

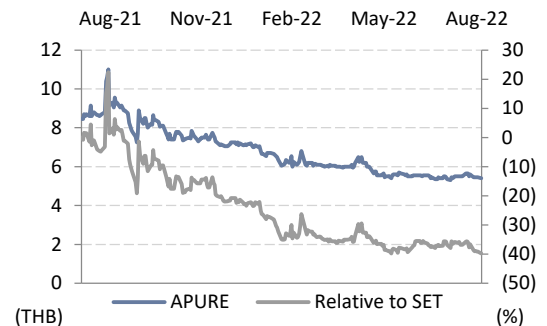
ใน 2Q22 ต้นทุนขายปรับขึ้นเป็น 470 ลบ. (+61% q-q, +4% y-y) เทียบกับรายได้ที่เพิ่มขึ้น 65% q-q และลดลง 3% ต้นทุนที่ปรับขึ้นส่วนมากเกิดจากราคาวัตถุดิบข้าวโพดหวานที่ปรับขึ้นจากอุปทานที่ขาดแคลน อัตรากำไรขั้นต้นลดลงเหลือ 25.6% จาก 30.7% ใน 2Q21 แต่เพิ่มขึ้นจาก 24.1% ใน 1Q22 จากต้นทุนวัตถุดิบที่ปรับขึ้น สัดส่วนค่าใช้จ่ายการขายและบริหารต่อยอดขายลดลงเหลือ 13.2% จาก 14.2% ใน 1Q22 แต่เพิ่มจาก 10.7% ใน 2Q21 จากต้นทุนโลจิสติกส์ บรรจุก๊าซและแรงงานที่ปรับขึ้น

อัตรากำไรสุทธิทรงตัวเหนือ 10% ใน 2Q22

ใน 2Q22 อัตรากำไรสุทธิจากการดำเนินงานอยู่ที่ 13% เพิ่มขึ้นเล็กน้อยจาก 10.4% ใน 1Q22 แต่ลดลงอย่างรุนแรงจาก 16.2% ใน 2Q21 จากผลกระทบของต้นทุนวัตถุดิบที่ปรับขึ้น ค่าขนส่งที่สูงขึ้น และปริมาณขายที่ลดลงจากการขาดแคลนข้าวโพดหวาน อย่างไรก็ตาม APURE ได้คงอัตรากำไรสุทธิไว้ที่ประมาณ 10% โดยเฉลี่ยอย่างต่อเนื่องมาตั้งแต่ 3Q21 หลังต้นทุนวัตถุดิบที่เพิ่มขึ้นเริ่มกระทบอัตรากำไรสุทธิของบริษัทฯ

คาดการณ์ราคาหุ้นจะฟื้นตัวดีในช่วง 2H22

เราแนะนำซื้อที่ราคาเป้าหมาย 10 บาท เราเชื่อว่าราคาหุ้นของ APURE ได้ตกต่ำสุดไปแล้ว และได้สะท้อนผลกระทบจากการขาดแคลนวัตถุดิบส่วนมากอยู่ในค่า 2022E P/E ที่ 10.8x เราคิดว่าราคาหุ้นของ APURE น่าจะฟื้นตัวดีตั้งแต่ 2H22 เป็นต้นไปจากกำไรไตรมาสที่สูงขึ้นตามอัตรากำไรสุทธิที่ดีขึ้นจากความพร้อมของวัตถุดิบที่สูงขึ้นและราคาข้าวโพดหวานที่ลดลงจากรายงานของ US Department of Agriculture อุปทานข้าวโพดหวานในประเทศไทยน่าจะเพิ่ม y-y ในปี 2023 นอกจากนี้ APURE ยังประกาศเงินปันผลระหว่างกาลที่ 0.05 บาทสำหรับการดำเนินงานในช่วง 1H22 โดยหุ้นจะขึ้น XD ในวันที่ 26 ส.ค. 22

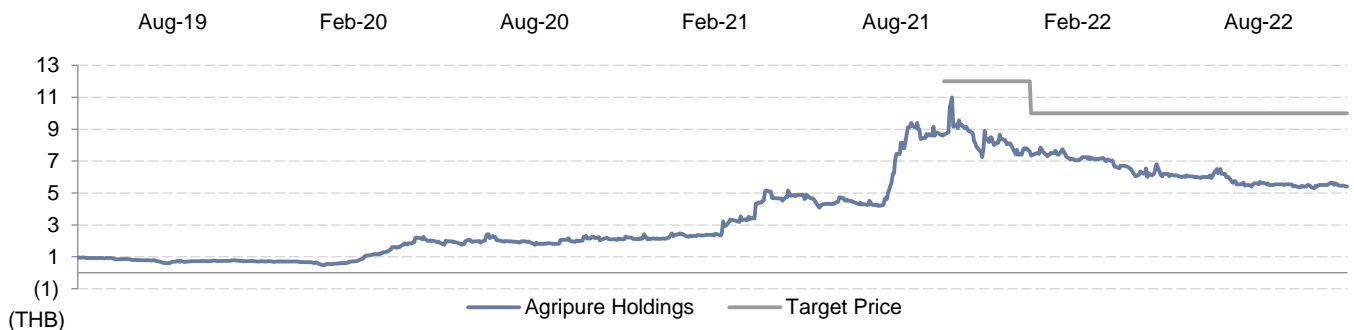
