2Q25 results at first glance

กำไร 2Q25 ทำสถิติสูงสุดใหม่ตามคาด

Highlights

- OSP รายงานกำไรสุทธิ 2Q25 อยู่ที่ 1 พัน ลบ. (-20% q-q, +67% y-y) เมื่อหักรายการพิเศษในไตรมาสก่อนและปีก่อน กำไรปกติเติบโต 4% q-q และ 9.4% y-y ทำสถิติสูงสุดใหม่
- รายได้รวมลดลง 0.4% q-q และ 7.3% y-y ลดลง q-q จากรายได้ที่ลดลงตามฤดูกาลในพม่าและผลกระทบจากเหตุแผ่นดินไหว รายได้ลดลง y-y ส่วนมากจากการปรับระดับสินค้าคงคลังสำหรับเครื่องดื่มชูกำลังในประเทศเป็นหลัก
- อัตรากำไรขั้นต้นทำสถิติสูงสุดใหม่ที่ 41.9% สูงขึ้นจาก 40% ใน 1Q25 และ 38.2% ใน 2Q24 โดยมีปัจจัยหนุนจากต้นทุนวัตถุดิบและพลังงานที่ลดลง กอปรกับ product mix จากการเติบโตของพม่าและ Personal Care (y-y)
- บริษัทฯ ควบคุมค่าใช้จ่ายรวมได้ดี แม้ว่าจะเปิดตัวสินค้าใหม่ และมี Presenters ใหม่ แต่สัดส่วนค่าใช้จ่ายการขายและบริหารต่อยอดขายยังอยู่ที่ 24.4% ก่อนช่วงทรงตัว q-q และ y-y

Outlook

- กำไรปกติ 1H25 อยู่ที่ 1.98 พัน ลบ. คิดเป็น 56% ของประมาณการทั้งปีของเรา เราคาดว่ากำไร 2H25 จะลดลง h-h จาก Low Season ของตลาดต่างประเทศแต่น่าจะยังได้ดี y-y เนื่องจากปรับระดับสินค้าคงคลังสำหรับเครื่องดื่มชูกำลังแล้วเสร็จและรายได้น่าจะกลับมาโต y-y
- เราคงประมาณการกำไรสุทธิ 2025 ของเราที่ 3.55 พัน ลบ. (+17% y-y) และคงราคาเป้าหมายของเราที่ 24 บาท
- บริษัทฯ ประกาศจ่ายเงินปันผลต่อหุ้นสำหรับผลประกอบการ 1H25 อยู่ที่ 0.40 บาทคิดเป็นผลตอบแทน 2.2%

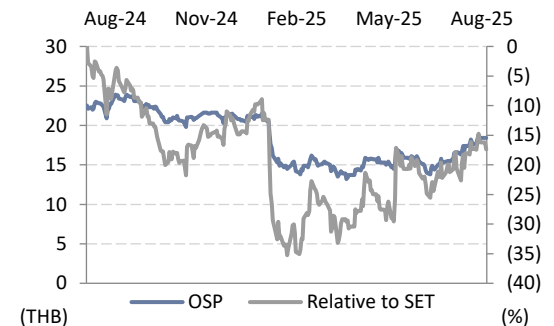

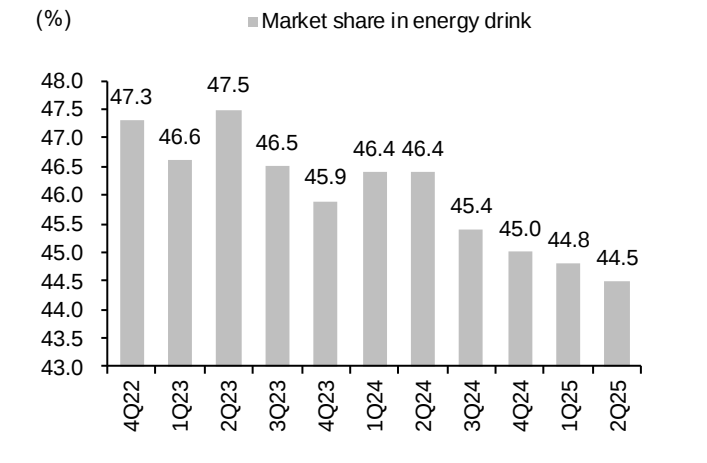

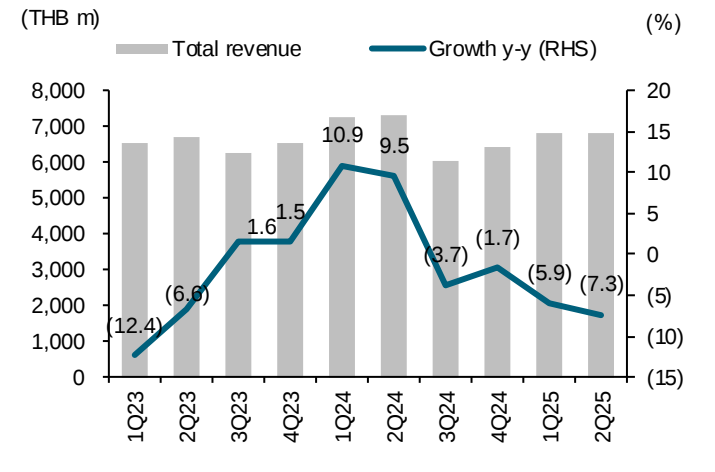

Exhibit 2: OSP's energy drink market share

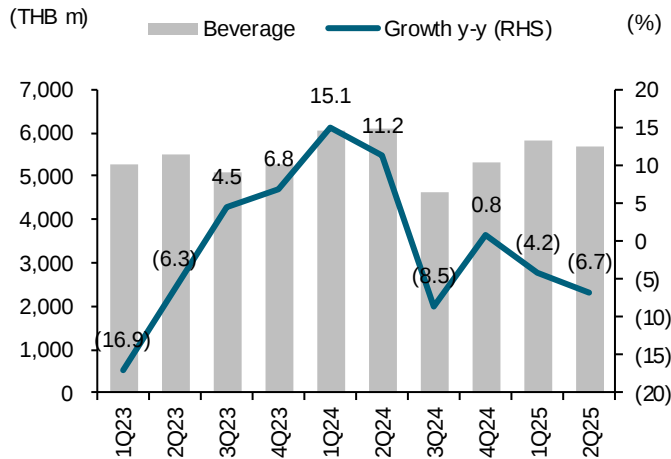

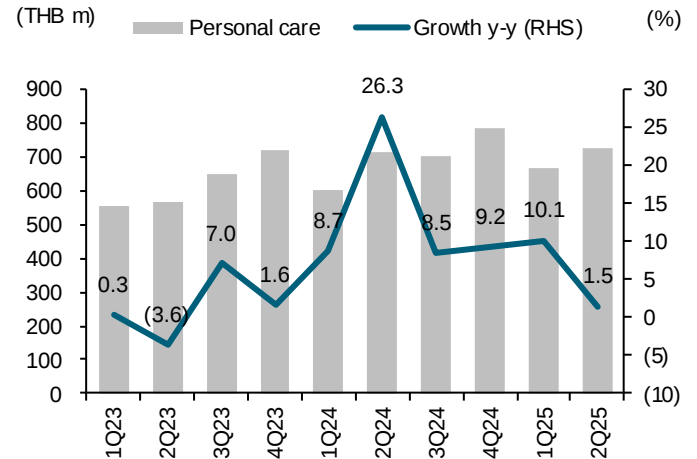
Exhibit 3: Total revenue and growth



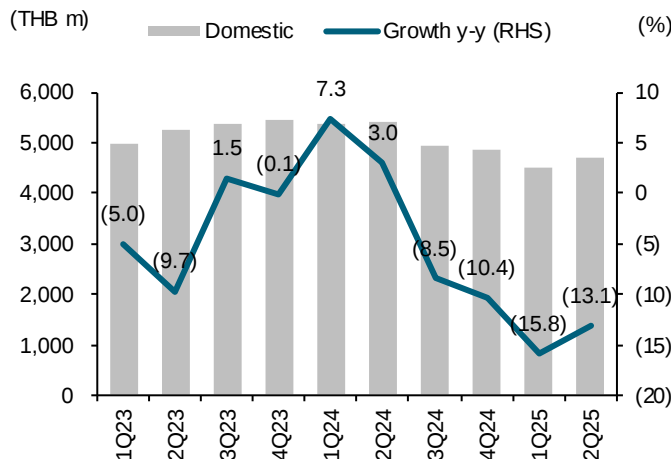

Exhibit 4: Beverage revenue and growth

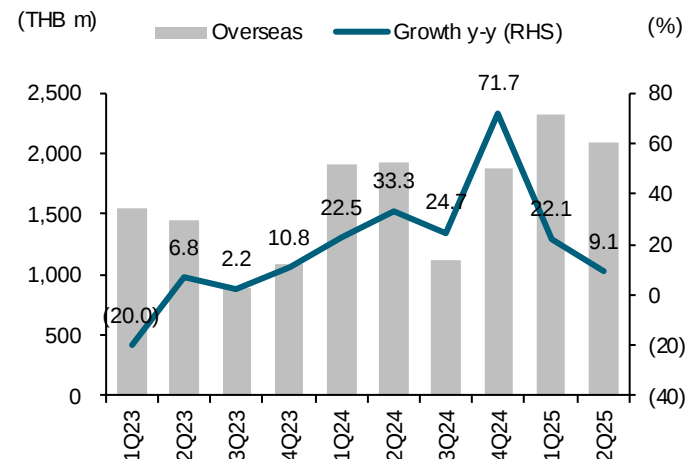

Exhibit 5: Personal care revenue and growth

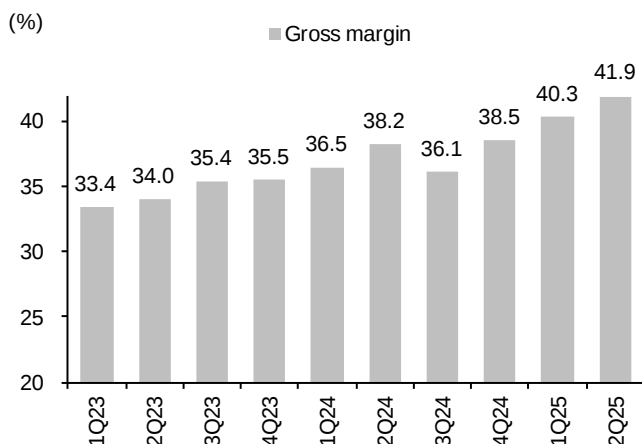

Exhibit 6: Domestic revenue and growth

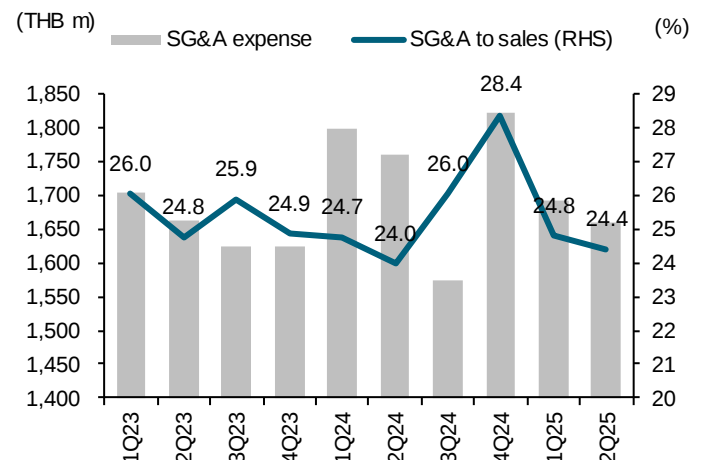

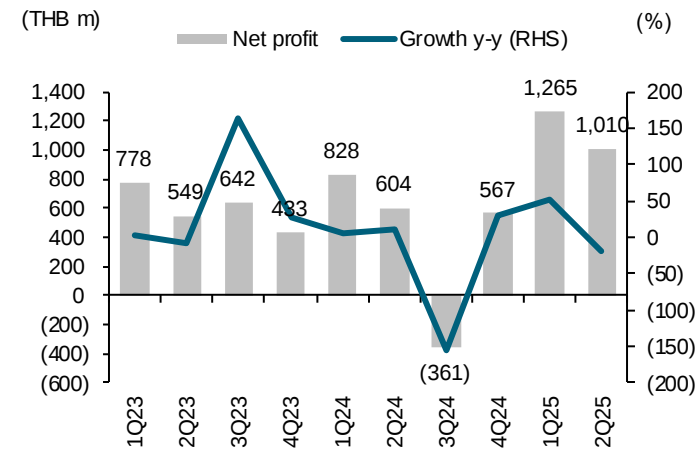
Exhibit 8: Gross margin

Exhibit 9: SG&A to sales

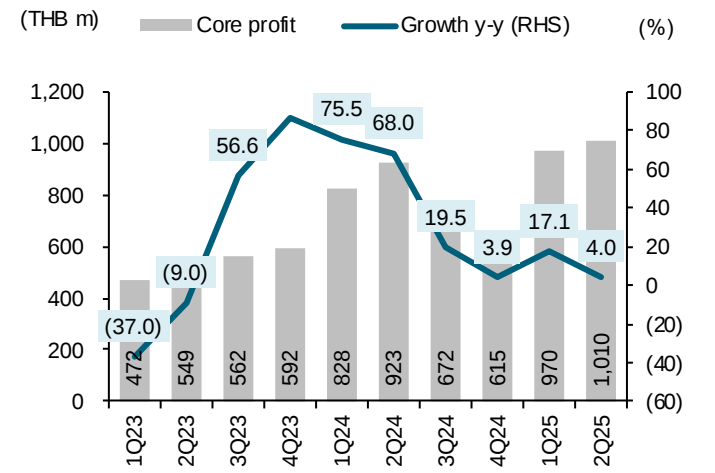
