## 2Q25 results at first glance

กำไร 2Q25 ตามคาด

### Highlights

- กำไรสุทธิ 2Q25 เท่ากับ 32 ลบ. (-1.3% q-q, +149% y-y) เท่ากับคาด สาเหตุที่กำไรลดลง q-q มาจากค่าใช้จ่ายที่สูงขึ้น ทั้งการเปิดสาขาใหม่ และค่าใช้จ่ายจัดเลี้ยงพนักงานประจำปี (ปีก่อนอยู่ใน 3Q24) ทำให้ SG&A to sales ขยับขึ้นเป็น 38.1% จาก 36.2% ใน 1Q25 และ 33.5% ใน 2Q24
- รายได้รวมทำนิวไฮต่ออยู่ที่ 447 ลบ. (+7.8% q-q, +39.4% y-y) แม้ SSSG ติดลบมากขึ้นเป็น -9.8% y-y จาก -5.3% y-y ใน 1Q25 แต่ถูกหักล้างได้ทั้งหมดด้วยสาขาใหม่ โดยมีการเปิดสาขาใหม่เพิ่ม 5 สาขา q-q และ 17 สาขา y-y ทำให้สิ้น 2Q25 มีทั้งหมด 45 สาขา
- สัดส่วนรายได้หลักยังมาจากแบรนด์ MAGURO 49% (ลดลงจาก 56% ใน 2Q24) เนื่องจากเปิดแบรนด์ใหม่เพิ่ม โดย Tonkatsu Aoki มี 5 สาขา สร้างรายได้ 50.7 ลบ. (สัดส่วน 11%) ส่วน CouCou มีรายได้ 12 ลบ. จาก 2 สาขา (สัดส่วน 2.7%)
- อัตรากำไรขั้นต้นขึ้นต่อทำนิวไฮที่ 48.7% จาก 48% ใน 1Q25 และ 42.6% ใน 2Q24 เพราะต้นทุนวัตถุดิบลดลง และแบรนด์ใหม่มีอัตรากำไรที่ดี

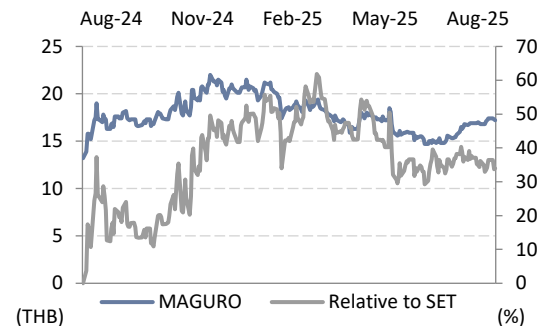
### Outlook

- กำไรสุทธิ 1H25 เท่ากับ 65 ลบ. (+96% y-y) คิดเป็น 49% ของประมาณการทั้งปี แนวโน้มกำไร 3Q25 น่าจะโตทั้ง q-q และ y-y ได้ เพราะไม่มีค่าใช้จ่ายจัดเลี้ยงพนักงานอีก ขณะที่ยังเปิดสาขาเพิ่มขึ้น และมีแบรนด์ใหม่ 2 แบรนด์คือ BINCHO และ KIWAMIYA
- จ่ายปันผลงวด 1H25 หุ้นละ 0.25 บาท Yield 1.5%

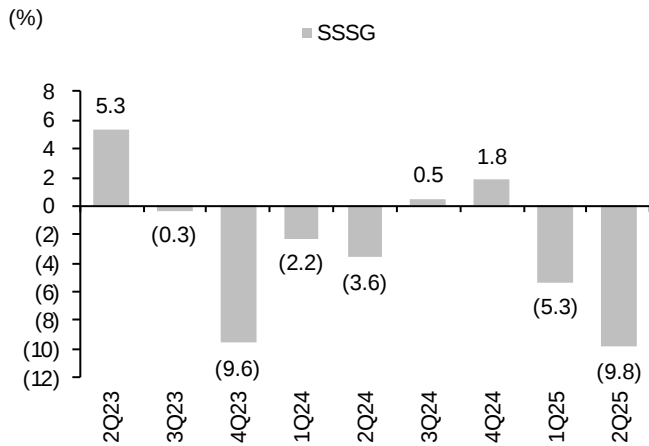

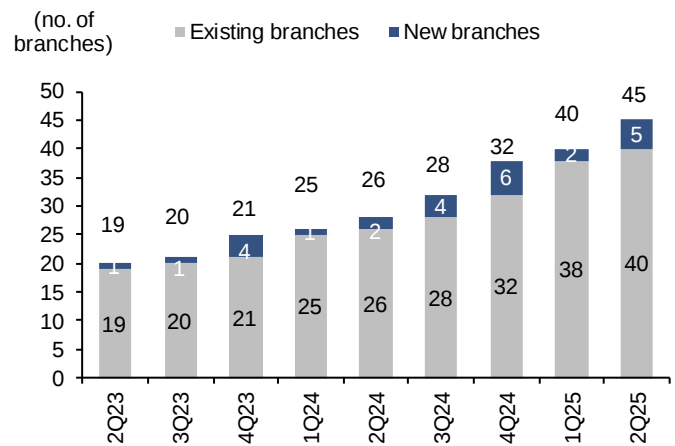

**Exhibit 2: Same-store-sales growth**



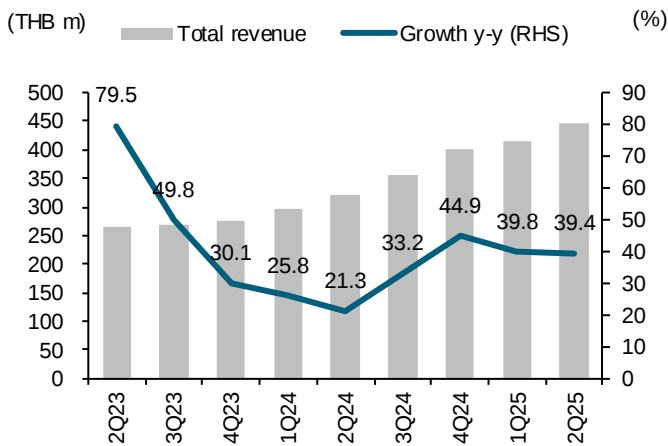

**Exhibit 3: Total branches**



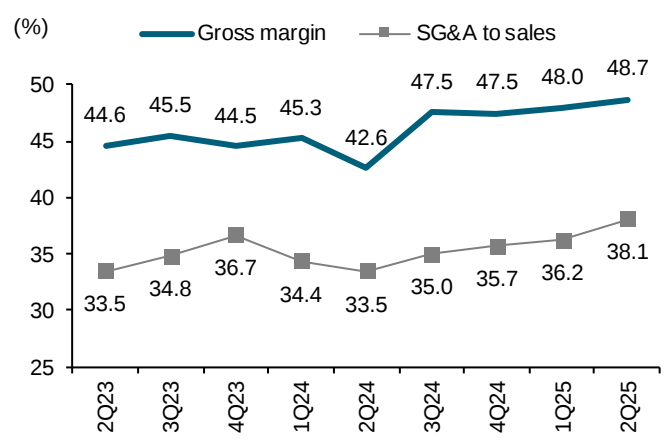

**Exhibit 4: Total revenue and growth**



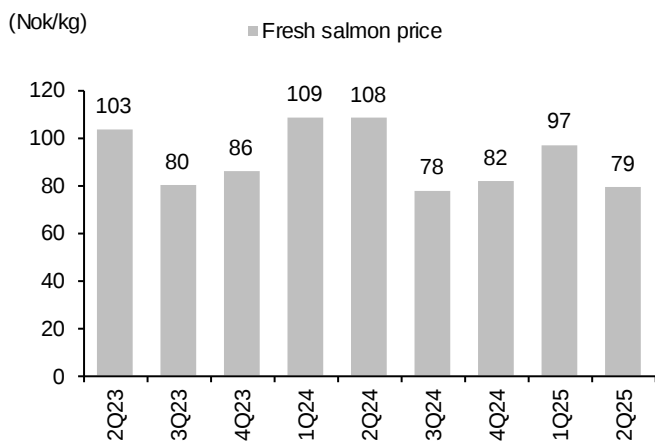

**Exhibit 5: Gross margin and SG&A to sales**



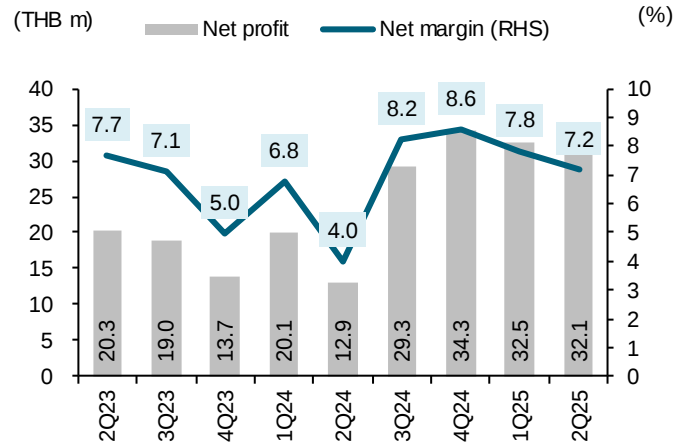

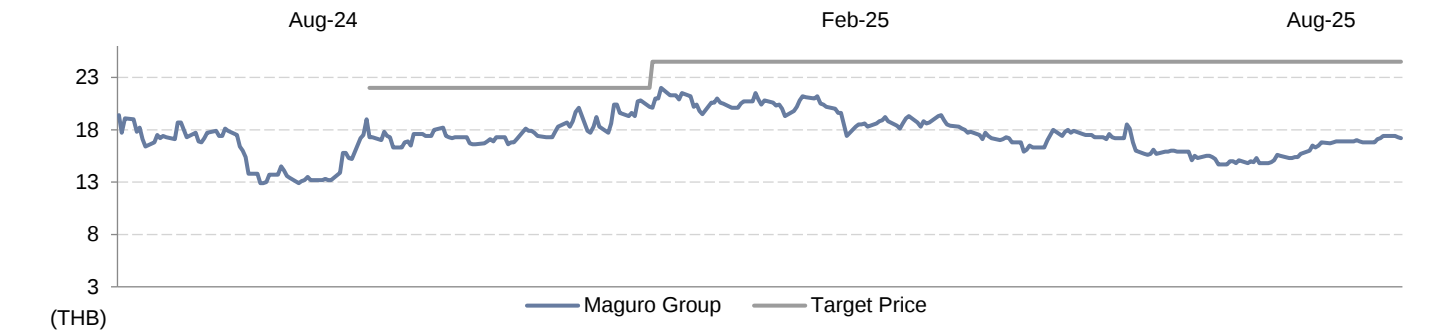
