## Key takeaways from analyst meeting

### Highlights

- เรามีมุมมองเป็นกลางต่อการประชุมนักวิเคราะห์ SEAFCO ใน 2Q25 ผู้บริหารปรับลดเป้าหมายได้ปี 2025 อยู่ที่ 1,500 ล้านบาท (+18% y-y) จากเดิม 2 พันลบ. อย่างไรก็ตาม เป้ารายได้ดังกล่าวยังสอดคล้องกับสมมติฐานของเรา
- Backlog ปัจจุบันยังแข็งแกร่งอยู่ที่ 2,660 ล้านบาท เพิ่มขึ้นจาก 2,400 ล้านบาท ณ สิ้น 2Q25 จากการรับงานเอกชนเพิ่ม 2 โครงการ โดยสัดส่วนหลักเป็นงานภาครัฐคิดเป็น 69% ของ backlog ทั้งหมด หากพิจารณาตามประเภทของงาน สัดส่วน 80% เป็นงานรับเฉพาะค่าแรง ส่วนใหญ่เป็นโครงการรถไฟฟ้าสายสีส้ม จำนวน 6 สถานี ซึ่งมีมาร์จิ้นสูง และจะทยอยรับรู้รายได้ต่อเนื่องถึง 2Q26
- ผู้บริหารคาดว่าจะงานใหม่จะมาจากโครงการภาครัฐเป็นหลัก อาทิ ทางด่วน ทางยกระดับ ขณะที่ความต้องการจากงานภาคเอกชนยังชะงักจากผลกระทบเศรษฐกิจชะลอตัวและเหตุการณ์แผ่นดินไหว ท่ามกลางการแข่งขันในตลาดที่ผ่อนคลายลง ขณะที่มีการยื่นเสนอราคาและอยู่ระหว่างการพิจารณาของเจ้าของงานรวม 1.16 หมื่นล้านบาท แบ่งเป็นงานภาครัฐ 68% และเอกชน 32% อย่างไรก็ตาม บริษัทยังดำเนินรับงานใหม่ด้วยความระมัดระวังจากข้อจำกัดด้านแรงงานซึ่งปัจจุบันใช้กำลังการผลิตเต็ม
- ประเด็นความขัดแย้งบริเวณชายแดนไทย-กัมพูชา ทำให้แรงงานกัมพูชา 10 คน (จากแรงงานทั้งหมดราว 300-400 คน) เดินทางกลับประเทศ อย่างไรก็ตาม ผู้บริหารคาดว่าจะไม่กระทบต่อการดำเนินงาน เนื่องจากมีแผนทดแทนด้วยการหาแรงงานเมียนมาและการเพิ่มชั่วโมงทำงานล่วงเวลา
- คณะกรรมการบริษัทมีมติยุติการดำเนินงานของบริษัทในเมียนมา (ถือหุ้น 80% คิดเป็นทุนจดทะเบียน 13.4 ล้านบาท) และอยู่ระหว่างทยอยจำหน่ายทรัพย์สิน คาดใช้เวลาประมาณ 1 ปี สาเหตุจากสถานการณ์ทางการเมืองและข้อจำกัดในการเคลื่อนย้ายเงินออกจากประเทศ อย่างไรก็ตาม ประเมินว่าไม่มีผลกระทบต่อภาพรวม เนื่องจากปัจจุบันไม่มีโครงการก่อสร้างที่กำลังดำเนินการอยู่ในเมียนมา

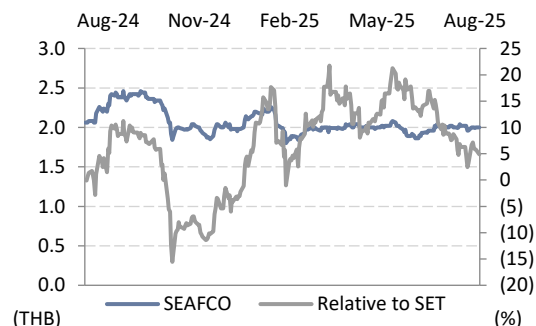
### Comments

- เรายังคงมีมุมมองเชิงบวกต่อผลประกอบการ 3Q25 คาดว่าจะเติบโตเด่นทั้ง q-q และ y-y หนุนด้วยการเพิ่มขึ้นของทั้งรายได้และ GPM แรงขับเคลื่อนหลักมาจากโครงการรถไฟฟ้าสายสีส้ม ซึ่งจะเร่งงานก่อสร้างเต็มที่ เป็น 5 สถานีใน 3Q25 จาก 3 สถานีใน 2Q25 สะท้อนปริมาณเทคอนกรีตเฉลี่ยต่อวันเพิ่มขึ้นเป็น 872 ลูกบาศก์เมตร/วันในก.ค. 2025 เทียบกับ 852 ลูกบาศก์เมตร/วันใน 2Q25 และ 526 ลูกบาศก์เมตร/วันใน 3Q24
- เราคงประมาณการกำไรสุทธิปี 2025 ที่ 148 ล้านบาท เพิ่มขึ้นจากปี 2024 ที่ 1 ล้านบาท และคงราคาเป้าหมายที่ 3 บาท ยังแนะนำซื้อ จากโมเมนตัมกำไรที่เร่งตัวขึ้นใน 3Q25 นอกจากนี้ ปัจจุบันหุ้นซื้อขายระดับ 1.0x 2025E P/BV (-1.5SD) และราคาหุ้น YTD ยังทรงตัวเมื่อเทียบกับ PYLON ที่ปรับขึ้น +10%

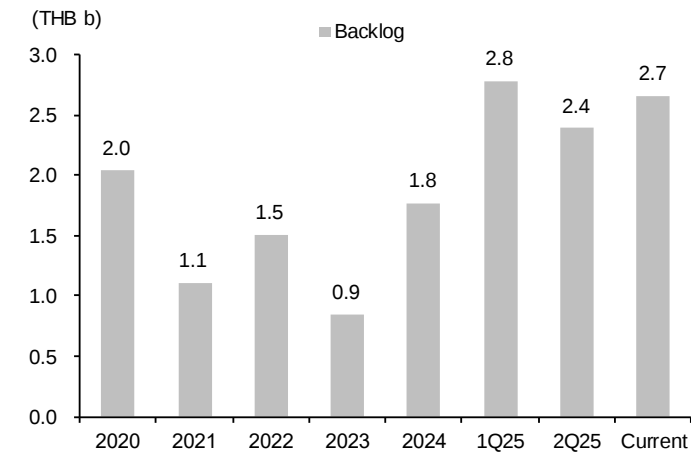

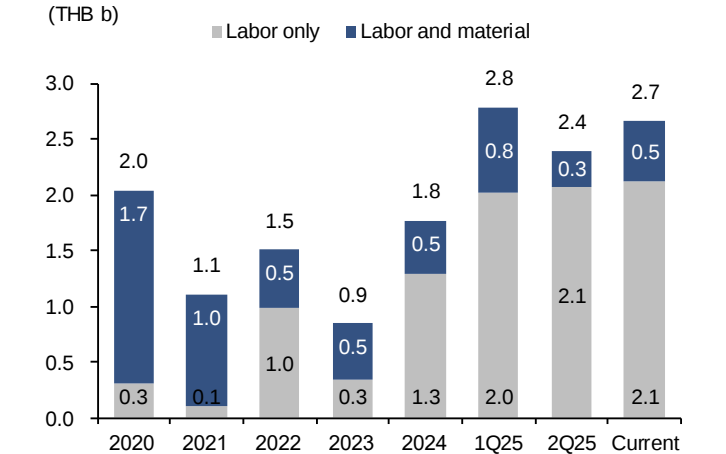

Exhibit 1: Current backlog



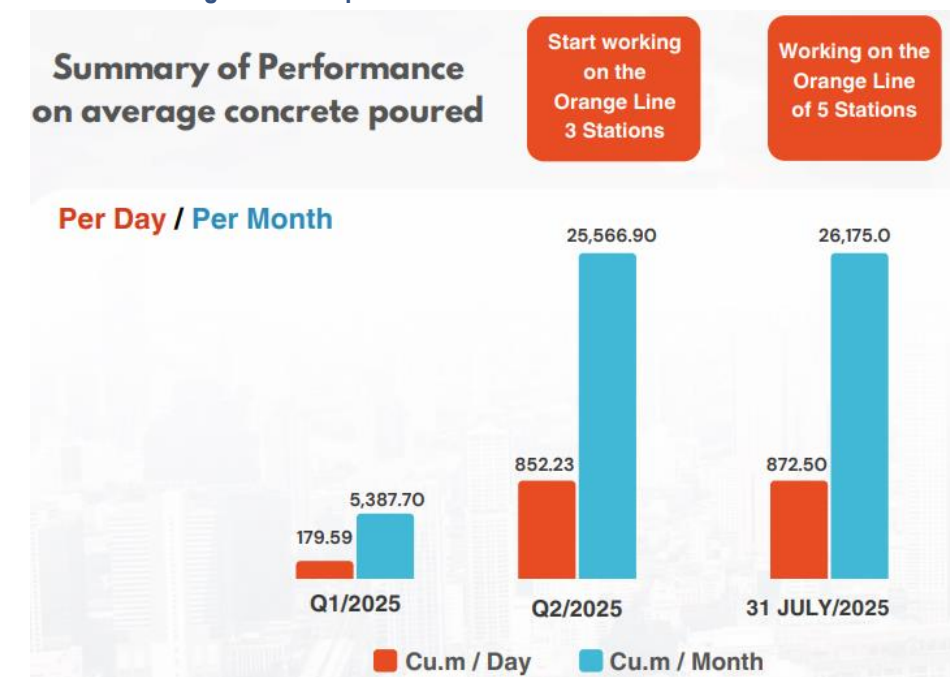

Exhibit 2: Backlog breakdown by type of work



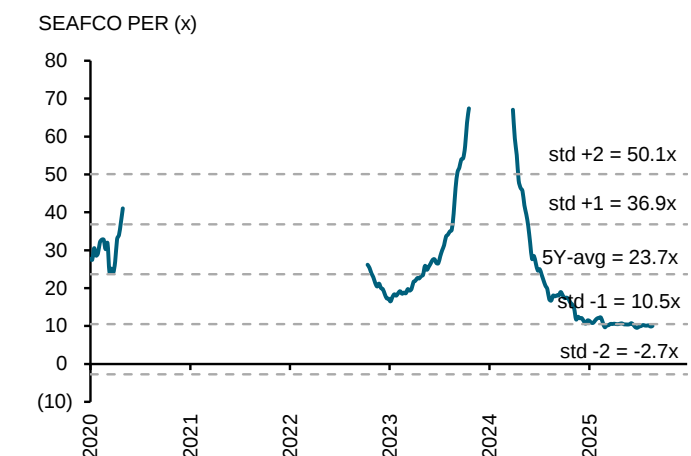

Exhibit 3: Average concrete poured



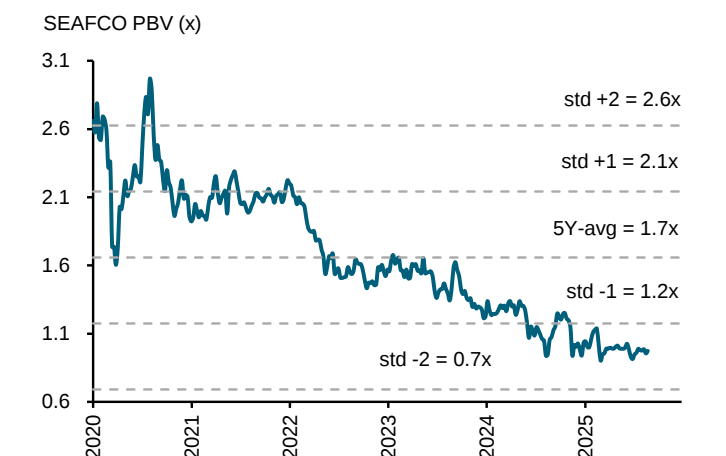

## RECOMMENDATION STRUCTURE

### Stock ratings

Stock ratings are based on absolute upside or downside, which we define as  $(\text{target price}^* - \text{current price}) / \text{current price}$ .

BUY (B). The upside is 10% or more.

HOLD (H). The upside or downside is less than 10%.

REDUCE (R). The downside is 10% or more.

Unless otherwise specified, these recommendations are set with a 12-month horizon. Thus, it is possible that future price volatility may cause a temporary mismatch between upside/downside for a stock based on market price and the formal recommendation.

\* In most cases, the target price will equal the analyst's assessment of the current fair value of the stock. However, if the analyst doesn't think the market will reassess the stock over the specified time horizon due to a lack of events or catalysts, then the target price may differ from fair value. In most cases, therefore, our recommendation is an assessment of the mismatch between current market price and our assessment of current fair value.

### Industry Recommendations
