## 3Q25 results at first glance

ขาดทุนสุทธิมากกว่าคาดเพราะขาดทุนจากสต็อกสูงกว่าคาด

### Highlights

- SCC รายงานผลขาดทุนสุทธิ 669 ล้านบาทใน 3Q25 มากกว่าที่เราคาดว่าจะขาดทุนสุทธิ 515 ล้านบาท จากผลขาดทุนจากสต็อกที่มากกว่าคาด
- หากไม่รวมผลขาดทุนจากสต็อก 1.3 พันล้านบาท และขาดทุนจากการปรับโครงสร้างธุรกิจอีก 95 ล้านบาท SCC จะมีกำไรปกติ 774 ล้านบาท -74.9% q-q เป็นไตรมาสที่ต่ำที่สุดในปี 2025 เนื่องจากโรงงาน LSP ที่เวียดนามกลับมาเดินเครื่อง (ตั้งแต่ 20 ส.ค. 2025) ในจังหวะที่ Spread ของสินค้าปิโตรเคมีลดลงอีกครั้งจากราคาวัตถุดิบที่สูงขึ้น และมีค่าใช้จ่ายสำหรับการเริ่มเดินเครื่อง (One-time) ประมาณ 200-300 ล้านบาท (ถึงแม้บวกกลับรายการ One time นี้ กำไรปกติ 3Q25 ก็ยังต่ำกว่า 1Q25)
- หากพิจารณาเฉพาะ Operation ในไตรมาสนี้ แม้ว่าจะรายได้จะ -2.3% q-q, -5.0% y-y แต่ SCC มี EBITDA 1.4 หมื่นล้านบาท (-18.6% q-q, +43.6% y-y) EBITDA ที่ลด q-q มาจากการลดลงของแทบทุกธุรกิจ (ยกเว้น SCGD) จากผลของ low season ของธุรกิจซีเมนต์และวัสดุก่อสร้าง เงินปันผลรับลดลงจากไตรมาสก่อน ทั้งนี้ เงินปันผลรับมักสูงทุก ๆ 2Q และ 4Q, และ Spread ของปิโตรเคมีที่ลดราว 10% q-q
- EBITDA ที่ดีขึ้นมาก y-y มาจากการเพิ่มขึ้นแทบทุกธุรกิจ ทั้งปิโตรเคมีที่ Spread ดีขึ้น ธุรกิจซีเมนต์ได้ประโยชน์จากการปรับขึ้นราคาปูนซีเมนต์ในประเทศและเพิ่มสัดส่วนสินค้า HVA การปรับโครงสร้างธุรกิจและการควบคุมรายจ่ายอย่างเข้มข้น ทั้งนี้ ยกเว้นกลุ่ม Smart living ที่มี EBITDA ลดลง y-y จากกลุ่มอสังหาริมทรัพย์ที่ชะลอตัว
- ดอกเบี้ยจ่าย -2.1% q-q, -7.2% y-y ลดลงต่อเนื่องเป็นไตรมาสที่ 3 ตามนโยบายของผู้บริหารในการลดภาระหนี้ให้มากที่สุด หนี้สินสุทธิในไตรมาสนี้ลดลงอีก 2.5 พันล้านบาท ทำให้ Net debt ต่อ EBITDA ลดเป็น 4.7 เท่าจาก 5.1 เท่าใน 2Q25

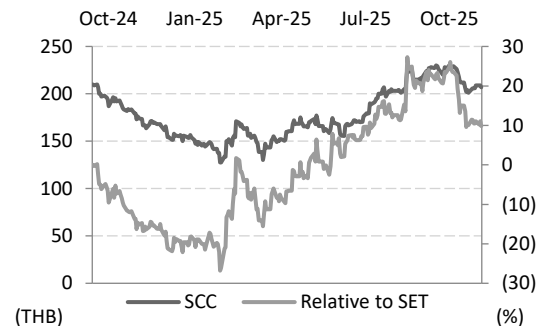
### Outlook

- แนวโน้มโดยรวมของธุรกิจ 4Q25 ดีขึ้น q-q แต่ธุรกิจปิโตรเคมียังอาจทำได้เพียงทรงตัว เพราะต้นทุนแนฟทายังอยู่ระดับสูง สำหรับกำไรปกติ 9M25 ที่ +47.7% y-y เป็น 5 พันล้านบาท คิดเป็น 50% ของประมาณการทั้งปี น่าจะมีการปรับลดประมาณการ แต่กำไรสุทธิ 9M25 คิดเป็น 73% ของทั้งปี ยัง in line
- แม้อุตสาหกรรมปิโตรเคมียังอยู่ในวัฏจักรขาลงอีก 1 ปี แต่การคุมรายจ่าย ปรับโครงสร้างธุรกิจ และกระแสเงินสดมั่นคง ทำให้ SCC ดีกว่าอุตสาหกรรม แต่ราคาหุ้นมี upside จำกัดเมื่อเทียบราคาเป้าหมายปีนี้ที่ 220 บาท คงคำแนะนำถือ

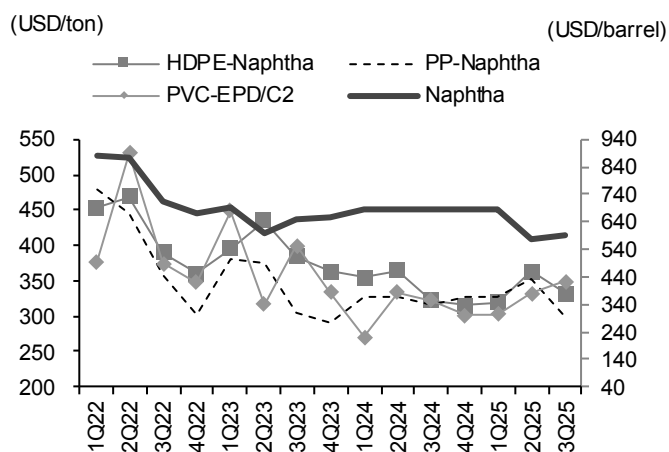

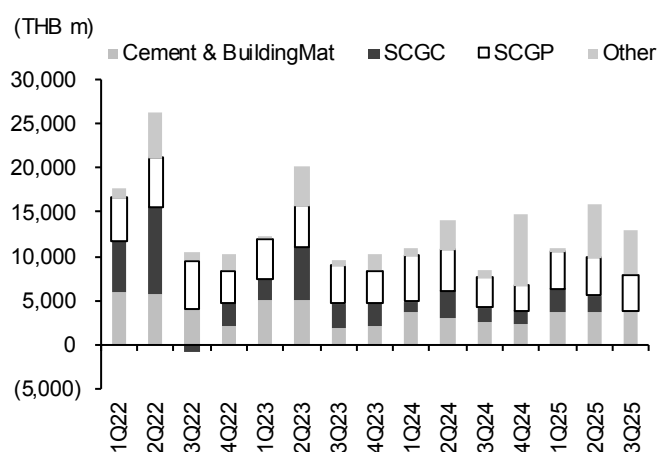

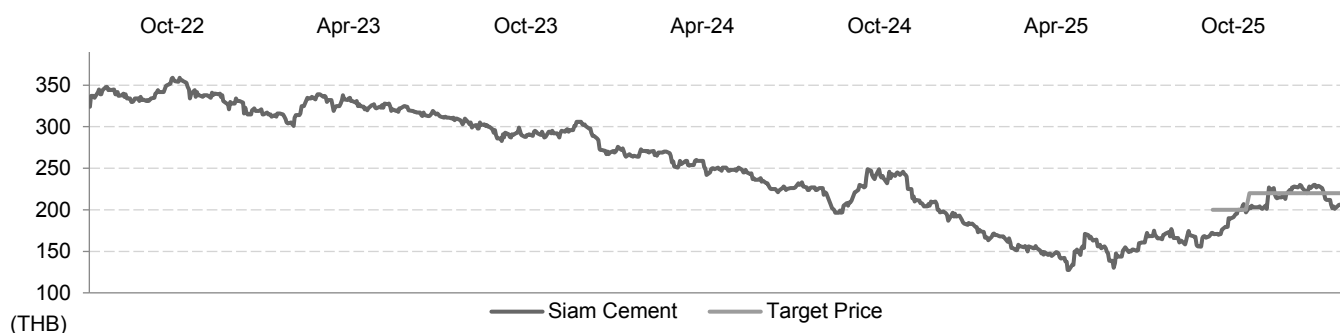
