2.2% EPS downside on rising oil price and weaker GDP growth in 2022

Fears of stagflation have triggered a sell-off of risky assets across the globe, including the SET index, as the likelihood of concurrently rising inflation driven by high energy prices and an economic slowdown is rising. We, however, believe that the recent 5.8% sell-off on the SET index should have already priced in the worst impact of the Russia-Ukraine war since 24 Feb-22. To assess the earnings downside risks, we conducted stress tests on the SET index with a high crude oil price and weaker GDP growth for Thailand using both top-down and bottom-up approaches. We found that the downside risk to the SET index would be 4.6% to 1.567 via the top-down approach and 3.6% to 1.584 via the bottom-up approach.

Higher inflation: a short-term bane but a long-term boon to the Thai economy

While we believe that higher inflation could dim the Thai economy in the short term due to weaker purchasing power and the Bank of Thailand (BoT)'s policy rate hike, we think that in the long term, inflation should boost Thai economic growth, driven by rising tourism revenue, mild inflation on government subsidies, and stronger industrial production for exports and investments. Based on the BoT's analysis of GDP growth sensitivity to changes in the crude oil price, every USD10/bbl rise in crude oil price would reduce Thailand's GDP growth by 0.1% and increase inflation by 0.5%. Thus, if the Brent crude oil price rises by USD35-40/bbl to USD100/bbl, we project Thai GDP growth to weaken by 0.4% to 3% y-y.

Limited downsides for the SET index; in both top-down and bottom-up tests

We have gauged the downside risks to the SET index, using both top-down and bottom-up approaches, and found that the potential downsides would be 3.6-4.6% with SET values of 1,567 and 1,584, and -0.4% GDP growth in 2022. Our chief methodologies are a top-down approach using the SET's historical gross margin levels during the prolonged high oil price period in 2011-14 under an average inflation adjusted oil price of USD110/bbl; and a bottom-up approach using FSSIA's analyses of the impact on the SET's EPS. Our key assumptions are: 1) an average USD100/bbl Brent crude oil price in 2022, up from the current USD75/bbl; and 2) 3.4% 2022 GDP growth as forecast by the BoT.

Overweight on Thai equity market

We believe the SET index has limited downsides (3.6-4.6%) under our stress-test assumptions of a higher oil price and lower GDP growth, and hence prefer domestic sectors to cyclical, backed by a strong domestic recovery and the return of tourism. We are OVERWEIGHT on Thai equity and maintain our SET index target of 1,892, based on 17.2x 2022E P/E, the 10-year average, by end-2022, backed by 1) stronger corporate earnings; 2) an improving economic outlook; and 3) upsides from tourism and export growth.

Thailand Retailing - Inflation coming to shore up SSSG

Net positive impact on retailers amid high inflation environment

Thailand's inflation (headline CPI) hit a record high at 5.3% in Feb-22, the highest level over the past ten years. The high inflation environment should have both positive and negative impacts on retailers. On the positive side, the retail price of consumer products should increase as suppliers pass through their higher raw material costs to the customers. Hence, this would positively impact both retailers' SSSG and gross profits, as the retailers would get a fixed percentage of the profit sharing. On the negative side, retailers would be exposed to higher transportation costs and utility costs due to the higher fuel price, but we see a limited impact as fuel costs typically account for c1-2% of total SG&A expenses for retailers. Overall, we believe the high inflation environment will have a net positive impact which could boost retailers' SSSG.

Positive correlation between CPI and SSSG; limited impact from high fuel price

We see a positive correlation between the headline CPI and SSSG. We believe this can be attributed to suppliers increasing retail prices to reflect the higher manufacturing costs. Retailers should see a limited impact from the higher oil price. The diesel price rose by only 5.3% YTD to THB29.9/litre thanks to the government's price cap policy for diesel at THB30/litre since Nov-21. We have followed up with CPALL and reaffirmed our view. CPALL guided that the current oil price would reduce its net profit (NP) by 0.02%. For the utility cost, the ERC announced a higher fuel tariff (Ft) to THB0.014/unit in Jan-Apr 2022 from THB-0.153 in 4Q21. This implies that the electricity cost would increase by 4-8% depending on the base rate. Hence, the impact on retailers' NPs would be less than 1%.


Possibility for wage hike: positive impact to the retailers

According to the Bangkok Post newspaper on 26 January 2022, the government plans to increase the daily minimum wage from THB336 per day to THB492 per day (+46%). This raises a concern for retailers which would be exposed to higher personnel expenses, which normally account for 3-10% of total sales. However, the wage hike should increase purchasing power and contribute to positive SSSG and solid NP growth.

Top picks: CPALL and BJC


We reiterate our OVERWEIGHT call on Thai retailing for the strong earnings recovery expected in 2022 and the potential windfall benefit from the high inflation environment. Amid the high inflation and global uncertainty, we like staple retailers over discretionary retailers for their more resilient earnings. Our top picks are CPALL and BJC. We like CPALL as it should be a prime beneficiary of the domestic recovery and the resumption of international tourism. We like BJC as a laggard play and a beneficiary of the high inflation environment. Big C's SSSG should turn positive at 8% in 2022 after suffering negative SSSG since 2019.

Exhibit 4: Thailand's food inflation





Exhibit 5: Thailand's food inflation growth





Thailand Energy – Oil Stations - Getting out from the devil and the deep blue sea

Favourable regulations to further enhance the rebound in demand and margins

After a poor 2021 due to the impact of Covid-19, we think Thai operators of oil stations should see strong net profit growth in 2022, backed by 1) an improving marketing margin on the back of the government's more favourable tax and subsidy policy for diesel; 2) higher sales volumes due to improving economic activities – demand growth in Jan-22 was high y-y despite the rising number of the Covid-19 cases; and 3) improving non-oil EBITDA for food & beverage (F&B), LPG, and retail businesses.


Gasoline demand recovery has already surpassed pre-Covid levels

The demand for four key fuels – diesel, gasoline, fuel oil, and jet fuel – has recovered markedly y-y, particularly for diesel (+24% y-y), gasoline (+12% y-y), and jet fuel (+76% y-y), which bounced back from their bottoms in mid-2021 after the government largely opened up economic activities and domestic and international flights, though at a piecemeal pace for international flights. Lower margin burdens thanks to government initiatives

We believe the government's recent moves to curb the prices of electricity and diesel will benefit Thai operators of oil stations, effectively reducing the burden on the private sector. First, the government aims to maintain the retail price of diesel at THB30/litre by cutting the excise tax from THB5-6/litre to THB0.05/litre in Feb-22 and lifting the subsidy to THB9.6/litre. Second, on 8 Mar-22, the Thai cabinet approved cuts to the excise tax for biodiesel from THB3.2/litre to THB0.05/litre and for fuel oil from THB0.64/litre to THB0.05/litre to help relieve the financial burden on the Electricity Generating Authority of Thailand (EGAT), effective from 8 Mar to 15 Sep-22. However, the oil fund status has turned to a net loss of THB24b since Dec-21 and could worsen financially in the next few months as we expect the crude oil price to remain high above USD100/bbl throughout 2022. PTG and OR are our top picks

We expect stronger net profit growth for oil station operators in 2022, backed by 1) solid sales volume growth post economic reopening; 2) a rising marketing margin, supported by government policies; and 3) improving EBITDA from non-oil businesses, namely F&B, LPG sales volumes (PTG), and wholesale volumes. Our top picks in the oil station sector are PTG and OR. As a pure play, PTG has the highest operating leverage on the projected recovery in the marketing margin as most of its oil stations have a COCO model. OR is our top pick for its well-diversified and integrated portfolio of oil (retail and wholesale) and non-oil businesses (F&B, CVS), and we expect OR's net profit growth to accelerate in 2022, backed by a rise in the sales volumes and margins for its oil and non-oil units.

Exhibit 10: Oil fund status





Exhibit 11: Oil fund tax



Exhibit 12: Top 25 countries by new cases



Exhibit 13: Global by new cases and deaths




Daily New Cases in Thailand




Daily New Cases in India

Thailand affirms neutral stance, Urges peaceful end to Ukraine conflict BANGKOK POST: Thailand has confirmed its neutrality in the Russia-Ukraine conflict, saying it remains committed to a balanced foreign policy that is in the country's best interests. Government spokesman Thanakorn Wangboonkongchana clarified the government's stance on the Russia-Ukraine situation on Thursday, saying that since the start of the conflict, Prime Minister and Defence Minister Prayut Chanocha had laid down a policy of supporting dialogue to find a peaceful resolution in accordance with the principles of the United Nations Charter.

- TAT devises plan to relax travel rules, Targets cut due to invasion of Ukraine BANGKOK POST: The Tourism Authority of Thailand (TAT) is preparing a plan to relax travel rules in line with the timeline to declare Covid-19 an endemic disease on July 1. The tourism goals for revenue and arrivals this year might be downgraded because of surging oil prices and inflation caused by Russia's invasion of Ukraine, said TAT governor Yuthasak Supasorn. Mr Yuthasak said the plan to label Covid-19 endemic from the second half of the year will lead to further relaxations, including the termination of Thailand Pass, marking a milestone for the industry. The agency has to start working on new protocols over the next four months, he said. However, an RT-PCR Covid test result from tourists remains essential for the time being as the country is struggling with an overwhelming daily caseload, said Mr Yuthasak. He said Thailand should adopt safety procedures and learn lessons from other countries that have already opened up to ensure the kingdom remains competitive in luring international tourists.
- Industries confidence drops for first time in 6 months BANGKOK POST: The country's industries sentiment dropped in February for the first time in six months, dented by a spike in Covid-19 infections, surging oil prices and the impacts of Russia's invasion of Ukraine, an industries group said on Thursday. The Federation of Thai Industries (FTI) said its industries sentiment index fell to 86.7 in February from 88.0 in the previous month. Industries were worried about every factor in the FTI's survey, including the global and domestic economies and volatile exchange rates, FTI chairman Supant Mongkolsuthree told a news conference. The Ukraine crisis has had a direct and indirect impact, particularly on the prices of energy and raw materials, he said.
- Phuket welcomes sea tourists BANGKOK POST: Phuket has welcomed its first group of foreign travellers arriving by sea under the Test & Go entry programme. Nanthasiri Ronnasiri, director of the Phuket office of the Tourism Authority of Thailand, said the four Indonesian nationals arrived from Singapore on a private yacht called The Maggie, which docked at Ao Por pier. They were the first to arrive under the scheme by sea after the Centre for Covid-19 Situation Administration (CCSA) early this month eased travel restrictions to allow overseas arrivals by land and sea in addition to by air. Fully vaccinated travellers arriving by sea are required to take an RT-PCR test upon arrival and must remain aboard their vessels until the result is released.
- Ministry to revise Covid-19 fatalities, Up to 30% died due to underlying causes BANGKOK POST: The Public Health Ministry will revise how it records Covid-19 fatalities after finding that up to 30% of people who died with the infection did so due to underlying causes. Public Health Minister Anutin Charnvirakul said the ministry will conduct revisions to more accurately determine the cause of fatalities in relation to Covid-19 infections. Dr Kiattiphum Wongrajit, permanent secretary for public health, said that 10-30% of those who died while infected with Covid-19 were found to have serious underlying diseases such as cancer.
- Government aims to double booster shot rate for elderly ahead of Songkran BANGKOK POST: An ambitious vaccination campaign for the elderly will be rolled out later this month to prevent a surge in Covid-19 cases during the Songkran festival in mid-April. Centre for Covid-19 Situation Administration assistant spokeswoman Sumanee Wacharasin, said on Thursday authorities will pool resources to encourage people over 60 to receive a booster shot to help maintain high levels of immunity ahead of the Thai New Year holiday. From March 21-31, the campaign will aim to get around 70% of the elderly vaccinated against the coronavirus, she said.

- SCG rejigs investment plans, Increasing energy prices a major factor BANGKOK POST: The widening impact of the Russia-Ukraine war is causing SET-listed Siam Cement Group (SCG), Thailand's largest cement maker and industrial conglomerate, to review its investment plan this year as energy and raw materials prices are increasing. The company earlier vowed to allocate 80 billion baht for investments in Thailand and overseas this year. "We will delay some new investment projects, especially greenfield investments, and consider increasing more investments under merger and acquisition plans to avoid possible impact on our long-term financial management," said Roongrote Rangsiyopash, president and chief executive of SCG. The ongoing conflict between Russia and Ukraine is blamed for driving up global crude oil prices, causing higher energy costs in the logistics and manufacturing sectors. Prices of naphtha, a key feedstock for the petrochemical industry, also cannot avoid the impact, said Mr Roongrote. Naphtha costs account for 70-80% of SCG's petrochemical business. They account for 20% in the company's cement and building material business and 5% in its packaging business. "SCG may need to increase the prices of petrochemical products, following higher naphtha prices," said Mr Roongrote. "Prices of cement and building materials will also gradually increase."
- NDID to service corporate sector, Move 2nd phase of platform's growth BANGKOK POST: The National Digital ID (NDID) Co Ltd plans to expand digital identity verification and data-sharing services on its NDID platform to cover the corporate sector. The company wants to expand services this year to the business and government sectors as the second phase of the NDID platform development, said chairman Payong Srivanich, who is also chairman of the Thai Bankers' Association. Currently the platform provides services to individual users.
- Bitcoin dips below \$40,000 BANGKOK POST: Bitcoin dropped back below US\$40,000, erasing nearly all gains sparked by optimism about US President Joe Biden's executive order on crypto, as digital currencies fell with stocks Thursday amid

high inflation data and continued geopolitical uncertainty. The largest cryptocurrency declined as much as 7.9% to \$38,582 on Thursday, falling for the first time in three days. Ether fell as much as 5.7% to \$2,553. Most of the top cryptocurrencies were down at least slightly in the 24 hours prior to 9.30am New York time, according to pricing from CoinGecko. In terms of risky assets, digital currencies fall on the far-end of the spectrum, according to Callie Cox, US investment analyst at eToro. Yet, in a survey of 100 institutional investors and wealth managers, 73% saw Bitcoin as a viable hedge against inflation, according to research commissioned by London-based Nickel Digital Asset Management.

- Malaysia could spend \$6.7bn in oil subsidies in 2022 BANGKOK POST: KUALA LUMPUR: Malaysia's petroleum subsidies bill could more than double to 28 billion ringgit (US\$6.7 billion) this year if crude oil prices remain at elevated levels following Russia's invasion of Ukraine, the finance minister said on Thursday. Finance Minister Tengku Zafrul Aziz told parliament the government has already started boosting subsidies, spending 2 billion ringgit on petrol, diesel, and liquefied petroleum gas subsidies in January a tenfold increase from the same month last year. Malaysia spent 11 billion ringgit in petroleum subsidies last year. Its monthly subsidies bill could balloon to 2.5 billion ringgit if the war in Ukraine, which Russia calls a "special operation", keeps crude oil prices above \$100 a barrel as global supplies are squeezed, Tengku Zafrul said. He added the government was reviewing its subsidy mechanisms to ensure the handouts reach targeted vulnerable groups, as prices of other subsidised goods such as cooking oil are also set to rise. "The government cannot borrow to finance operating expenditures such as subsidy costs," he said. "So the increase in subsidies needs to be offset by additional revenue and expense savings."
- 'World's largest' floating hydro-solar farm powers green push in Isan BANGKOK POST: The first of 15 such farms planned to help Thailand reach carbon neutrality by 2050 is also touted as a tourist attraction A vast array of solar panels floats on the shimmering waters of a reservoir in the northeastern province of Ubon Ratchathani, symbolising the kingdom's drive towards clean energy as it seeks carbon neutrality by 2050. The immense installation, covering 720,000 square metres of water surface, is a hybrid system that converts sunlight to electricity by day and generates hydropower at night. Touted by authorities as the "world's largest floating hydro-solar farm", the Sirindhorn dam project is the first of 15 such farms Thailand plans to build by 2037. The country is stepping up efforts to wean itself off fossil fuels, and at the COP26 climate conference in Glasgow last year, Prime Minister Prayut Chan-o-cha set the target of carbon neutrality by 2050 followed by a net-zero greenhouse emissions by 2065. The Sirindhorn dam farm -- which began operations last October -- has more than 144,000 solar cells, covering the same area as 70 football pitches, and can generate 45 MW of electricity.

Exhibit 14: Foreign fund flow and SET Index





Exhibit 15: Foreign participation
