Continuing to capture revenue from green Covid patients

The market is concerned about Covid-related revenue falling after the government launches its new Covid treatment payment scheme, UCEP Plus, starting on 16 Mar. From BCH's analyst meeting on 11 Mar, we are confident that it should continue to capture strong Covid-related service revenue under a new scheme in which green symptom Covid patients have three main treatment options: 1) hospitals for SSO patients which BCH can reimburse cTHB2,000 per day; 2) home isolation for non-SSO patients which BCH can reimburse up to THB12,000 per case; and 3) an alternative hospital package starting from THB28,000 per case for self-pay and insurance patients. The reimbursement rate for yellow and red symptom Covid patients will not be impacted by UCEP Plus.

Expect strong 1Q22 earnings to be in line with 4Q21

Despite the reimbursement rate declining under UCEP Plus, we expect the higher volume of Covid patients to offset the decline. The number of infected patients rose from an average of c6,700 cases per day to more than 20,000 over the past three weeks. The number of Covid patients under BCH's hospitals and hospitelts also increased to c13,500 beds/day in Jan-Feb, higher than c3,700 beds/day in 4Q21 and c11,700 beds/day in 3Q21. Overall, we expect Covid-related revenue contributions to increase to 65-70% in 1Q22 from 59% in 4Q21, and roughly forecast a core profit of THB2.4b in 1Q22 (vs THB2.5b in 4Q21).

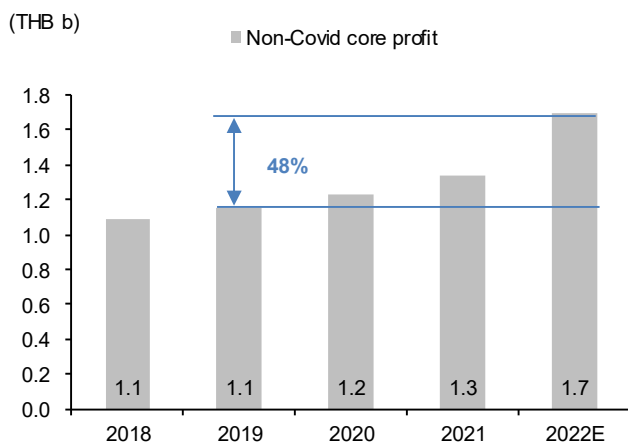
2022E non-Covid profit to grow by 27% to THB1.7b

We estimate that 2021 non-Covid profit was THB1.3b and it should grow to THB1.7b in 2022, exceeding the pre-Covid level by 48%, driven by the recovery in both Thai and international non-Covid patient numbers, a larger SSO-registered member base and a better utilisation rate for its three new hospitals. We also expect an additional profit of THB1.9b based on Covid-related revenue of THB6.6b in 2022 (vs THB12.5b in 2021). As a result, we expect a total core profit of THB3.6b in 2022.

Revised 2022E core profit

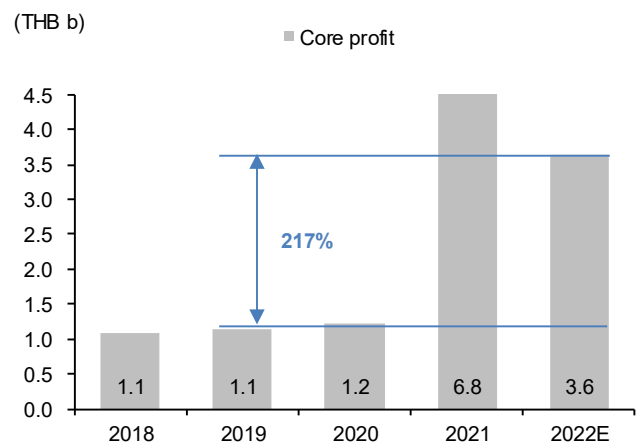
We revise up our 2022E core profit by 68% to reflect the strong 1Q22 outlook. BCH trades at an attractive 14x 2022E P/E (30x non-Covid profit) vs its peers' average of 35x and its five-year average of 34x. A short-term catalyst would be strong 1Q22 earnings.

Expect Covid-related revenue to grow q-q in 1Q22

We expect CHG's earnings to remain strong in 1Q22. Covid-related revenue should increase q-q due to the surging Omicron variant. The number of infected patients rose from an average of c6,700 cases per day to more than 20,000 over the past two weeks. The number of Covid patients under CHG's care also increased from c3,500 beds/day in 4Q21 to more than c4,000 beds/day in Jan-Feb. CHG has started to accept Home Isolation patients, with more than 1,000 cases/day in Feb-22. We expect CHG to book Moderna vaccination revenue of c360k doses in 1H22 (already booked 90k doses in 4Q21). Overall, we expect CHG to report a core profit of cTHB1.4-1.6b in 1Q22 (vs THB1.8b in 4Q21).

Strong 2022E earnings even without Covid

We estimate that organic core profit should hit THB1.1b in 2021 and grow by 22% to THB1.3b in 2022, driven by the recovery in both Thai and international non-Covid patient numbers, a larger SSO-registered member base and three new managed heart centres. 2022E organic core profit of THB1.3b should exceed the pre-Covid level by 84%. Aside from strong organic growth, we expect an additional Covid profit of THB0.8b based on Covid-related revenue of THB2.7b in 2022 (vs THB6.1b in 2021). As a result, we expect a total core profit of THB2.1b in 2022, exceeding the pre-Covid level by 196%.

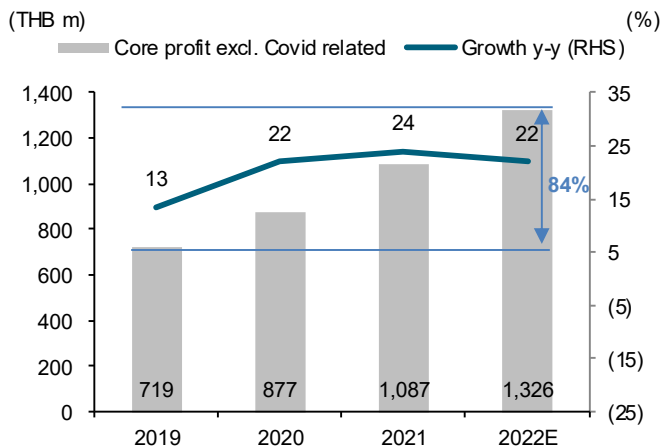
IPD bed capacity to jump 70% by 2026

CHG plans to open three new greenfield hospitals including CHG Mae Sot (100 beds), Cancer Center (50 beds) and CHG Phraeksa (100 beds). CHG also plans to expand its IPD capacity for existing hospitals by up to 272 beds. As a result, its IPD capacity would jump by 70% from the 749 beds currently to 1,271 beds by 2026. This would support long-term growth for CHG over the next five years.

Revised 2022E core profit

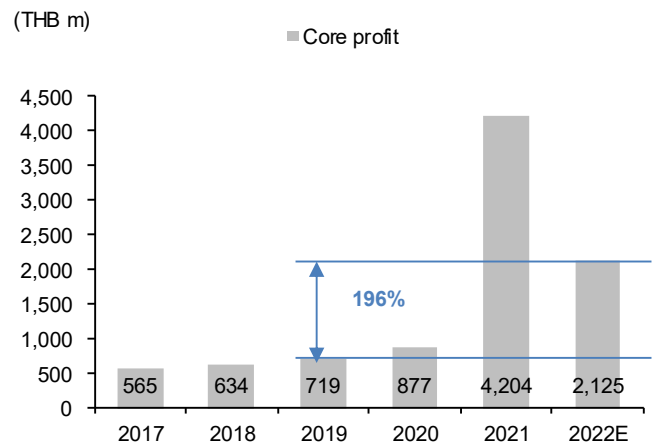
We revise up our 2022E core profit by 30% to reflect the strong 1Q22 outlook. CHG trades at an attractive 19x 2022E P/E (31x non-Covid profit) vs its peers' average of 35x and its five-year average of 34x. We believe its current valuation is unjustified and that it deserves to trade at a premium valuation to both its peers and historically as CHG is one of the few stocks that can leverage the pandemic and use it to boost organic earnings going forward.

Key takeaways from Analyst Meeting

NCAP (BUY; TP THB16.8) – Slightly positive view from analyst meeting

- NCAP will aggressively increase its loan portfolio during the next three years. It targets 2022 loan growth of more than 45% y-y (+46% y-y in 2021). Key driven growth in 2022 is motorcycle hire purchase (MHP). Moreover, NCAP targets to deliver significant loan growth of 40% and 35% in 2023-24. Motorcycle title loan (expected to start operation in 4Q22) and point of sale lending should gradually increase in 2023-24.
- To achieve such a remarkable loan growth, in 2022, the company will expand 20% in its motorbike dealer from 733 dealers in 2021, along with increase three more branches to support its staff.
- NCAP affirmed that with the surge in its loan volume, the company should continue to deliver a healthy asset quality. In 2021, its NPL ratio was only 1.4% with 402% coverage ratio.
- The competition of MHP might increase due to the new comers. Thus, management expects its loan yield (excluding the impact from the potential rate from the OCPB) should gradually decline.
- Regarding the potential rate cap on MHP, currently the BoT is considering the impact to MHP industry. There is no timeline for the official announcement.
- NCAP believes its recent capital increase (RO and warrants) together with the increase in its debt instrument should sufficient for its aggressive expansion during the next three years.

Comments;

- We read overall message as slightly positive following its aggressive expansion plan.
- With the experience management and solid IT platform, we are convinced that NCAP should achieve its loan growth target.
- However, due to the regulation uncertainty and the negative impact in the short term from its capital increase, we think its share price will still be pressured.

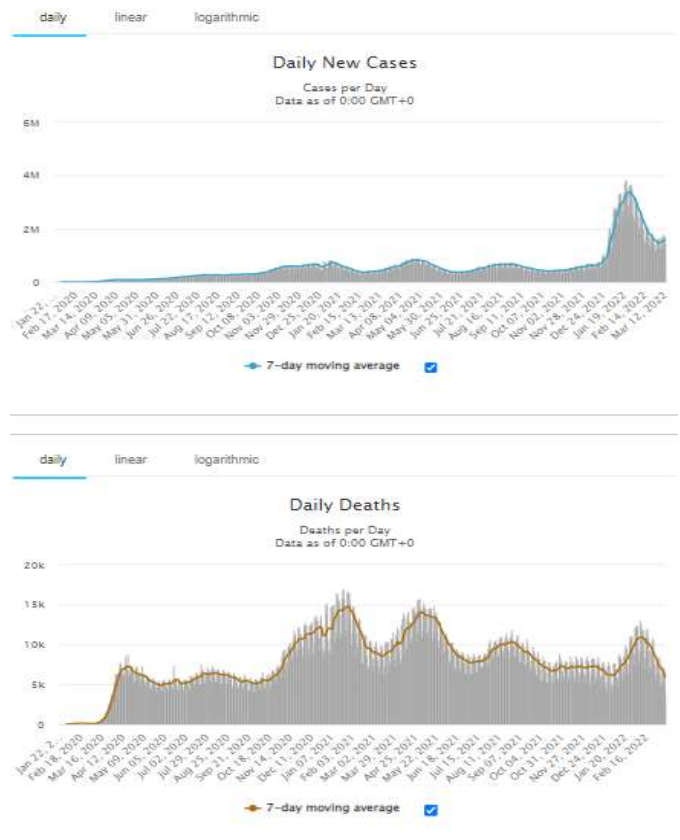

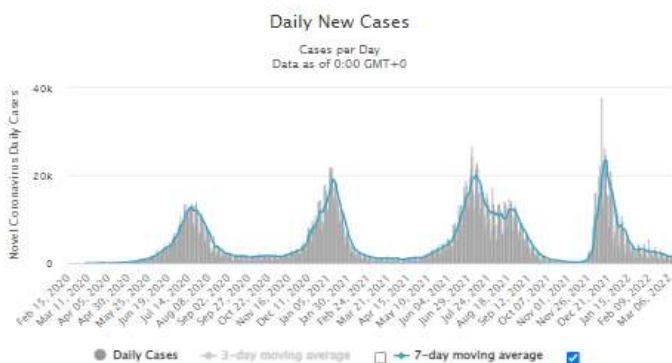

Exhibit 8: Global by new cases and deaths

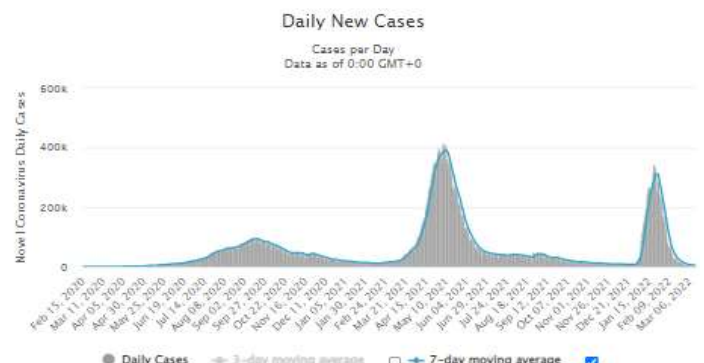

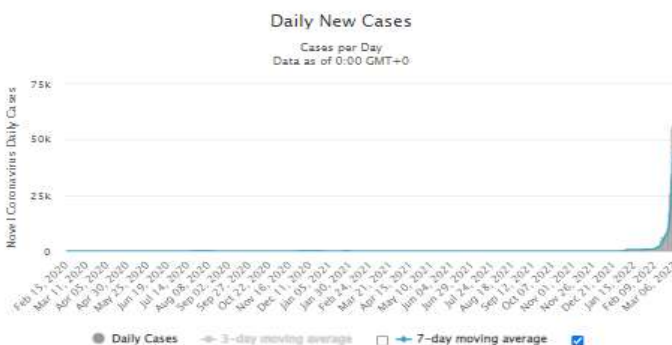
Daily New Cases in South Africa



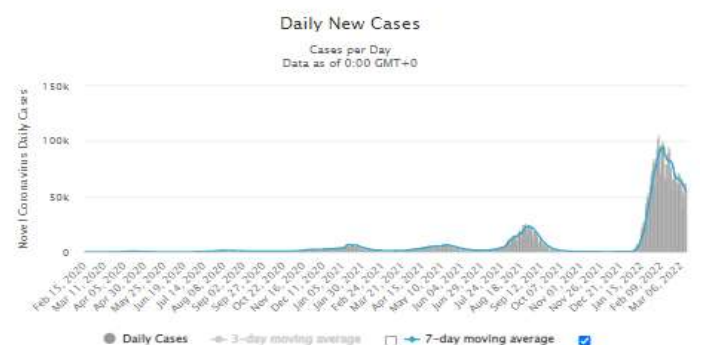
Daily New Cases in India



Daily New Cases in China, Hong Kong SAR

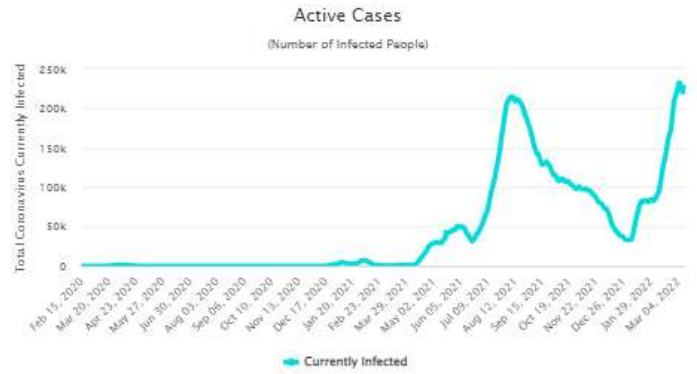
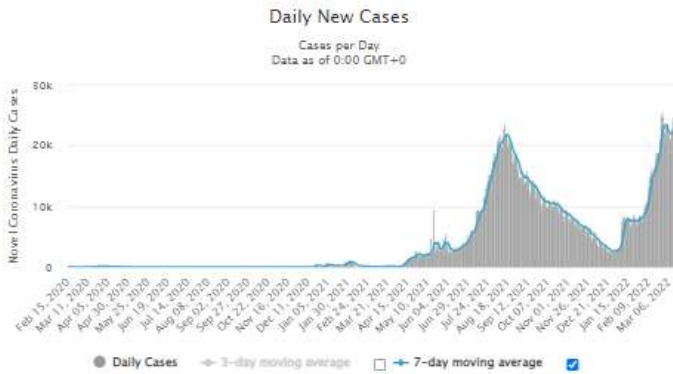


Daily New Cases in Japan

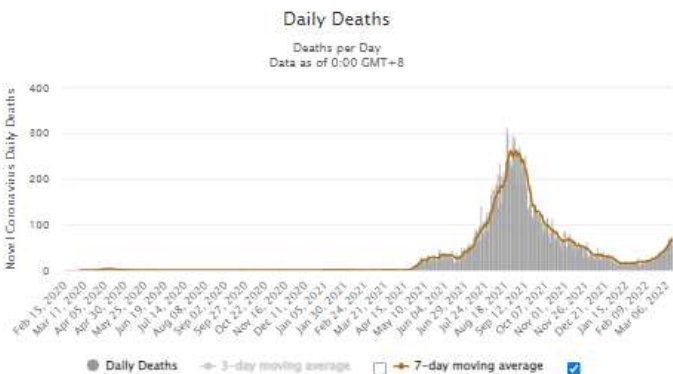


Daily New Cases in Thailand

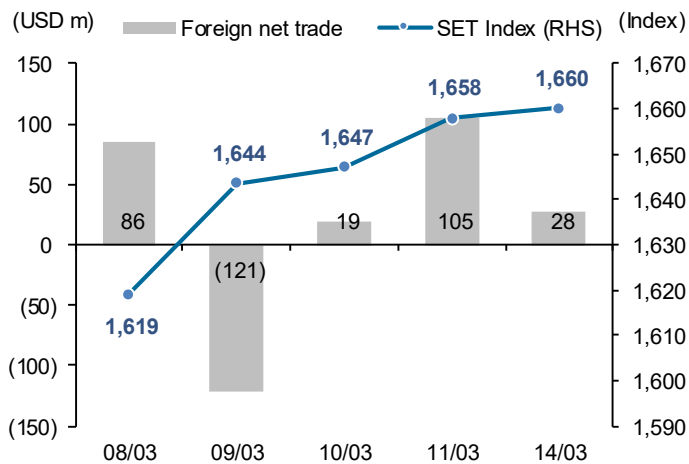
- US expresses 'deep concerns' on Russia-China 'alignment'** BANGKOK POST: WASHINGTON - The United States expressed concern Monday about "alignment" between Russia and China, after high-ranking US and Chinese officials met for seven hours on the Ukraine war and other security issues. US National Security Advisor Jake Sullivan and Yang Jiechi, the Chinese Communist Party's chief diplomat, met in a Rome hotel for what a White House readout described as a "substantial" session. Chinese foreign ministry spokesman Zhao Lijian told journalists Monday that China had "played a constructive role in urging peace and calling for negotiations."
- Snap poll 'likely early next year', Prawit: Dissolution after Apec summit** BANGKOK POST: Deputy Prime Minister and Palang Pracharath Party (PPRP) leader Prawit Wongsuwon on Monday told small coalition partners that a House dissolution is expected late this year with snap elections likely to take place early next year, a source said. Gen Prawit shared the timeline during talks with representatives from small coalition parties at the Five Provinces Bordering Forest Preservation Foundation on Phahon Yothin Road yesterday evening. As he called on the small parties to stay united and be careful about media interviews, he told them that a House dissolution was likely to take place late this year.
- Bangkok, Pattaya polls set for May 22, Both Incumbents tight-lipped on future** BANGKOK POST: The people of Bangkok and Pattaya will to vote for new city chiefs and councillors on May 22. The Election Commission announced on Monday it had decided on May 22 for elections in the two cities, and the date would be officially declared on March 25.
- Laos power plant deals in the pipeline** BANGKOK POST: Developers and operators of four hydroelectric power plants in Laos will sign power purchase agreements with energy policymakers in Laos and Thailand within May under a plan to promote more renewable energy. Massive investments in these power plants, which will be located in northern Laos, are expected over the next few years. The facilities are part of the Thai government's attempts to achieve carbon neutrality, a balance between carbon dioxide emissions and absorption. Thai authorities also want to use more clean power to run the economy. The hydropower plants are in line with the memorandum of understanding to import electricity from Laos at a total of 10.9 gigawatts over the next two decades.
- Further diesel excise cut sought, LTFT wants stations to sell 'pure diesel'** BANGKOK POST: The Land Transport Federation of Thailand (LTFT) has called on the government to further cut diesel excise tax and abandon sales of diesel, blended with expensive palm oil-derived methyl ester, for six months to better control domestic diesel prices during the global oil price surge. The Energy Policy Administration Committee earlier decided to reduce the proportion of methyl ester to 5%, down from 7%, as prices of methyl ester went up. Biodiesel 5, known as B5 for a mix of diesel and 5% methyl ester, will be sold as a single-grade biodiesel until the end of March. However, the LTFT wants authorities to have petrol stations sell only "pure diesel" without methyl ester blend for six months. Prices of domestic crude palm oil are currently more expensive than the global market prices, said the federation.

Corporate news

- **Listed companies see profits surge 80% to B986bn in 2021** BANGKOK POST: Thai listed companies recorded a nearly 80% rise in net profit to 986 billion baht in 2021, as rising oil and commodity prices supported related businesses and the government's easing of pandemic restrictions spurred economic recovery. Manpong Senanarong, senior executive vice-president at the Stock Exchange of Thailand (SET), said 757 companies from a total of 780 listed on the SET and Market for Alternative Investment (MAI) have submitted their annual financial performance reports. He said that of 757 companies, 592 companies have recorded net profits, representing 78.1% of the listed companies that submitted their financial statements. Companies that reported high growth in net profits last year were mostly those in commodity-related industries such as energy, petrochemicals, steel and transportation (waterways), healthcare and medicine-related businesses such as rubber glove manufacturers, and businesses in fast-recovering industries including electronic components, industrial materials, and automotive, said Mr Manpong. Overall, SET-listed companies recorded total sales worth 13.13 trillion baht, up 23.1% year-on-year, with core operating profits of 1.56 trillion baht, an increase of 68.3% from the previous year. The average operating profit margin and net profit margin were at 11.9% and 7.5%, respectively. Compared with 2019, the year before the pandemic started, listed companies have delivered better financial performances in 2021 with increases in sales, core operating profits and net profits, while their profit margins also bounced back to 2019 levels. Meanwhile, companies on the MAI reported a 38.9% rise in operating profits to 10.76 billion baht and a 273.6% increase in net profits to 8.44 billion baht.
- **Sizzler set to raise prices, Pandemic, Ukraine war push up costs** BANGKOK POST: SLRT, the operator of Sizzler steak restaurant under The Minor Food Group Plc, is poised to increase prices of some items by 5-10% today as operating costs continue increasing as a result of the prolonged Covid-19 outbreaks and the Russia-Ukraine conflict. Kreetakorn Siriatha, the company's general manager, said operating costs have risen continuously over the last 3-4 months. Prices of vegetables, for instance, doubled since the end of last year while those of pork, chicken and dairy products started increasing early this year.
- **Betong airport welcomes first commercial flight** BANGKOK POST: The newly opened Betong airport welcomed its first commercial passenger flight shortly after noon on Monday. Flight DD6260, a Nok Air service from Bangkok, was welcomed at a ceremony presided over by Prime Minister Prayut Chan-o-cha. He was accompanied by his deputy, Anutin Charnvirakul and Interior Minister Anupong Paojinda.
- **Self-built homes hit by cost hike** BANGKOK POST: Prices of self-built homes will rise 5-8% after the Russia-Ukraine conflict pushed up prices of metals and fuel by more than 50% in less than a month, according to the Home Builder Association. Woravut Kanjanakul, the association's president, said metal prices, which account for 20% of the cost of home construction had risen by 50% since the war started three weeks ago. "Nickel is a metal which had the highest jump in price with a surge of 60%," he said. "It represents around 20-30% of system works like electricity."
- **Mastercard gears up for digital currency payment, Company devoted to providing choices** BANGKOK POST: Payments technology company Mastercard has been working closely with related parties everywhere, including Thailand, to prepare for the future of payments in which digital currencies will be a critical choice for consumers, said Aileen Chew, country manager of Mastercard for Thailand and Myanmar. Regarding Mastercard's vision for Thailand in terms of the future of payments, Ms Chew said that Mastercard's business starts and ends with people. People want to choose a payment method that's right for them -- and what's right might differ with each transaction. "What doesn't change is that people want choice in how they pay, and they want every transaction to be convenient, easy to use, safe and secure," she added. "That has been the centre of our strategy for several years now -- giving people choice in how they want to pay -- in a fast, convenient and secure way."
- **Thai Vietjet eyes 8 new planes for fleet** BANGKOK POST: Thai Vietjet (TVJ) will be ready to add eight new aircraft this year if the Chinese market returns by the fourth quarter, in the airline's best-case scenario. It also aims for annual revenue growth of 20-30% in the next five years, under the assumption that air travel starts to pick up from its pandemic low. Woranate Laprabang, TVJ chief executive, said fleet expansion is based on different scenarios, particularly borders reopening in Southeast Asia and East Asia. At least four aircraft will be added to the current 16-aircraft fleet, in which each jet has 8-9 hours of utilisation per day, a dip from over 10 hours prior to the pandemic.
- **Imminent IPO expected for enabler aCommerce** BANGKOK POST: Southeast Asian e-commerce enabler aCommerce aims to launch its initial public offering (IPO) this year while expanding into Vietnam to capture the burgeoning regional online shopping market, expected to be close to US\$130 billion in value by 2025. "We expect the IPO sometime this year," said Paul Srivorakul, aCommerce group chief executive. "We have spent nine years growing the business over five countries in Southeast Asia and invested 80 million baht to invest in technological capability." The company now has a business presence in Thailand, Indonesia, Malaysia, the Philippines and Singapore. It has 168 customers, 13 of which are global top-100 brands. In 2021, it handled 8 million order transactions with an end-to-end merchandise value (EMV) of 10.1 billion baht. Asean's e-commerce gross merchandise value (GMV) is expected to reach \$129.2 billion in 2025 with a compound average growth rate of 19.8% from 2020. In 2025, e-commerce in the region is expected to account for 21% of total retail, up from 11% in 2020 and 2.1% in 2016.
- **Thai chicken factories win Saudi export approval** BANGKOK POST: After 18 years of suspended exports, 11 Thai chicken factories have been given permission by Saudi Arabia to export chilled and frozen fresh chicken, effective as of March 13. According to Commerce Minister Jurin Laksanawisit, on March 13 the commercial ambassador in charge of the Saudi market and a charge d'affaires of the Thai Foreign Affairs Ministry met with senior executives of the Saudi Food & Drug Authority and agreed that Saudi Arabia would allow chicken imports from 11 factories in Thailand. The move came after Saudi authorities inspected those factories last year.

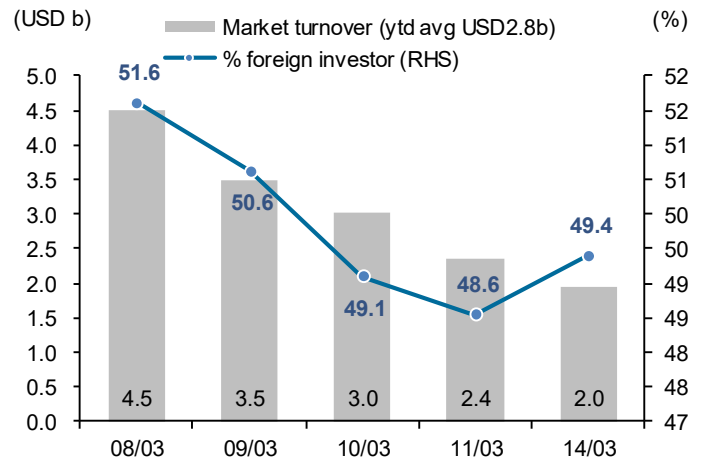
- **State ramps up Mideast fruit exports** BANGKOK POST: The government looks set to ramp up fruit exports to the Middle East this year and is speeding up talks with its Chinese counterpart to help facilitate fruit exports after China's zero-Covid policy has taken a heavy toll on Thai fruit exports, especially durian. According to Rachada Dhnadirek, a deputy government spokeswoman, the government through the Agriculture and Cooperatives Ministry is aiming this year to expand fruit shipments to Middle Eastern countries such as Saudi Arabia and the United Arab Emirates where there is high demand for Thai fruits such as rambutan, mangosteen, longan, mango and durian.
- **Vongsayam bid given green light** BANGKOK POST: Eastern Water Resources Development and Management Public Co or East Water has held the current concession since 1994. The Treasury Department called for a new round of bidding ahead of the current concession's expiration in 2023. The new concession has a term of 30 years.
- **Krungsri Consumer preps new digital personal loan** BANGKOK POST: Krungsri Consumer, the unsecured loan unit under Bank of Ayudhya (BAY) that uses the marketing name Krungsri, plans to offer a new digital personal loan product for customers to enable them to purchase goods first and pay the loan later. The new product, called Buy Now Pay Later (BNPL), will be available on Krungsri Consumer's UChoose mobile app. Krungsri Consumer's new product will allow customers to buy goods first and will then request a loan installment from the customers around one to two months later. The new product will focus on goods with smaller ticket size and a longer period of loan installments, compared with existing loan installments via credit cards. However, Krungsri Consumer has yet to finalise the conditions of BNPL, said Nayanee Peaugkham, chairwoman of Krungsri Consumer. Krungsri Consumer has received a digital personal loan business licence from the Bank of Thailand and prepared to launch several new digital loan products on the UChoose app around the middle of this year.
- **PTTEP to operate Myanmar gas field after TotalEnergies exit** BANGKOK POST: Thai oil and gas giant PTT Exploration and Production Plc said on Monday it would take over operations of the Yadana gas field in Myanmar from July following the exit of France's TotalEnergies. Oil majors Chevron and TotalEnergies in January withdrew from Myanmar citing worsening humanitarian conditions following last year's coup. PTTEP in a statement said it "recognises that equitable access to energy is a fundamental human right that all people are entitled to". "After the decision of TotalEnergies to withdraw from Yadana project, PTTEP has thoroughly considered to take a step as the successor operator in order to ensure the no interruption of natural gas supply," it said. Myanmar has been in turmoil since the army overthrew an elected government in February 2021 and used lethal force to suppress protests against its rule.
- **Nectec head targets national AI strategy** BANGKOK POST: After being recently reappointed executive director of the National Electronics and Computer Technology Center (Nectec), Chai Wutiwiwatchai has vowed to usher in a national strategic plan for artificial intelligence (AI) usage and explore new tech frontiers, such as terahertz, quantum computing and the metaverse, to drive the country forward. "Our mission is to build upstream digital technology as a core foundation for the country," Mr Chai, who was originally appointed Nectec executive director in 2018, told the Bangkok Post. His position is for a four-year term. Nectec is a state organisation responsible for undertaking, supporting and promoting research and development (R&D) of electronics and computer technologies. Mr Chai was the first Nectec executive director who came from the top job at Nectec's research unit, and not from the office of deputy executive director.
OUR DEVELOPMENT FIELDS: The AI plan consists of four areas. The first is to develop hard and soft infrastructure, covering high-performance computing, AI service platforms, government cloud and AI ethics. The second is to create 30,000 AI engineers within six years. The third area concerns R&D for AI, such as the further development of the "AI for Thai" Thai AI service platform. AI For Thai can be developed to analyse rice leaf images for plant disease in the farming sector and medical diagnosis for the healthcare sector. It can be developed as "AI for PA", or AI for performance audit to support the work of the State Audit Office. The fourth area involves the use of AI to power startups through collaboration with the National Innovation Agency, with priorities in health, food and agriculture, government services and digital solution fields. According to Mr Chai, AI can be used to support the work of the Revenue Department, analyse policy outcomes, and evaluate projects.
