ADVANCED INFO SERVICE (ADVANC TB) - Expect a soft 1Q22; Maintain BUY TP THB260.00

Slower core service revenue growth on the way in 1Q22

We expect ADVANC's mobile revenue in 1Q22 to drop slightly to THB29.2b (-1.4% q-q, -0.6% y-y). Mobile subs should continue to grow thanks to aggressive new sub acquisitions from its competitors who are still focused on merger talks. However, we think mobile average revenue per user (ARPU) should decline due to the remaining competition, Covid, and inflation. We expect other revenue from enterprise and fixed broadband to grow continuously, bringing ADVANC's service revenue down slightly to THB36.6b (-6% q-q, +1% y-y). Note that in 1Q22, there was a q-q slowdown in handset sales following the high season. Thus, we expect ADVANC's 1Q22 revenue to drop by 10.3% q-q to THB45.2b.

Higher cost pressure to hit profit

ADVANC should report higher operating costs mainly from network OPEX that should continue to increase due to its 5G network expansion. Moreover, its SG&A should grow y-y due to the strong marketing campaign backing its mobile sub acquisition strategy. As a result, we expect ADVANC's core profit in 1Q22 to slip to THB6.5b (-2.4% q-q, -5.1% y-y).

Catalysts from new ventures should take time to bear fruit

The data centre with Singtel and Gulf Energy Development (GULF TB, BUY, TP THB60) is still in the JV setup stages. AISCB, the digital financing business with Siam Commercial Bank (SCB TB, BUY, TP THB160), is in the process of getting licensing approval from the Bank of Thailand. We think this means that the new catalysts based on their new businesses should take more time to bear fruit, possibly in 2Q22.

Maintain BUY with the same TP of THB260

Given the slower earnings outlook in 1Q22, which may continue into 2Q22, due to Covid, inflation, and high competition, we see the potential for slower growth in ADVANC's share price performance after a strong 1Q22. However, in the longer term, we still like ADVANC due to its potential to gain more mobile subs from competitors during the merger process. If the company can continue to acquire more subs in the next six months, we believe this could be its key driver in the future. For this reason, we maintain BUY with the same TP of THB260.

Bangkok Airways (BA TB, BUY, TP THB16) – Set up the REIT to buy Samui Airport

- BA announced yesterday to establish REIT which will invest in the leasehold right of some assets used in the operation of Samui Airport (Runway, Apron, building)
- We have an update with management. BA expect the term and condition of this REIT would favor to BA compared to SPF. First, BA plan to pay only fixed payment to REIT, unlike SPF that BA paid both fixed and variable. This mean the upside of Samui Airport would belong to BA. Second, BA can continue to renovate Samui Airport and the upside from non-aero revenue (commercial space) would belong to BA
- Timeline to divest Samui Airport to REIT is scheduled by 3Q22. BA would use the proceed to repay its debt (c5% interest expense) and prepare for U-Tapao project
- At this stage, we see this deal as neutral. It would not have impact to our SoTP TP given that we value Samui Airport at THB22b and we believe the value size of REIT have a high potential to exceed our value (Note that BA terminate leased contract for SPF with THB18b fee)
- The deal would turn positive if BA divest Samui Airport with value more than THB22b and manage to pay fixed payment less than THB1.6b per year (Payment to SPF in 2019) by 20-30%. This would implies BA can unlock Samui Airport value, while keep the upside of Samui Airport with them





Exhibit 3: Global by new cases and deaths



Daily New Deaths in Thailand




- 'Epidemic' status still some way off: expert** BANGKOK POST: The kingdom is expected to record about 100,000 new Covid-19 cases per day following the Songkran holiday, according to Dr Prasit Watanapa, dean of Siriraj Hospital's medical school under Mahidol University. According to government figures, 50–60% of Covid-19 patients who died in the past 30 days were unvaccinated, while 30% received a second dose more than three months before and 5–10% had been inoculated with a single dose.
- Nok Air offers charter flights to Betong** BANGKOK POST: Nok Air has joined hands with three business allies to provide charter flights from Bangkok to Yala's Betong district for three months starting from April 29. On Friday, Nok Air signed a memorandum of understanding with Tangmo Tour Co, CCT Group, and the Thai Tourism Promotion Association to provide the Bangkok-Betong flights. The move was supported by the Tourism Authority of Thailand, Betong airport, the Betong municipality, and local restaurant and business operators in Betong. On March 14, Nok Air inaugurated a regular service with a flight from Don Mueang to Betong carrying Prime Minister Prayut Chan-o-cha and other dignitaries, with the prime minister officially opening the airport for commercial services.


- **BAAC to help farmers hurt by rising price of fertilizer, Bank to propose option to board** BANGKOK POST: The Bank for Agriculture and Agricultural Cooperatives (BAAC) has mulled two options to ease the burden on farmers caused by rising chemical fertiliser prices, says bank president Tanaratt Ngamvalairatt. He said the BAAC will propose one of the options for the bank board's consideration this month. Mr Tanaratt said the first option is to waive interest on loans for buying chemical fertiliser for two years, with the bank asking the government to take responsibility for this interest. The other option gives farmers a two-year grace period on loan repayment, with instalments starting the third year and running until the fifth year.
- **Bol speeds up rejig of incentives, Aim is to align them with global changes** BANGKOK POST: The Board of Investment (Bol) is accelerating the revision of investment incentives to align them with global changes and offset the impact of the new world tax regimes proposed by the Organisation for Economic Co-operation and Development (OECD). According to Duangjai Asawachintachit, Bol secretary-general, investment incentives need to be rejigged to retain Thailand's investment competitiveness after members of the OECD last October took a decisive step towards forcing the world's biggest companies to pay their fair share of tax. The plan is for a global minimum corporate tax rate of 15% to be imposed by 2023. The requirement is for companies that have revenue worldwide of at least €750 million per year.
- **Tourism banking on digital realm, New technology offers hope for ailing industry, writes Dusida Worrachaddejchai** BANGKOK POST: The Covid outbreak has been a catalyst for disrupting the tourism and digital landscapes, hastened when social media giant Meta (formerly Facebook) announced a rebranding towards the metaverse last year. The metaverse frenzy created a great amount of global hype, but it is still too early to predict how this trend will play out once people become more aware of it. In addition to the gaming industry, the tourism supply side and destinations such as Seoul and Barbados have already jumped on the metaverse bandwagon by embracing technology to serve this new digital trend.
- **Interest-Rate Surge Starts to Ripple Through U.S. Economy, Fed's moves to chill inflation drive up bond yields and many other borrowing costs linked to them** BANGKOK POST: The market is finally getting the message that the era of cheap money is ending. Just look at mortgage rates. At the beginning of 2022, the average interest rate on a 30-year mortgage hovered above 3%. Today it stands at 4.72%, according to Freddie Mac. That translates into sharply higher borrowing costs for Americans looking to buy a home -- and it is only the beginning. For the better part of the past 15 years, households and businesses paid very little to borrow. Americans could get cars and homes and the appliances to fill them at interest rates in the low single digits. Companies, especially profitable ones, could practically name their price in the credit markets.

Corporate news

- **Haier eyes B16bn Thai sales** BANGKOK POST: Haier (Thailand) Co, the manufacturer and distributor of Haier home appliances, wants to double its domestic sales to 16 billion baht in three years. To achieve this lofty plan, the company divided its business unit into four brands to provide clear services to each customer segment. The Haier brand serves general customers, while the Yudee brand caters to consumers who prefer monthly instalments. The Candy brand targets Gen Y and Gen Z customers. The fourth brand has not been disclosed as the company plans to launch it in the second half of this year.
- **GBX offers new services in digital transformation** BANGKOK POST: SET-listed Globlex Holding Management (GBX), a holding company and gold trader, plans to launch services related to digital assets and new products to support all kinds of investment in 2022. Tharaphut Kuhapremkit, managing director of GBX, said the company is undergoing a digital transformation to enhance competitiveness and build on new business models to meet investment needs in the digital world and cover all customer groups through affiliated companies. GBX is also studying the feasibility of providing digital asset-related services and foreign brokerage services, including launching fractional shares of global stocks to give investors a chance to gain higher returns. He said fractional shares will allow investors to easily diversify into foreign stocks and receive higher returns.
- **NBTC supports training for people in need** BANGKOK POST: The National Broadcasting and Telecommunications Commission (NBTC) is working with the Department of Skill Development (DSD) and Disabilities Thailand (DTH) to conduct digital skills training for the underprivileged and people with disabilities to support their career opportunities and improve their quality of life. The target is to reach 40,000 trainees in two years. The NBTC signed memorandum of understanding agreements for cooperation with the two parties on Friday. The move is in line with the NBTC's second plan under its universal service obligation scheme, including supporting digital skill-building for 500,000 underprivileged people to enhance their career journey.
- **CKP to build hydropower plant near Luang Prabang** BANGKOK POST: CK Power Plc (CKP), the power generation arm of construction firm CH Karnchang Plc, expects to start building a new hydropower plant near Luang Prabang on the Mekong River in northern Laos as it joins the global trend of focusing more on clean energy. The project faced a two-year delay caused by the Covid-19 pandemic. The company recently signalled it is preparing for the construction by announcing to its shareholders a bank guarantee worth 98.1 million baht granted for the project, which will be developed and operated by CKP subsidiary Luang Prabang Power Co.
- **Centara Osaka debut slated for July 2023** BANGKOK POST: Centara Hotels & Resorts has confirmed a July 2023 opening date for Centara Grand Hotel Osaka. Thirayuth Chirathivat, the group's chief executive, was recently in Japan for the project's topping-off event alongside executives from Centara's partners: Taisei Corporation and Kanden Realty & Development. Mr Thirayuth made time to visit the site of the hotel on Namba Street. Construction is progressing, with a 35-storey structure completed as work nears the halfway point on the time table.
