Economic news

■ Bank of Thailand raises key interest rate BANGKOK POST: The Monetary Policy Committee (MPC) yesterday voted unanimously to raise the policy rate by another 25 basis points, from 1% to 1.25%, effective immediately. The Bank of Thailand (BoT) raised its key interest rate by 25 basis points for a third straight meeting on Wednesday, as it tries to contain above-target inflation while supporting an economic recovery facing increasing global headwinds. The Bank of Thailand believes the country's economy will take off in the final quarter of this year and return to pre-pandemic growth levels. Mr Piti said the Thai economy is projected to grow by 3.2% in 2022, 3.7% in 2023 and 3.9% in 2024. The central bank cut the growth outlook slightly for 2022 and 2023 from a previous assessment of 3.3% and 3.8%, respectively.

- Factory output unexpectedly falls as factories close BANGKOK POST: Thailand's manufacturing production index (MPI) in October dropped 3.71% from a year earlier, due to weaker exports and refinery maintenance shutdowns, the Industry Ministry said on Wednesday. The figure compares with a forecast rise of 1.2% in factory output for October in a Reuters poll, and after September's revised 3.34% rise year-on-year.
- 1st phase of U-tapao revamp faces delay BANGKOK POST: The first phase of the new U-tapao international airport is likely to face a delay of two years because of the pandemic's impact, according to U-Tapao International Aviation Company Ltd (UTA). The first phase could be finished in 2026 as the company has to adjust the construction process because of a lower growth rate of passengers during the pandemic, said Puttipong Prasarttong-Osoth, president of Bangkok Airways and a representative of UTA. The first phase was previously supposed to be completed in 2024 with a carrying capacity of 15.9 million passengers a year, featuring a 157,000-square-metre terminal, 60 airplane parking lots, commercial space and a ground transportation centre.
- 6 firms pick up satellite bid forms BANGKOK POST: Six companies have picked up bid documents for the satellite
 orbital slot auction as the process concluded on Wednesday, says the National Broadcasting and Telecommunications
 Commission (NBTC).
- Car manufacturers expect election to improve sentiment BANGKOK POST: Automakers in Thailand expect the
 general election next year will generate better sentiment, causing people to buy new cars, even though the industry has
 slowed since October this year.

- Sweet Meet to extend palm oil sales to consumers BANGKOK POST: Sweet Meet (Thailand), the producer of Ploen vegetable cooking oil for clients, looks set to expand into palm oil for consumers next year.
- Tourism trade braces for more headwinds BANGKOK POST: The tourism industry has to brace for uncertainties from domestic politics and pressure from geopolitical conflicts amid higher competition next year, forcing the public and private sectors to work together.
- China-Laos Railway boosts travel, promotes tourism in Laos BANGKOK POST: VIENTIANE: The China-Laos Railway
 has significantly bolstered passenger transportation, greatly facilitated travel, and helped promote tourism in Laos since its
 launch in December 2021.
- AirAsia parent narrows Q3 loss on strong demand recovery, upbeat outlook BANGKOK POST: Capital A Berhad, the
 parent of Malaysian budget airline AirAsia, reported a narrower third-quarter operating loss on Wednesday, buoyed by a
 strong rebound in travel demand and the easing of pandemic-related restrictions in Southeast Asia.
- IRPC expects petrochemical prices to rise BANGKOK POST: IRPC, the petrochemical arm of national oil and gas
 conglomerate PTT Plc, expects prices of petrochemical products, which hit a 10-year low, to increase early next year as
 Covid-19 eases.
- Elon Musk's Apple Attack Sets Stage for Public Spat BANGKOK POST: Elon Musk's onslaught Monday against Apple Inc. and a cornerstone of the iPhone empire has set the stage for a potentially bruising battle between the world's richest man and the world's most valuable company.
- Frozen product registrations surge 84% BANGKOK POST: Entrepreneurs have flocked to invest in the frozen food segment, with new registrations rising by 84% in the first nine months, driven by rising domestic and export demand.
- IBM puts new focus on sustainability BANGKOK POST: IBM Thailand, a local operating unit of the global technology firm, has emphasised the importance of sustainability among es that can be powered by hybrid cloud and artificial intelligence (AI) for growth.
- **E-commerce: Prep for the peak season** BANGKOK POST: Black Friday has come and gone, and as any online knows, especially in North America, it marks the start of a very lucrative sales period. But this year, the e-commerce sector is contending with unprecedented global inflation, unstable supply chains and new consumer buying behaviour.

Exhibit 1: Foreign fund flow and SET Index




Exhibit 2: Foreign participation
