
## **Economic news**

- Foreign investors deterred by financial transaction tax BANGKOK POST: Enforcement of the financial transaction tax could give foreign investors a reason to exit the Thai stock exchange and focus on other bourses, according to investment analysts.
- New Year spending to hit B103bn BANGKOK POST: Consumer spending during the New Year holiday is expected to reach 103 billion baht, pushed by the country's continued economic recovery from the pandemic. That would be a record 20% jump from about 86 billion baht spending during the previous New Year period, UTCC president Thanavath Phonvichai told a briefing on a consumer survey. "It'll be an active New Year," he said, adding the economy would return to normal in 2023.
- Lenders demand access to utility bill data BANGKOK POST: The Thai Bankers' Association (TBA) plans to continue its push for the incorporation of data from utility bills into the National Credit Bureau (NCB) database as an alternative source for banks to consult when extending loans to the underbanked segment.
- TAT estimates 3.14m domestic trips BANGKOK POST: The Tourism Authority of Thailand (TAT) forecasts domestic tourism to tally 3.14 million trips during the New Year holiday, generating 11.2 billion baht, with the northern region posting the highest occupancy rate at 78%.

- GSB unit unveils loan based on land pledge BANGKOK POST: Mee Tee Mee Ngern, a Government Savings Bank (GSB) subsidiary, aims to extend land collateral loans worth 10 billion baht next year, says chief executive Isara Wongrung.
- BLS upbeat on Thai stock market rebound next year BANGKOK POST: Bualuang Securities (BLS) is bullish on the Thai stock market outlook next year as the local economy is on the recovery path while inflation and interest rates are starting to moderate.
- SKE expects 2023 revenue to near B1bn BANGKOK POST: SET-listed Sakol Energy (SKE), a compressed natural gas
  trader and biomass power plant operator, expects revenue to soar to almost 1 billion baht next year, driven by demand for
  refuse-derived fuel to support carbon dioxide emission reduction.
- Pricey low-rise sector grows BANGKOK POST: Demand for high-priced low-rise houses continued to grow for two
  consecutive quarters, with market value in the third quarter soaring by 58% from the second, while developers launched
  new supply in this segment.
- **Muji adjusts strategy to reach Thai buyers** BANGKOK POST: Muji Retail (Thailand) Co, the homewear and lifestyle retailer, has fine-tuned its business strategies to reach more Thai customers and drive its sales growth in the longer term.
- PTT sets out stance on Myanmar after fund exit BANGKOK POST: PTT Group has clarified its stance amid violence in Myanmar, which reportedly led to the withdrawal of an investment fund from its subsidiary PTT Oil and Retail Business Plc (OR), which is operating a petroleum business in the country.
- Ross Digital keen on robotics expansion BANGKOK POST: Ross Digital, a Singapore-based robotics and automation startup for the food and beverage (F&B) industry, plans to set up a robotic service arm assembly line in Thailand to serve the country's growing market and ensure an effective supply chain.
- The End of Netflix Password Sharing Is Nigh BANGKOK POST: The end of password sharing is coming to Netflix soon -- and it will be a challenge for both viewers and the streaming giant.
- BGRIM adds South Korean wind farms BANGKOK POST: B.Grimm Power Plc (BGRIM) has bolstered its overseas investment in renewable energy by establishing partnerships and taking partial stakes in four wind farm projects in South Korea.
- Ericsson, Depa push 5G transformation BANGKOK POST: Ericsson and the Digital Economy Promotion Agency (Depa) have signed a memorandum of understanding (MoU) to accelerate 5G-based digital transformation in Thailand.
- Bad energy habits sweeping the world BANGKOK POST: A new survey of 6,000 homeowners and renters from across the globe has revealed nearly 9 in 10 people ignore what's best when it comes to energy efficiency in the home, despite 80% saying they know how to use their household appliances in an energy-efficient way.
