
## Economic news

- [Malaysia caps retail rice sales](#) BANGKOK POST: KUALA LUMPUR: Malaysia will limit retail purchases and step up enforcement to prevent locally produced rice being sold as the more expensive imported grain, as the fallout from Indian export curbs continues to upend the market.
- [Drought to cut sugar output by almost 20%](#) BANGKOK POST: The country's sugar output will drop by almost a fifth in the upcoming harvest due to a severe drought which will lead to further tightening in the global market, according to Thai Sugar Millers Corp. Production will fall by 18% to around 9 million tonnes in the 2023-24 season, said Rangsit Hiangrat, director of the industry group. Extreme heat and dryness will probably become worse in the coming years, he said on Thursday.
- [Minister seeks air force flight slots to boost tourism](#) BANGKOK POST: Transport Minister Suriya Jungrungreangkit plans to acquire some flight slots from the air force to serve growing demand from airlines to boost tourism. Mr Suriya said on Thursday that that he learned from Airports of Thailand that the air force had many unused flight slots at the country's airports. He subsequently asked Defence Minister Sutin Klungsang to look into allocating some of the unused slots to commercial flights.
- [Vietnam to sign inter-government rice pact with Philippines](#) BANGKOK POST: HANOI - Vietnam will soon sign an inter-government agreement on the rice trade with the Philippines to help the countries ensure food security, its government said in a statement on Thursday.
- [Chinese yuan strengthens in August](#) BANGKOK POST: BEIJING: Chinese yuan strengthened against a basket of currencies in August, according to the China Foreign Exchange Trade System (CFETS). At the end of last month, the CFETS yuan exchange rate composite index, which measures the yuan's strength relative to a basket of currencies, edged up 0.34 percent from the end of July to 97.14, according to the system.
- [New minister pledges to prioritise cost of living, prices](#) BANGKOK POST: Phumtham Wechayachai, the newly appointed commerce minister, has pledged to address the cost of living and ensure product prices are in line with production costs as his top priorities. In addition, he wants to accelerate initiatives aimed at discovering new export markets and ramp up trade negotiations to enhance opportunities for Thai shipments.
- [DES Ministry vows to tackle online fraud](#) BANGKOK POST: The Digital Economy and Society (DES) Ministry promises to establish a centre to monitor and track suspicious financial transactions by the end of this year as a new tool against rampant online fraud and call centre scams, says DES Minister Prasert Jantararungtong.
- [Call for measures to prop up Thai steel](#) BANGKOK POST: The Iron and Steel Institute of Thailand is calling on the Srettha Thavisin government to bolster the local steel industry, which plays a key role in helping build national security and reduces dependence on imports.


- [JKN founder admits to 'forced selling' of shares](#) BANGKOK POST: The founder and largest shareholder of JKN Global Group says she sold nearly 100 million shares of the Miss Universe Organization operator through "forced selling" to comply with the margin accounting rules of the Stock Exchange of Thailand (SET) after its share price dropped by more than 50% in one week.
- [Ttb decides not to raise its rates for now](#) BANGKOK POST: TMBThanachart Bank (ttb) has no plans to increase interest rates on loans following the latest policy rate hike by the central bank last month, aiming to support the debt payment ability of retail customers. The bank chose to maintain its interest rates after the Bank of Thailand's Monetary Policy Committee (MPC) increased its policy rate by 0.25 percentage points in August.
- [THAI explores acquiring 'up to 95 new jets'](#) BANGKOK POST: Thai Airways International is in talks with Boeing and Airbus for a plane order potentially involving more than 90 jets as it pursues restructuring and gears up for booming travel markets, industry sources have told Reuters.
- [Clover Power eyes profitability in 2024](#) BANGKOK POST: SET-listed Clover Power, a renewable power plant operator and constructor, expects to return to the black on its balance sheet next year as it proceeds with delayed construction jobs and strengthens its power business under the new government. The company posted a loss of 98.5 million baht in the first half of this year, which was attributed to a delay in state construction projects during the long process to establish a coalition government following the May 14 general election.
