CHAYO GROUP (CHAYO TB) - Surprising 4Q23 profit from NPA sales; Maintain HOLD TP THB5.70

4Q23 profit meaningfully beat our and BBG's consensus estimate

CHAYO surprised the market with a 4Q23 net profit of THB120m, up 58.6% q-q and 41.1% y-y. The figure surpassed our forecast and BBG's consensus estimate by 25%. Critical support was from a gain on NPA sales worth THB56m (up 373% q-q and 101% y-y), partially due to the collection of a large-ticket NPA, which contributed cTHB30m to the amount. Meanwhile, 4Q23 NPL cash collection was higher than expected at THB137m, boosting the revenue from the debt management business. The upbeat performance was partially offset by a rising ECL expense of THB133m (up 24% q-q, 85% y-y), which we expect was due to the firm's accelerating acquisition of bad debt during 2H23 (CHAYO's cash collection and ECL projection on loans starts around two quarters after debt acquisition).

2H23 investment to accelerate contributions from 1Q24 onwards

The company's receivable investment in 4Q23 was THB782m, pushing the whole-year figure to finish at THB1.5b, which consisted mainly of unsecured NPLs, in line with our estimate. We expect new acquisitions of unsecured loans to benefit the firm's cash collection performance as soon as in 1Q24 (two quarters after acquisition), but should also result in higher ECL expenses, especially during the low season in the first half of the year.

Expect a q-q drop in 1Q24 results; maintain outlook in 2024-25

We expect a q-q drop in CHAYO's 1Q24 net profit from the absence of large NPA sales vs 4Q23. However, on a y-y basis, the company should be able to yield growth from portfolio expansion in the AMC business. Moreover, we estimate its corporate loan business (CCAP) to contribute more profit for a more extensive portfolio (CCAP loans grew 62% y-y in 2023). As the gain on NPA sales was a significant surprise for its 4Q23 results, the highly volatile nature of the item leads us to maintain our 2024-25 estimates.

Maintain HOLD call at 2024 TP of THB5.70

The stronger-than-expected 4Q23 results from the NPA gain should provide some upbeat movement for the share price in the near term. However, as we view the gain on NPA sales as possessing a high degree of volatility, we put more weight on the company's 2024 performance, in which we have a less favorable view on the industry's outlook following the slowing economy. This justifies our HOLD call on CHAYO with our GGM-based 2024 TP at THB5.7, implying a P/BV ratio of 1.63x.

ICHITAN GROUP (ICHI TB) - RTD green tea still refreshing; Maintain BUY TP THB21.00

Management remains confident with growth in 2024

At the latest analyst meeting on 22 Feb 2024, management mentioned that, according to data from AC Nielsen, the ready-to-drink (RTD) green tea market value continued to grow by 20% y-y in January 2024. ICHI plans to launch a product in the energy drink market with its new 'Tan Power' brand, priced at an affordable THB10 in March 2024. Management set its 2024 targets as follows: 1) total revenue growth of 12% y-y to THB9b, of which THB8.5b will come from its own production capacity, and the remaining THB5m will be generated through OEM production; and 2) overall gross margin at 23% (vs 23.4% in 2023).

1Q24 net profit looks promising

We expect ICHI's 1Q24 total revenue to grow 15% y-y and remain high, close to the 4Q23 level. Its 1Q24 gross margin should increase to 24% from 20.8% in 1Q23, but might drop by 50 bps from 4Q23, due to higher sugar costs and the product mix. Tan Power is produced by an OEM manufacturer; hence, its gross margin will be lower than ICHI's current gross margin. We anticipate 1Q24 net profit to grow 8.3% q-q and 44% y-y to THB319m. Even though sugar costs might increase along with domestic sugar prices, they should be offset by lower packaging costs.

Revise up our 2024-25E profit by 8-9%

We revise up our 2024-25 net profit forecasts by 8.2% and 9.5% to grow 7.4% y-y and 6% y-y, respectively. Our new revenue growth assumption at 8.4% y-y is lower than management's target. In addition, ICHI targets 2024 Tan Power revenue of THB300m, accounting for 3.3% of total revenue. If the launch fails, we estimate a limited impact because it is 100% OEM produced, and the expected expense is not high as Mr. Tan, ICHI's CEO, will be Tan Power's presenter.

Retain BUY call with new TP of THB21

We maintain our BUY call with a higher TP to THB21 from THB19, based on 23x 2024E P/E (maintained). We are impressed by its strong balance sheet with high liquidity, no interest-bearing debt, and high ROE of 18.8%. ICHI is preparing to sell vacant land valued at THB360m, which is expected to support its solid financial position and enable it to continue paying high dividend yields to shareholders.





MASTER STYLE (MASTER TB) - Continuing to invest in more deals; Maintain BUY TP THB82.00

Ending 2023 with impressive results

MASTER reported a record high 4Q23 net profit of THB164m (+64% q-q, +108% y-y). We are impressed by the new operating-hour high at 14,316 hours (+13.7% q-q), implying a utilization rate of 73.8% (vs 64.9% in 3Q23). Its 4Q23 gross margin soared to 63.6% from 58.2% in 3Q23, supported by higher operating leverage. The company began to recognize profit sharing from four companies, totaling THB5m. At the end of 2023, MASTER achieved a record high profit of THB416m, an increase of 38% y-y.

Preparing to move to the SET; announced additional deals

The company announced a stock dividend at 1:0.142857, resulting in an increase of 301.71 million shares after the ex-dividend date on 4 Mar 2024. Following this, the company will prepare to apply to move to the SET. In addition, MASTER announced four more investment deals worth a total of THB152m. These include 1) a 20% stake in Aesthelis Code – a medical-grade silicone manufacturer; 2) a 35% stake in Me Center Clinic – a mental health clinic; 3) a 40% stake in Aurora Clinic – a cosmetic surgery clinic with two branches; and 4) a 15% stake in Korawin Holding – Korawin Clinic and Ronnapee Clinic. We expect MASTER to recognize a share profit from these four deals starting from 3Q24 onward.

Revise up our 2024 profit forecast with dramatic growth

We maintain our bullish view of MASTER's 2024 growth outlook due to organic growth, i.e. the full-year realization of its new operating beds and goal to increase foreign customer contributions to c30% of total revenue from 26% in 4Q23. There would also be inorganic drivers, such as the realization of profit sharing from 14 companies. We have increased 2024-25E profit sharing by 19-22% to THB125m and THB137m, representing roughly 20% of the 2024-25E net profit. Thus, we revise up our 2024-25E net profit by 16% and 13% to grow by 49% y-y and 10% y-y, respectively.

Our new TP is THB82 before XD and THB72 after XD

Following the earnings revisions, we revise up our target price to THB82 before XD and THB72 after XD (35x 2024E P/E, maintained). The pre-XD target price has a potential upside of 12.7%. In the short term, we expect its 1Q24 profit to decline due to the low season, while the downside risk is that its share of profits might be lower than expected.





MK RESTAURANT GROUP (M TB) - 4Q23 results at first glance; Maintain BUY TP THB47.00

A surprising 4Q23 net profit

Highlights

- M reported a surprising 4Q23 net profit of THB509m (+31% q-q, +59% y-y), beating our forecast and Bloomberg's consensus estimate by 26% and 43%, respectively, due to lower-than-expected SG&A expenses.
- Its 4Q23 total revenue was in line with our forecast, dropping by 1.3% q-q and 2.6% y-y along with a slower consumption recovery. 4Q23 SSSG turned negative at 3.5% y-y. In particular, it lost more momentum in November before recovering in the second half of December. Also, the company opened only five new branches in 4Q23.
- We are impressed by the high 4Q23 gross margin of 67%, up from 66.7% in 3Q23 and 65% in 4Q22 thanks to the lower pork price.
- SG&A expenses declined by 8.7% q-q and 7.9% y-y, due to lower-than-expected employee expenses. We note that it may have been caused by the reversal of accrual bonus expenses and declining electricity expenses. SG&A to sales decreased to 53.3% in 4Q23, down from 57.6% in 3Q23 and 56.3% in 4Q22.
- M's 2023 net profit was equal to THB1.68b (+17% y-y). The company announced a 2H23 DPS of THB1, implying a dividend of 2.7%.

Outlook


- Preliminarily, we expect its 1Q24 net profit to accelerate y-y because of the low base in 1Q23, but gradually recover q-q. The slow q-q growth would mainly come from the higher electricity prices, and M did not join in the E-Receipt campaign.
- However, total revenue should surpass the pre-Covid level from 2024 onwards. Since inflation has passed its peak, we remain optimistic that purchasing power will gradually recover in 2024.
- We maintain our 2024E net profit of THB1.76b, growing slightly by 4.3% y-y. Retain our BUY call with the same target price of THB47 (25x 2024E P/E, maintained).



Exhibit 11: Quarterly SSSG





Exhibit 13: Total revenue and growth





MEGA LIFESCIENCES (MEGA TB) - 4Q23 profit beats with record sales; Maintain BUY TP THB56.00

4Q23 profit beats with all-time revenue high

MEGA reported a net profit of THB473m in 4Q23 (-12% q-q, +18% y-y). Excluding a hefty forex loss and other extra items, the firm had a very strong core profit of THB621m (+18.2% q-q, +20.4% y-y), the second- best quarter in at least ten years, beating our estimate by 8% and Bloomberg's consensus by 16%. This was attributable to the record revenue of THB4.2b (+9.3% q-q, +7.0% y-y), driven by both the Mega We Care brand and the distribution business. The blended gross margin was stable q-q at 45.8% in 4Q23. SG&A expenses were well-controlled. Interest expenses declined after the company paid down its debt. Its fiscal status remains healthy with net D/E at 0.3x and IBD/E at 0.01x.

Overall performance in 2023 was flat from high base in 2022

The full-year 2023 core profit was another story. The overall revenues were flat for both the branded and distribution units. 2022 was a high base for its branded business, while the company lost one of its distribution business clients in Myanmar since 1Q23. The 2% y-y increase in core profit was a result of the slightly improved gross margin and decreased SG&A expenses. MEGA declared a dividend payment of THB0.80 apiece, representing a payout ratio of 70%; much higher than its policy of at least 25% of net profit to compensate for its low profit growth.

Maintain our profit projections in 2024-26

In 2023, MEGA reported a huge forex loss of THB707m, c70% of which was from the depreciation of the Nigerian naira. Currently, the naira has plunged almost 80% further since the beginning of 2024, indicating an additional forex loss in 1Q24, although some of it will be unrealized. We like MEGA for its strong brand, diversified markets and healthy finances. We believe MEGA can grow its profit consistently at 5% CAGR in 2024-26 with an improved net profit margin to 15.1-15.3%; higher than 10.2-11.8% during the pre-Covid period.

Maintain our BUY rating

MEGA shares are good for long-term investment due to its resilient business, in our view. We retain our BUY rating for MEGA with the same TP of THB56 (8.2% WACC, 3.5% LTG). This implies 20x 2024E P/E, equal to its five-year average.

Exhibit 15: Revenue structure by business unit






Exhibit 16: Margins and core profit


Exhibit 17: Revenue projection

SISB (SISB TB) - Profit hit a record high in 4Q23; Maintain BUY TP THB42.00

SISB achieved a record quarterly profit in 4Q23 as expected

SISB had a record performance in 4Q23 after its two new schools in Nonthaburi and Rayong operated for a full quarter. Net enrollments in 4Q23 added another 72 students, bringing the total number of students to 4,197 at end-2024. Revenue from tuition fees and education equipment income in 4Q23 surged 18% q-q and 45% y-y to THB564m, with a wider gross margin at 53.8%. With the higher number of students, the reduced loss from new schools, and the absence of a one-time expense as incurred in 3Q23, 4Q23 net profit hit a record high of THB211m (+64% q-q and y-y), with a net margin of 37.3%, in line with our expectation.

Excluding losses from new schools, 2023 profit soared 95% y-y

SISB opened two new schools in August 2023. The Nonthaburi campus turned profitable at THB4m in 4Q23 from a net loss of THB38m in 3Q23, with total students numbering 277 at year-end, representing a utilization rate of 26.6%. The Rayong campus with a total of 108 students or an 11.6% utilization rate posted a smaller loss of THB11m in 4Q23 from a net loss of THB25m in 3Q23. Excluding losses from new schools, SISB would register a net profit of THB217m in 4Q23. The full-year profit would be THB718m (+95% y-y), excluding losses from new schools.

Expect Nonthaburi to be profitable in 2024 and Rayong in 2025

In 2023, SISB recorded 77% net profit growth as 100% on-site learning resumed and new schools opened. Although the new schools contributed a net loss of THB65m in 2023, we expect Nonthaburi campus to continue its momentum in 2024, while Rayong campus should reach its break-even point in 2025 once it reaches almost 300 students.

Maintain profit growth forecast and TP of THB42


The expansion continues; the second half of Pracha Uthit's renovation is scheduled for completion by August 2024 (+150 seats), Chiang Mai phase 2 by 1Q24 (+300 seats), and Thonburi phase 3.1 by 3Q24 (+600-900 seats). We maintain our profit growth projections of 36%/18%/17% in 2024-26 based on an incremental c400 students a year. We maintain our DCF-based 2024 TP at THB42 (8.2% WACC, 5% LTG), implying 44x 2024E P/E, and reiterate our BUY call on SISB.



Exhibit 20: Net enrollments and accumulated students





Exhibit 22: Student numbers by campus





Exhibit 24: Revenue and margins





Exhibit 21: Total students and net profit





Results Comments

CENTEL (BUY, TP THB50) - booked 4Q23 core profit of THB297m, missing our estimate

4Q23 earnings highlight

CENTEL reported 4Q23 core profit of THB297m (+302% q-q, -40% y-y), missing our estimate by 19% mainly due to THB135m deferred tax expenses related to a reduction in loss carryforward. Excluding deferred tax expenses, core profit would be THB432m, beat our estimate by 17%.

 CENTEL booked THB128m reversal of impairment on assets following significant improvement in the performance of Centara Grand at Central Plaza Ladprao. Thus, net profit was THB425m

Hotel business

- Hotel Revenue grew by 20% y-y driven by RevPAR of Thai hotels (+18% y-y) and Dubai hotel (+13% y-y). On the negative note, RevPAR of Maldives hotels fell by 5% y-y due to a decrease in the key customer from India. RevPAR of Japan hotel grew by 32% q-q with strong OCC rate of 77%.
- EBITDA margin of hotel business decreased to 34% (vs 38% in 4Q22) due to the impact of the 2 major renovations (Karon and Mirage Pattaya) and low margin during ramping-up of Osaka hotel
- Hotel business booked smaller core loss of THB172m in 4Q23 (vs THB360m loss in 4Q22) due to lower EBITDA margin, higher interest expenses and deferred tax expenses of THB135m.

Food business

- Food business revenue grew by 4% y-y thanks to 2% y-y SSSG and 3% y-y outlet expansion
- EBITDA margin of food business decreased to 16% (vs 20% in 4Q22) due to an increase in rental fees and the provision of outlet closures.
- As a result, food business core profit dropped by 10% y-y to THB125m

Overall

- 2023 core profit of THB1.1b accounted for 94% of our 2023E forecast of THB1.2b.
- We expect operation to improve in 1Q24 driven by high tourism season in Thailand and recovery of Maldives

- HMPRO reported a 4Q23 net profit of THB1.68b (+9.4% q-q, +1.4% y-y), beat our estimate by 6% thank to better-thanexpected GPM from reduce promotional activities.
- Retail sales dropped by 1.4% due mainly to the decreased SSSG of HomePro by 8%, MegaHome by 7% and HomePro (Malaysia) by 2%, offset by the opening of 11 new stores, the total sales decreased less than the SSSG

Economic news

Cash gifts, free milk raise risks to Thailand, Indonesia ratings
BANGKOK POST: JAKARTA/BANGKOK - Southeast Asia's new leaders risk blowing past budget constraints to make good on costly campaign promises of cash handouts and free lunches, increasing the risks to their prized investment-grade ratings. Indonesia's likely next President Prabowo Subianto plans to provide free meals and milk to more than 80 million school children across the country to combat extreme poverty and stunted physical development. The project is estimated to cost 120 trillion rupiah (US\$7.7 billion) in its first year, before ramping up to 450 trillion rupiah annually by 2029.

- Thailand seeks two years to fully adopt green tariff BANGKOK POST: Thailand may take two years to fully adopt the green utility tariff (GUT), recently launched to regulate renewable power prices, as many businesses would need time to adapt to the global campaign against carbon-intensive manufacturing, according to the Energy Regulatory Commission (ERC). The timeframe is an estimate, following a public hearing on the GUT, which is a new tariff to be used to calculate the price of electricity generated by renewable resources.
- FTI foresees drop in border trade BANGKOK POST: Thailand's border trade is expected to slow down this year due to the ongoing political conflict in Myanmar and economic problems in other neighbouring countries, says the Federation of Thai Industries (FTI). Myanmar, Laos, Cambodia and Malaysia are the countries that border Thailand.

Corporate news

- Iconic Dusit Thani Bangkok to reopen Dusit Thani Bangkok in September 2024. The new hotel is situated in the same prime location as the original property, which graced the Bangkok skyline from 1970 until 2019.
- Centel revenue up 24% to B22.5bn BANGKOK POST: Central Plaza Hotel Plc (Centel), the operator of Centara Hotels and Resorts and its food business, reported 6.02 billion baht in total revenue for the fourth quarter of 2023, an increase of 9% year-on-year. For its full year 2023, the company reported total revenue of 22.5 billion baht, an increase of 4.33 billion baht or 24% year-on-year.
- SCB 'poised to purchase Vietnamese lender' BANGKOK POST: SCB X Plc, Thailand's biggest bank by market value, is close to an agreement to buy the Vietnamese business of the consumer lender Home Credit in Vietnam in a deal that could be worth as much as US \$900 million, according to people familiar with the matter. The SET-listed holding company of Siam Commercial Bank has emerged as the most likely buyer after outbidding rivals, the people said. The potential deal, which values Home Credit Vietnam at \$800 million to \$900 million, is expected to be announced as early as this week, the people said, asking not to be named as the process is private.
- SET plans switch to auction trading BANGKOK POST: The Stock Exchange of Thailand (SET) is preparing to upgrade measures to control stock price fluctuations from automatic order matching (AOM), with the change expected to be enforced by the third quarter, says the bourse. The statement was issued as the SET announced a warning to investors urging caution before deciding to buy or sell Miss Grand international (MGI) shares as the price continued to increase, even though fundamental factors remained unchanged.

Exhibit 28: Foreign fund flow and SET Index




Exhibit 29: Foreign participation
