### BANGKOK DUSIT MEDICAL SERVICES (BDMS TB) - Defensive growth remains resilient; Maintain BUY TP THB28.75

#### 2026 outlook supports steady topline growth and wider margins

We expect BDMS to deliver 3% revenue growth in 2026, in line with the 2-4% target. Thai patient revenue should grow 2% on stronger marketing and continued momentum in complex treatments, while international revenue is projected to rise 5%, driven by key source markets including the US, China, Myanmar and Japan. Cambodia remains stable after prior correction. Capex will focus on expanding capacity at existing hospitals. Efficiency initiatives, tighter opex control, and higher in-house drug and medical product usage should improve EBITDA margin slightly to c24%.

#### Limited Middle East exposure, with modest downside

Middle East patients account for only 4% of total revenue. As the current period coincides with Ramadan, travel is seasonally subdued. If geopolitical tensions extend for an additional two weeks in late March, management estimates a revenue impact of THB100-150m. Our scenario assumes a 60% decline in Middle East patient volume for three months and 70% for six months. Even under these stress cases, earnings and target price impact would remain modest at c1-2%, supported by BDMS's diversified patient mix and limited spillover to other markets.

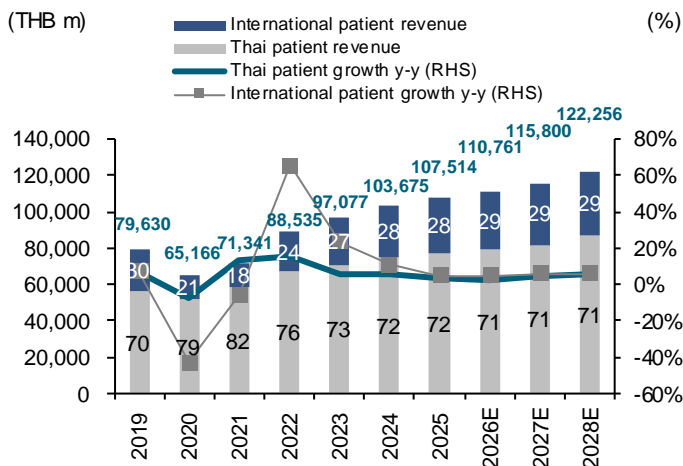
#### Near-term volatility, but sustained earnings recovery over 2026-28

To reflect management's conservative tone and our assumption of a one-month Middle East disruption, we trim our 2026-2028 core profit forecasts by 4-7%. Nonetheless, we still expect 2026 core earnings to grow 4%, before accelerating to 7-9% in 2027-28. January 2026 revenue rose 2% y-y, led by foreign patients (+2%) and provincial hospitals (+3%). We preliminarily estimate 1Q26 core profit of THB4.30b, rising 7% q-q on margin improvement but dipping 1% y-y due to the March impact.

#### Maintain BUY, compelling valuation

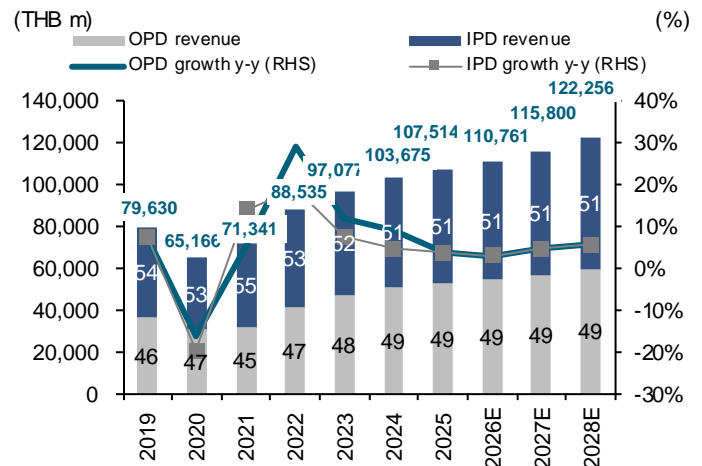
We lower our DCF-based target price to THB28.75 (from THB31), equivalent to 27x 2026E P/E, in line with its five-year historical average. The stock currently trades at 18x 2026E P/E (-2.0SD), with ROE above 15% and a 2H25 dividend (including special payout) of Bt0.65 per share, implying a 3% yield. We expect earnings momentum to improve from 2Q26, with stronger growth in 2H26. We maintain BUY, given its limited Middle East exposure and continued core earnings growth.

## PYLON (PYLON TB) - Growth momentum building; Maintain BUY TP THB3.80

### Record backlog underpins growth outlook

Overall, the tone at the Opportunity Day was positive. Management expressed an optimistic outlook for business performance in 2026–27, supported by a record-high backlog of THB2.2b. This backlog secures full-quarter revenue recognition through 3Q26 and partially into 4Q26, providing longer visibility than the typical 4–5 months. Most projects are large-scale private sector developments, including Central Embassy 2, BDMS Wellness, as well as several hotels and hospitals. Management targets 2026 revenue growth of 10–15% y-y from THB1.5b, with gross profit margin (GPM) expected to improve from the 2025 level of 22.9%.

### Public project acceleration to drive piling demand

Management expects demand in the piling industry to rise, driven by the acceleration of public infrastructure project tenders following the formation of the new government, with construction likely to commence in late this year or early next year. Key projects include the Double Deck Expressway, the Thai–Chinese high-speed rail, as well as the resumption of the High-Speed Rail Linking Three Airports project. On the supply side, competition has eased after the exit of a major player from the market, while leading operators are currently operating at full capacity. However, competition is likely to gradually intensify in 2H26 following the completion of the Orange Line project. Nevertheless, management believes the market will remain balanced, supported by an expanding project pipeline, particularly projects requiring specialized expertise with a limited number of qualified contractors. Meanwhile, management expects no material impact from the Middle East war, with a 1% increase in oil prices estimated to raise costs by only 0.4–0.5%.

### Earnings upgrade on stronger new contracts

We raise our 2026 net profit forecast by 26% to THB256m (+21% y-y), reflecting higher-than-expected new contract signings. As a result, we revise up our revenue forecast by 11% to THB1.66b, implying 12% y-y growth in line with the company's target, alongside an expansion in gross margin to 25.1% (from 22.5%), driven by new higher-margin projects amid easing competition and improved operating leverage.

### Maintain BUY with higher TP of THB3.80

We raise our TP to THB3.80 (from THB3.10), based on a PBV of 2.4x (its historical average), and maintain our BUY rating. The strong backlog is expected to support high equipment utilization, with around 20 machines operating during 1Q–3Q26. In the near term, 1Q26 earnings are expected to decline slightly q-q, as the quarter marks a transition period with the gradual ramp-up of new projects, but increase sharply y-y.

## NEO CORPORATE (NEO TB) - Key takeaways from analyst meeting; Maintain BUY TP THB27.00

### Highlights

- Management maintained its 2026 revenue growth target of 5–8% y-y, supported by 5–8% y-y growth in the domestic market and double-digit growth overseas. Although revenue from Cambodia has been discontinued, it previously accounted for only 2% of total revenue. Vietnam and Laos continue to perform well, and the company has started expanding into new markets such as the Philippines, Hong Kong, and Malaysia.
- The company is assessing the impact of the Middle East conflict after the recent rise in crude oil prices. Packaging costs represent about 30% of total costs, with 15–20% of packaging costs linked to oil prices (around 4.5–6.0% of total costs).
- Raw material and packaging costs are locked in for 1H26. However, higher-than-expected raw material prices could pressure the gross margin target of 38–40%. The SG&A to sales target remains unchanged at no more than 32%.
- Construction of the Phase 1 Household plant is about 77% complete and is on track to start operations in 3Q26. Depreciation is expected to begin in 2H26 at around THB75m, or 0.65% of total revenue.

### Comments

- We believe the company can achieve its 2026 revenue growth target, supported by a new distributor in Vietnam and potential upside from domestic stimulus measures under the new government. There is also additional upside from expansion into new markets.
- In the near term, January revenue grew ahead of the market, led by Household (+18% y-y vs. market +6%) and Personal Care (+11% y-y vs. market -1%). We expect 1Q26 revenue to grow y-y in both domestic and overseas markets, but decline q-q due to seasonality and the high base in 4Q25, which benefited from the government co-payment scheme.
- Raw material costs are likely to remain high, similar to 4Q25. As a result, we expect 1Q26 net profit to decline both q-q (seasonally) and y-y due to a high base, higher costs, and increased depreciation. Profit should recover both q-q and y-y in 2Q26.
- However, we are more cautious on raw material and packaging cost trends. Although average CPKO price in 1QTD is MYR7,050/tonne (-4.8% q-q, -7.8% y-y), close to our assumption of MYR7,068/tonne, our sensitivity analysis suggests that every 10% increase in CPKO price would reduce profit by about 13%. We will continue to monitor the situation.
- We maintain our 2026E net profit at THB636m (+13.3% y-y). The stock is currently trading at 9.6x 2026E PE and will pay a 2025 dividend of THB1.35/shr (6.7% yield), with the XD date on 5 May.

## CENTRAL RETAIL CORP (CRC TB) - Key takeaways from analyst meeting; Maintain BUY TP THB23.00

### Highlights

- Management remains positive on business expansion in Vietnam and a recovery in Thailand. However, the situation and potential consumption impact from the war remain key risks to monitor.
- Management assesses impacts from the Middle East conflicts in three areas: 1) higher freight costs, with freight expenses estimated at around 0.7–0.8% of COGS; 2) higher logistics costs, which are still being assessed (we expect this could account c1–2% of COGS following sector practice); and 3) softer Middle East tourist arrivals. Tourist-related sales account for around 15% of department store sales, with Middle East tourists contributing around 3–9% of tourist sales. This is implying a potential impact of roughly 0.1–0.3% of total sales.
- For the 40% acquisition of JD Sports, CRC invested around THB530m, implying a forward P/E of around 5.3x based on management's expected profit contribution of roughly THB100m per year. We already incorporated JD Sports share of profit in our current forecasts. Strategically, the investment aims to penetrate the premium sportswear segment both within CRC and outside CRC. This should also improve CRC's access to international brands, similarly to the Rev Runnr acquisition to ride the HOKA growth trend.
- Management guided on an effective tax rate for 2026 of c22–23%, mainly reflecting Vietnam operations where tax remains higher than normal, but it should decline on a y-y.
- SSS for Jan–Feb 26 dropped by 4% y-y, dragged by a decline in Fashion and Hardline for -8% and -6%, respectively. The Food business remained resilient at 2.5% y-y growth on the back of strong Vietnam's SSS momentum.
- We maintain our 2026 profit growth forecast of 5.7% y-y, supported by the divestment of Nguyen Kim, the JD Sports investment, and organic recovery. However, if we include Rinascente profit in 2025, the 2026 would still drop by 3.3%.
- We are positive on CRC's long-term outlook given the exposure in Vietnam business. We expect a potential P/E re-ratings for CRC on the back of strong Vietnam SSS recovery, however; the current share price is still trading at 14.1x 2026E P/E in line with peers which expect more limited earnings growth. We maintain BUY on CRC with a target price of THB23.00/share.

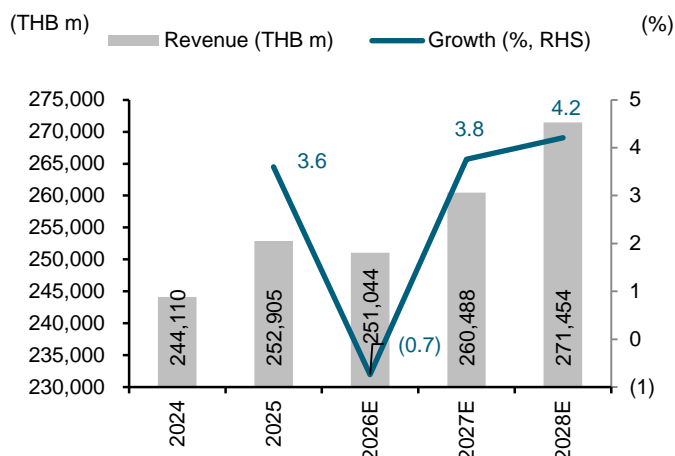

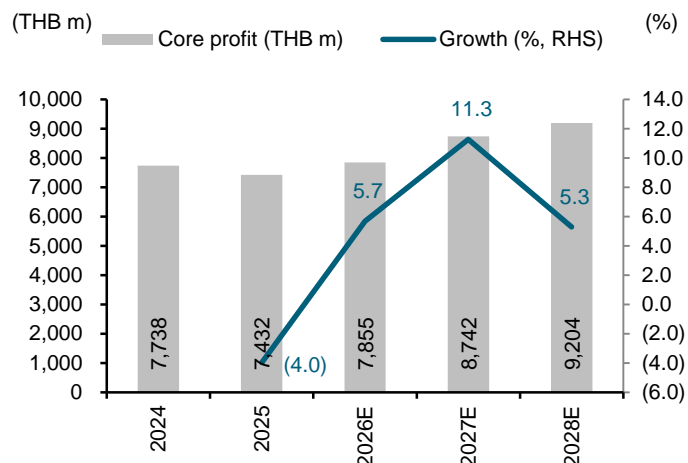

### Exhibit 9: Core profit and growth momentum



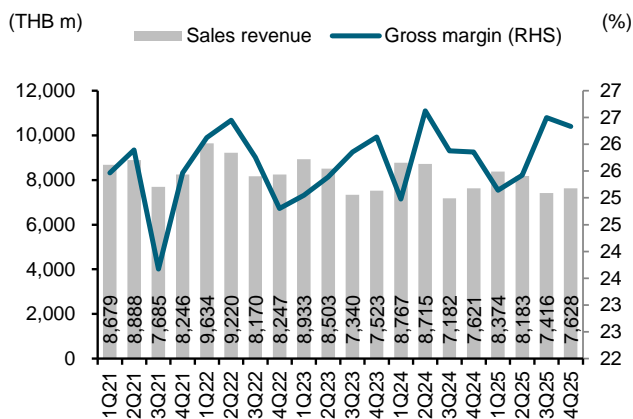

# SIAM GLOBAL HOUSE (GLOBAL TB) - Key takeaways from analyst meeting; Maintain BUY TP THB8.00

## Highlights

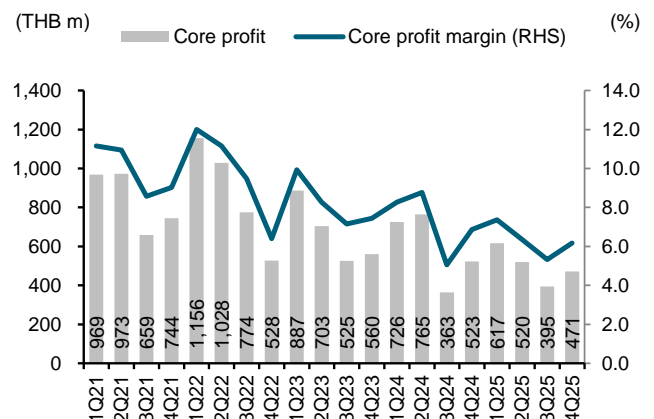
- Management sees purchasing power gradually recovering but still fragile. For 2026, the company's financial targets are: 1) SSS growth of 0-3% y-y, 2) GPM expansion of +20-30 bps, and 3) SG&A/Sales to remain flat, assuming a better SSS recovery.
- For Thailand store expansion in 2026, the company targets five new openings, bringing the total to 101 stores in 2026 (up 5.2% y-y).
- On the overseas expansion, management indicated that over the next 2-3 years it plans to open stores in Myanmar (+2 stores), Indonesia (+1-2 stores), and Laos (+2-3 stores), mainly to increase coverage across provinces where the company is not yet present.
- Management still neutral on the Cambodia business while the impairment risk should remain limited as EBITDA remains positive, despite softer sales.
- The company is still monitoring potential impacts from the war. Based on our channel checks, management guided transportation costs at around 2% of COGS. As such, direct impacts are still viewed as limited, while the prolonged conflict could weigh mainly on purchasing power.
- Current SSS trends in Jan-Feb 2026 are down around 4-5% y-y.
- Overall, we expect 1Q26 earnings to be flat y-y and see a return to y-y growth in 2Q26.
- We forecast FY2026 normalized profit at THB2.2b, up 9% y-y, based on assumptions of SSS +1.5%, GPM +20 bps, and flat SG&A/Sales.
- We maintain our BUY call on GLOBAL with a target price of THB8.00/share. We like GLOBAL from the earnings turnaround momentum in 2026.

Exhibit 10: Sales and GPM momentum



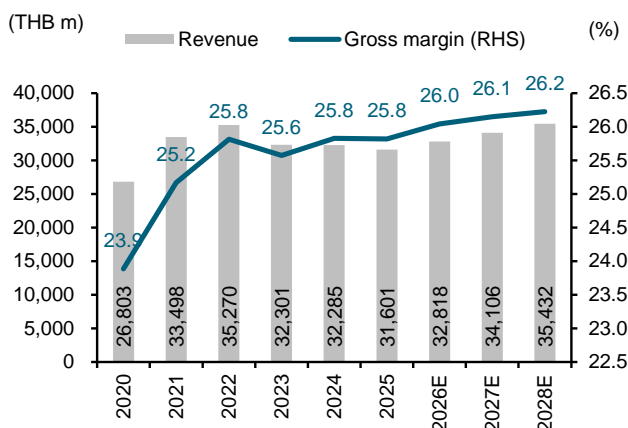

Exhibit 11: Core profit and margin



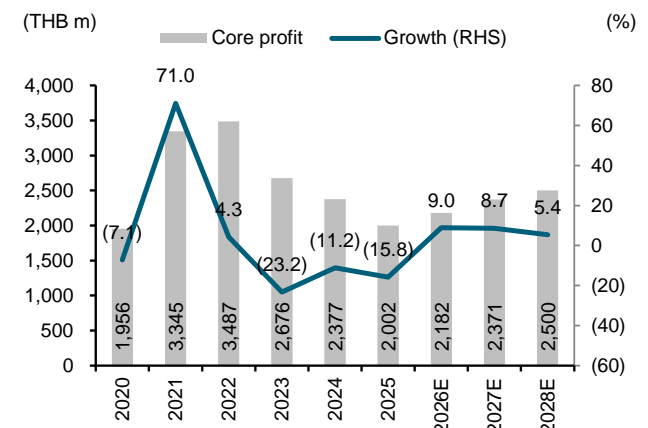

## FSSIA's portfolio update

We **add GULF** (BUY, TP THB67.50) and **CPN** (BUY, TP THB73) to our portfolio for the following reasons:

- We view GULF as one of the stocks with limited downside exposure from the US–Iran conflict, which has pushed energy prices higher. Most of its power plants operate under IPP contracts, allowing it to pass through fuel costs. In addition, its strong equity income contribution from ADVANC provides another key earnings pillar. In the near term, we expect 1Q26 earnings to remain solid, supported by newly COD solar capacity in late 2025, while ADVANC's earnings momentum is also expected to stay robust. We forecast GULF's 2026 net profit to grow by +28% y-y.
- We view CPN as another company with limited exposure to geopolitical tensions and rising energy prices, as rental income accounts for more than 80% of its total revenue. In 2026, we expect continued business growth, led by the retail segment with a full-year contribution from Central Park and the opening of four new shopping malls, which should expand leasable area by 7–8% from current levels. The residential segment will also benefit from five new condominium projects ready for transfer. We forecast 2026 net profit to grow by 14% y-y. The stock is currently trading at c15x PER and offers a dividend yield of 3.7%.

As a result, our portfolio favorites are **BA, BDMS, CPALL, CPF, CPN, ERW, GULF, KTB, MTC, OSP, and WHAUP**.

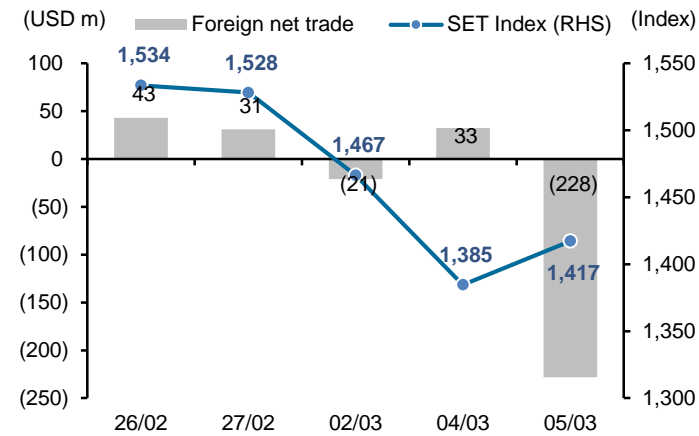
## Economic news

- [Energy price spike puts eateries on edge](#) BANGKOK POST: Restaurants are bracing for potential hikes in raw material prices due to rising energy costs, driven by the ongoing conflict in the Middle East. Thaniwan Kulmongkol, president of the Thai Restaurant Association, told the Bangkok Post that restaurant operators fear the war in Iran may escalate, while tensions have already driven up energy prices. The surge in energy prices will inevitably lead to higher logistics costs, resulting in higher prices for raw material and restaurant equipment, she said. Raw material prices have not increased yet thanks to government price controls, as the authorities warned that any business increasing prices at this time could face penalties. The uncertainty is likely to push diners to spend more cautiously, which could negatively impact the restaurant sector, said Ms Thaniwan.
- [Volatile hardware prices upend IT planning](#) BANGKOK POST: Purchasing IT equipment, particularly servers, has become significantly more difficult due to market volatility, said a veteran IT executive who requested anonymity. In the past, hardware prices were stable and price quotes were valid for 30 days. Now the duration has shrunk to 14 days. Before issuing a quote, vendors must strictly verify inventories with their supply chains, as production and delivery lead times have drastically stretched from 1-2 weeks to 3-4 months, noted the source. Given these extended timelines and increased costs, IT project planning has fundamentally changed. Customers are being forced to adjust in several ways, the source said. Budgets set mid-year or in the previous year are often no longer sufficient to cover the higher current prices.
- [IMF suggests deeper Asian economic integration](#) BANGKOK POST: The International Monetary Fund (IMF) chief has called for deeper integration among Asian economies to help the region prepare for heightened global trade tensions and policy shocks. Speaking at the "Asia in 2050" conference held in Bangkok on Thursday, IMF managing director Kristalina Georgieva said in a multipolar world, trade is affected by one policy shock after another. Strengthening regional integration could help mitigate uncertainties and reduce the impact of non-tariff barriers, she said. Economic growth in Asia has been driven partly by exports since the 1960s. However, rising geopolitical tensions and shifts in trade policies are creating new uncertainties. Despite these challenges, global trade will continue to adapt, said Ms Georgieva. "Trade is like water. When you put an obstacle in its way, it finds another route," she said, adding closer regional trade links could raise Asia's GDP by around 1.8% over the long term. Ms Georgieva also highlighted digital connectivity as a major opportunity for the region. Asia leads the world in mobile broadband subscriptions, providing a strong foundation for digital payments and cross-border financial services.
- [Iran war punctures strategy of 'Sell America, Buy Asia'](#) BANGKOK POST: The war in Iran is forcing investors to reevaluate one of their most profitable stock strategies, leading some to conclude that the "Sell America, Buy Asia" trade has reached an inflection point. Despite a rebound Thursday, the MSCI Asia Pacific Index has tumbled about 6% this week, compared with a 0.1% slide in the S&P 500. The swing indicates a reversal of a rotation by global funds into Asia and a renewed shift toward the United States as a haven, a move also supported by a stronger US dollar. Futures on the US benchmark are down less than 0.1% at 6.41am in New York on Thursday morning. The Iran war has impacted Asian stocks disproportionately, partly because of the region's outside reliance on fuel shipments through the Strait of Hormuz. There's also growing concern that a sustained supply shock may trigger a global economic slowdown, undermining key export industries. As a result, investors are taking profits from the recent AI-driven rally, particularly in the outperformers in the past year: South Korea and Taiwan. "Capital doesn't wait for certainty — it's already rotating, and the dollar's strength this week tells you everything about where the smart money is heading," said Hebe Chen, senior market analyst at Vantage Global Prime. "China, Japan, Korea and Taiwan are pure import dependents with no buffer, making this oil shock exponentially more corrosive for the region than for the West." Asian equities had been favoured for their artificial intelligence (AI) hardware exposure, relatively cheap valuations and solid earnings growth.
- [Authorities tout biofuel as global oil prices soar](#) BANGKOK POST: Energy authorities are stepping up efforts to expand biofuel usage to reduce reliance on oil imports and safeguard against potential fuel shortages. The move comes as global oil prices surge, driven by the ongoing conflict between the United States, Israel and Iran. Officials are also considering reviving the historic "han song (meaning divided by two)" energy conservation campaign, which decades ago encouraged households and businesses to cut energy consumption. Veerapat Kiatfuengfoo, energy deputy permanent secretary, said a special panel had been established to address energy security concerns. The panel is tasked with finding ways to extend the country's oil reserves by increasing the blending of biofuels with petrol and diesel. Thailand's oil reserves currently provide coverage for 60 days in the event of supply disruptions, such as a closure of the Strait of Hormuz in the Middle East. Of this, 38 days are based on domestic oil stocks, while the remaining 22 days account for oil shipments en route to Thailand, according to Sarawut Kaewtathip, director-general of the Department of Energy Business.
- [25% tourism decline 'worst-case scenario'](#) BANGKOK POST: War in the Middle East could seriously affect Thai tourism this year, with a 25% decline from the 2026 target being the worst-case scenario if the fighting extends beyond three months, prompting officials to target short-haul tourists to fill the gap. The conflict that has shut Mideast airspace has particular consequences for European markets, which regained strong momentum last year, caretaker tourism and sports minister Artthakorn Sirilatthayakorn said on Thursday after talks with Tourism Authority of Thailand (TAT) officials. In the short term, the conflict in the region has affected those whose flights are connected through Middle Eastern hubs, and might also hit travellers' confidence in taking long-haul trips to Thailand. Surging operating costs for airlines would also have an impact on airfares, as fuel typically accounts for 25% of a carrier's operating expenses. According to a preliminary forecast by the TAT, the worst-case scenario would involve a potential decrease of 25% to between 27 million and 29 million foreign visitors, from the 2026 target of 36.7 million.

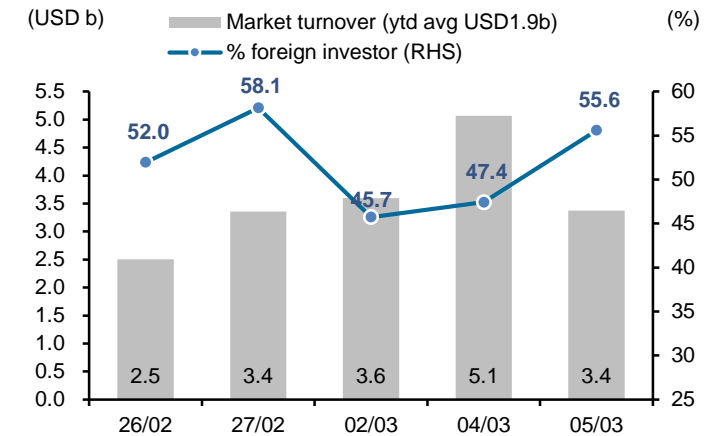
- [Banpu Posts Net Loss as Baht Strength Erodes Profits, But Coal and Gas Price Rally Lifts 2026 Outlook](#) THE NATION: Thai energy firm reports a USD 61.5m loss for 2025 despite solid operating performance, as Middle East tensions push coal to USD 136 per tonne. Banpu, the Thai energy conglomerate listed on the Stock Exchange of Thailand, has reported a net loss of USD 61.5 million for 2025, despite recording solid revenues and operating profit across its coal, gas and power businesses. The loss was driven primarily by an unrealised foreign exchange translation loss of USD 45.9 million, stemming from the appreciation of the Thai baht against the US dollar during the year, compounded by financial derivative adjustments and other non-recurring items. Total sales revenue for 2025 reached USD 5,278 million, with EBITDA of USD 1,191 million and an operating profit of USD 22.3 million. The company stressed that its underlying operational performance remained intact and pointed to favourable commodity price movements so far in 2026 as grounds for a more optimistic outlook in the year ahead.
