### CENTRAL RETAIL CORP (CRC TB) - Key takeaways from analyst meeting; Maintain BUY TP THB23.00


#### Highlights

- Management guided on the company financial targets for 2026 as followed: 1) total revenue growth of 4-5% y-y, driven by Food (+5-6%), Hardline (+3-4%), and Fashion (+1-3%); 2) EBITDA growth of 5-7%, supported by a 10 bps GPM improvement mainly from Fashion and Hardline, while Food GPM is expected to soften slightly due to a higher Go Wholesale contribution; and 3) CAPEX of THB16-18b.
- For store expansion in Thailand in 2026, CRC plans to open Thai Watsadu of +3-5, Go Wholesale +2, and Tops +8-10 stores, with no department store openings. In Vietnam, the plan includes Go Mall +1 (with Go! Hypermarket +2) and Mini Go +6 stores.
- CRC will focus on upgrading the existing store base and refreshing product merchandising, such as adding more brands in Fashion and expanding non-food product at Go! Vietnam. New store expansion drivers are expected to be weighted more heavily toward 2027-28.
- Management will be more proactive on the M&A given its strong financial position. At end-25, the company net debt/equity stood at 0.9x while debt covenant is at 2.0x. CRC will exploring opportunities across all BUs, mainly within ASEAN, focusing on earnings-accretive deals or those with a fast turnaround and solid long-term potential. Management reiterated that the future transaction would not be related-party transactions within the Central Group.

#### Comments


- Regarding the Iran war, management estimates total freight and utilities costs at around 1% of sales (freight 0.4%, utilities 0.6%). Based on our analysis, every 10% increase in these sum of costs could impact 2026's core profit by c3%.
- The company's QTD SSS as of 8 Mar 2026 was at around -3% y-y, gradually improved from 4Q25 of -4% y-y. We also see a slight improvement in Thailand given 1-8 Mar 2026's SSS turn to a positive 1-3% y-y, driven by Food and Fashion businesses. We expect 1Q26 earnings to decline on both y-y and q-q. However, we foresee 2Q26's core NPAT to turn to a positive y-y growth momentum from the Nguyen Kim divestment, and recovery in domestic businesses.
- We remain positive on CRC on the back of improving Vietnam business momentum, the Nguyen Kim divestment, and the JD Sports acquisition. We expect profit from continuing operations in 2026 to grow 5.7% y-y (still down 3.3% y-y if including Rinascente profit in the 2025 base), with a more visible y-y recovery from 2Q26 onward.
- We maintain BUY with a target price of THB23.00. CRC is traded at 14.5x 2026E P/E, below the regional consumer staple peers of 17.2x 2026E P/E, equivalent to a 15% discount to peers.

#### Exhibit 1: Revenue and growth momentum





#### Exhibit 2: Sales contribution by format





# SCGJWD LOGISTICS (SJWD TB) - Impact remains limited; Maintain BUY TP THB13.30

## Limited earnings sensitivity to oil prices

We assess that the recent increase in oil prices has a limited impact on SJWD’s overall earnings profile. While the transportation segment is directly exposed to higher fuel costs, only around 300 trucks out of the company’s total network of more than 14,000 vehicles are company-owned, with the remainder outsourced. As a result, fuel expenses account for less than 2% of total transportation costs. At the consolidated level, fuel costs represent less than 1% of SJWD’s total operating costs, implying minimal earnings sensitivity to oil price fluctuations.

## Cost Pass-through Potential

In 2025, the transportation segment accounts for 50% of total revenue, with a gross margin of 9.0%, contributing 31% of total gross profit. We estimate that every THB5/liter increase in oil prices would reduce the transportation gross margin by approximately 25bps, translating into an estimated 2% downside to SJWD’s overall earnings. By the nature of the business, higher transportation costs can generally be passed through to customers. While the company may temporarily absorb part of the increase in the near term, we expect costs to be gradually passed on through pricing adjustments over time.

## Cold storage: limited earnings Impact

Cold storage is another electricity-intensive business where power costs represent a key component of operating expenses. However, the company has installed solar rooftops and implemented the Chillox system, which helps reduce electricity consumption by approximately 15–20%. In 2025, revenue from the cold storage segment accounted for only 4.6% of total revenue. Nevertheless, due to its relatively high gross margin, the segment contributed about 11.2% of the company’s total gross profit. We estimate that every 1% change in the gross margin of the cold storage business would translate into roughly a 1% change in the group’s overall earnings.

## Maintain earnings forecast and TP

Based on the current situation, the impact is estimated at around 1–2% of earnings. We believe this remains manageable for the company. We therefore maintain our earnings forecast and target price of THB13.30.

Exhibit 5: Revenue structure in 2025






Exhibit 6: Gross profit by business in 2025


## Economic news

- **[Oil forecasts rise as Mideast war rages](#)** BANGKOK POST: Analysts are lifting their oil price estimates for this year and 2027 amid transport disruption in the Middle East, even though the potential release of reserves by the G7 and the Organisation for Economic Co-operation and Development (OECD) could help temporarily alleviate supply pressures. Tris Ratings raised its 2026 annual average oil price forecast to US\$70 a barrel, from \$63, for Brent in a base case scenario, with the Hormuz Strait remaining effectively closed for around a month. In its Global Economic Outlook released on March 11, the credit rating agency expects oil prices to remain in the \$90-100 range through March before falling to the mid-\$60s by the second half of the year in a "fundamentally oversupplied market". "However, there are huge uncertainties and the possibility of more sustained disruptions to oil shipments and significant damage to production facilities in the Middle East," Tris said. In an adverse scenario, in which oil prices rise to \$100 per barrel and remain there, it would trigger a significant global supply shock, reducing world GDP by 0.4% after four quarters and adding 1.2-1.5 percentage points to inflation in Europe and the US, noted the agency. Chak Reungsinpinya, managing director and head of research at Maybank Securities (Thailand), said the brokerage upgraded its Brent crude assumption to \$75 per barrel for 2026 and \$70 for 2027, from \$65 and \$66 respectively, projecting that the Middle East war will be "weeks-long rather than months-long".
- **[AI boom drives tech investment surge](#)** BANGKOK POST: IT spending in Thailand is expected to reach almost 1.1 trillion baht in 2026, up 8.36% year-on-year, thanks to artificial intelligence (AI) infrastructure investment, according to the latest forecast by business tech and insight firm Gartner. Investments in AI-related infrastructure will continue to surge in 2026, according to a company release issued last month. Gartner forecasts that spending on data centre systems in Thailand by enterprises and service providers will record the largest growth, increasing 27.9% to 70.6 billion baht. Within this category, server spending will increase almost 38% to reach 51.1 billion baht in 2026, driven by investments in AI-optimised servers to support AI adoption. Communications services remain the largest IT spending category in Thailand in 2026, mainly focused on spending on mobile connectivity, Gartner noted. The firm forecasts that communications services spending in Thailand will reach 457 billion baht in 2026, a 2.63% increase from 2025.
- **[Foreign holdings of Thai stocks peak](#)** BANGKOK POST: Foreign investor holdings in Thai stocks reached a new record high of 6.11 trillion baht in January, representing 37.1% of the total market capitalisation and reflecting growing overseas interest in the equities market, says the Stock Exchange of Thailand (SET). Despite a net seller position, data compiled by the SET shows the value of foreign holdings has steadily increased over the past several years. Foreign investors held 5.13 trillion baht, or 26.5% of market capitalisation, in December 2021. The figure rose to 6.02 trillion baht (29.6%) in 2022, before easing to 5.11 trillion (29.4%) in 2023. Holdings increased again to 5.83 trillion baht (33.8%) in 2024, followed by 5.61 trillion baht (35.7%) last year, then hit a new peak of 6.11 trillion in the first month of 2026. The baht was 31.39 to the US dollar as of Jan 30, based on figures compiled by the Bank of Thailand. Foreign investors were net sellers of Thai equities worth 107 billion baht last year, which analysts attributed to short-term profit-taking. In contrast, there was net buying of non-voting depository receipts totalling 87.1 billion baht, suggesting continued investment exposure to Thai companies through alternative investment channels. According to the SET, several factors contributed to the steady rise in foreign holdings, led by improved political stability following Thailand's elections.
- **[SEC confirms legal action against 'Acme Traderist'](#)** BANGKOK POST: The Securities and Exchange Commission (SEC) has reaffirmed that legal action was already taken against cryptocurrency promoter Worawat Narknawdee, widely known as "Acme Traderist", following renewed public attention and additional complaints from alleged victims. Anek Yooyuen, deputy secretary-general of the SEC, said the regulator filed a criminal complaint against Mr Worawat and 1000X Limited, the digital asset platform he operated, with the Economic Crime Suppression Division (ECD) in March 2023. The case accuses the parties of jointly operating an unauthorised digital asset trading business. According to the SEC, the case was forwarded to public prosecutors and is under consideration. The clarification follows social media attention about the case. On March 9, more than 30 alleged victims gathered at the Central Investigation Bureau to file additional complaints against Mr Worawat. The complainants claimed they were persuaded to invest in cryptocurrencies through the platform, with preliminary damages estimated at 1.39 billion baht.
- **[SET outlines strategies to spur market](#)** BANGKOK POST: The Stock Exchange of Thailand (SET) has outlined strategies to strengthen Thailand's capital market resilience amid rising global uncertainties stemming from war, energy price volatility, supply chain disruptions and rapid technological change. Despite the highly uncertain investment landscape, Thailand still holds strong potential due to its economic stability and diversified industrial structure, SET chairman Kitipong Urapeepatanapong said at a seminar on Thursday. Thailand continues to be viewed as a relatively "safe haven" in the region, supported by strong foreign-exchange reserves, manageable public debt levels and a resilient banking system, he said. The country's economic recovery is also gaining traction, reflected in improving GDP growth, expanding exports and rising private investment. From an investment perspective, the Thai equity market remains attractive as a value play. Many listed companies are also priced below book value but still offer strong dividend payouts. Thai listed firms distributed 680 billion baht in dividends last year, particularly in the banking, energy and technology sectors. The exchange is working to attract international technology firms by coordinating with investment authorities on a fast-track listing pathway, allowing companies in emerging sectors such as data centres and electric vehicles to list based on business potential and technology strength rather than solely on profitability requirements. At the same time, the SET is expanding investment products to enhance portfolio diversification. Thai investors can now gain overseas exposure through depository receipts (DRs) linked to more than 330 global companies, while tools such as inverse exchange-traded funds (ETFs) allow investors to hedge market risks during periods of volatility.


- [CRC plans up to B18bn investment for store expansion](#) BANGKOK POST: SET-listed Central Retail Corporation (CRC) plans to invest 16-18 billion baht this year to open new stores, renovate existing ones and enhance the customer experience. As of 2025, the company operated 76 department stores, 172 Tops stores, 14 GO Wholesale stores, 88 Thaiwatsadu stores and 28 Robinson Lifestyle stores in Thailand. This year the company plans to open 8-10 new Tops stores, two new GO Wholesale stores and 3-5 new Thaiwatsadu stores, said Suthisarn Chirathivat, chief executive of CRC. CRC also wants to renovate two department stores, two Tops stores, two Thaiwatsadu stores and one Robinson Lifestyle store. As of 2025, the company operated 44 GO! Mall stores, 43 GO! Hypermarket stores and 15 mini go! stores in Vietnam. This year the company plans to add one GO! Mall store, two GO! Hypermarket stores and six mini go! stores. Thailand contributes 80% of the company's total sales, while Vietnam accounts for 20%. The company operates in 26 of Vietnam's 34 provinces.
- [PTG confirms plans to raise refined oil reserves](#) BANGKOK POST: PTG Energy Plc, the operator of PT petrol stations, has announced plans to expand its refined oil reserves in line with a government directive aimed at safeguarding national energy security during the ongoing US-Iran conflict. Authorities last week ordered local oil retailers to raise their refined oil reserves proportion to 1.5% by March 31, up from the current 1%. Pithak Ratchakitprakarn, president and chief executive of PTG, confirmed the company holds refined oil sourced from six refineries. The oil storage volume will rise to 15 million litres to meet the 1.5% requirement, and could be doubled to 30 million litres should reserves be raised to 3%, he said. Rangsun Puangprang, executive vice-president, said refineries already provide storage services to PTG, and scaling up to 3% would not present operational difficulties. Reserve purchases are based on Singapore's reference price, which has surged above US\$120 per barrel, compared with less than \$100 per barrel during the same period last year. Despite the higher costs, PTG expressed confidence the financial impact would be manageable, citing expectations the conflict between the US-Israel alliance and Iran will ease, with military activity likely confined to areas near the Strait of Hormuz.
